**Norwood secures Tier 1 telecommunications operator voicemail services renewal expected to deliver approximately A\$1.5 million**

**Key Details:**

- Norwood has executed a contract variation with a long-standing Tier 1 telecommunications carrier customer, extending the provision of Norwood's carrier voicemail platform to 30 June 2028.
- Based on current service usage and agreed contract pricing, Norwood estimates the renewed engagement will generate approximately A\$1.5 million in new revenue to Norwood over the renewal period.
- The renewal continues a production relationship established in 2018 and comprises fixed licence and maintenance charges plus monthly usage-based charges.

Norwood Systems Ltd (ASX: NOR) (Norwood), a provider of communications service platforms and voice AI technology, is pleased to announce that it has executed a contract variation with a long-standing tier-one telecommunications carrier customer for the ongoing provision of Norwood's carrier voicemail services.

The variation extends a long-standing production services agreement (first announced by Norwood to the ASX on 7 December 2018) and establishes updated commercial arrangements through to 30 June 2028 for a Tier 1 telecommunications operator's premium visual voicemail service. The agreement includes recurring licence and maintenance fees together with monthly usage-based charges applicable to subscriber volumes above agreed minimum thresholds.

Based on existing service usage and agreed contract pricing, Norwood estimates the variation will be worth approximately A\$1.5 million. Actual revenue will depend on monthly end-user volumes and applicable exchange rates. The renewal provides recurring production revenue through to FY2028 and reinforces the durability of Norwood's carrier-grade voice technology as the company expands its AI-enabled voice and communications strategy.

Paul Ostergaard, CEO and Founder of Norwood, said:

*“This renewal is an important validation of Norwood's ability to deliver dependable, carrier-grade communications services in live production networks. It extends a long-running customer relationship through to 30 June 2028, secures meaningful expected revenue and further reinforces the relevance of Norwood's voice platform as we expand our AI-enabled voice and communications strategy.”*
