





BNY Group's power to vote or dispose of these securities is qualified accordingly. *Note 2: Each Group Entity is a direct or indirect wholly owned subsidiary of BNY, the ultimate parent company. Other than BNYM in respect of 32,602,320 securities (of which BNYM's power to only dispose of 32,501,010 securities is limited – see Note 1) and Pershing LLC in respect of 25 securities and Mellon Investments Corporation in respect of 2,637 securities, none of the BNY Group entities are entitled to be registered as holder of the securities and their power to vote or dispose of the securities is qualified accordingly.
