Alara Resources Celebrates 50th Copper Concentrate Shipment from Oman

Perth, Australia: Alara Resources Limited (ASX: AUQ) ("Alara" or the "Company"), a base and precious metals producer and explorer with projects in Oman, is delighted to announce the dispatch of the **50th shipment** of copper concentrate from its Al Wash-hi Majaza copper-gold mine in Oman, a proud milestone that reflects the Company's consistent operational performance and growing production track record. The mine is operated by Alara's joint venture company Al Hadeetha Resources LLC (AHRL), in which Alara holds a 51% interest.

Key Highlights

- **Milestone 50th shipment of 456 WMT copper concentrate departed Sohar Port on 21 June 2026, containing approximately 83 MT copper and 64 Oz gold.**
- **Cumulative total of 62,684 WMT of copper concentrate shipped across all 50 parcels, containing 10,988 MT of copper metal — a testament to the mine's productivity and long-term potential.**

The 50th parcel comprised 456 WMT of copper-gold concentrate with approximately 83 MT of contained copper and 64 oz of gold, departing Sohar Port on 21 June 2026. This shipment included concentrate that had been held back from an earlier cycle due to port clearance requirements, and its successful dispatch further demonstrates the operational resilience and flexibility of the Al Wash-hi Majaza processing facility.

Alara Resources Managing Director, Atmavireswar Sthapak, commented:

"Achieving our 50th shipment is a proud moment for everyone at Alara Resources and our joint venture partners at AHRL. This milestone is a direct reflection of the dedication and expertise of our team on the ground in Oman, who have built a track record of consistent, reliable production at Al Wash-hi Majaza. With nearly 11,000 tonnes of copper metal shipped to date, we are demonstrating the real and growing value of this asset. As we look ahead, we remain energised by the potential of our Oman portfolio and are focused on continuing to build on this strong operational foundation to deliver further value for our shareholders."

Production Outlook

Following unprecedented rainfall in March affecting mine production, the mine returned strongly in April and has continued to deliver strongly in May and June YTD.

Similarly, the concentrator has delivered above nameplate production, with exception in April owing to the planned shutdown for SAG Mill reline. Performance upon startup with consistent May and June YTD run rates above nameplate, are positioning the Al Wash-hi Majaza asset to deliver its best FY performance since inception.

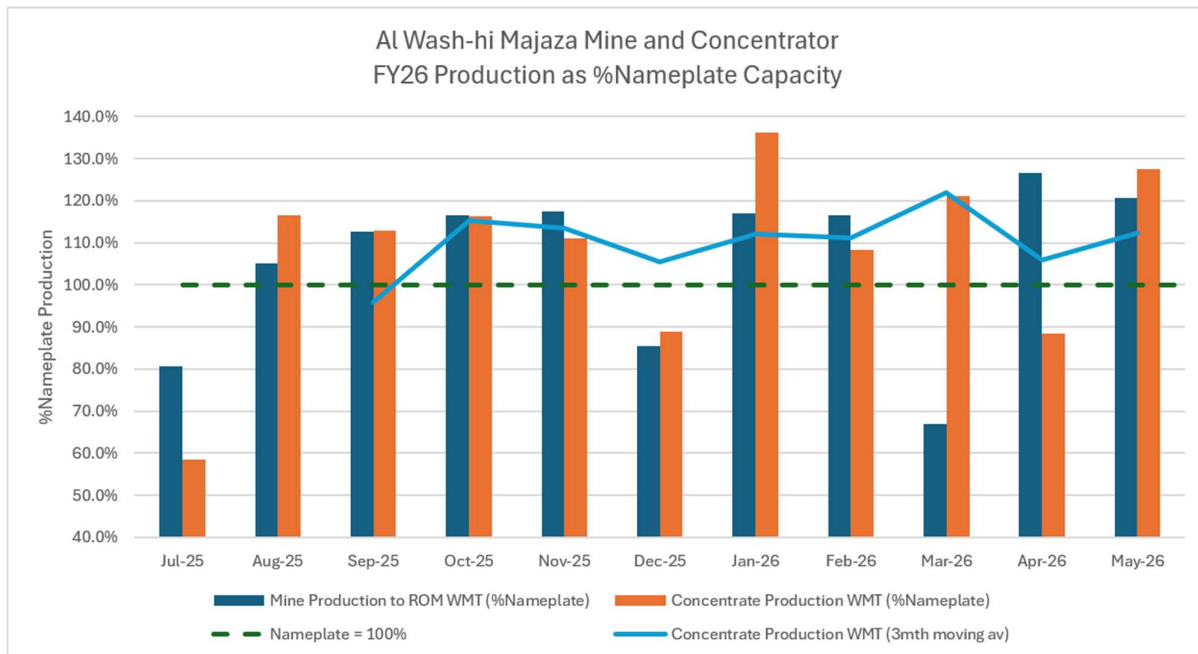


Figure 1 - FY26 YTD Al Wash-hi Majaza Copper Project Production as % Nameplate
