TRADING UPDATE

CTI Logistics Limited (CTI) is pleased to provide a trading update in relation to its financial results for the year ended 30 June 2026.

CTI advises that the profit before tax for the year ended 30 June 2026 is expected to be approximately 75% higher than the profit before tax for the previous corresponding period of \$19.7 million.

The improvement has been supported in part by strong revenue growth in May and June, with full year revenue expected to be approximately 9% higher than the revenue for the previous corresponding period of \$325.4 million.

CTI's transport and logistics operations have benefitted from increased demand across freight services and project work in Western Australia. This has been complemented by improved fleet utilisation and continued focus on cost control, and after incurring holding and relocation costs associated with the newly completed Lakes Road facility in Hazelmere.

The commentary in this announcement relating to the year ended 30 June 2026 is based on unaudited financial information. CTI expects to release its audited financial results for the year ended 30 June 2026 in late August 2026.
