Al Wash-hi Majaza Asset Delivers 51 Copper Concentrate Shipments for FY26

Perth, Australia: Alara Resources Limited (ASX: AUQ) (**Alara** or the **Company**), a pure-play copper producer and explorer with projects in Oman, is pleased to announce the dispatch of its 51st shipment of copper concentrate from its Al Wash-hi Majaza copper mine in Oman. The Al Wash-hi Majaza mine is operated by Alara's joint venture company Al Hadeetha Resources LLC (**AHRL**). Alara holds a 51% interest in AHRL.

Key Highlights

- **51st shipment of 1060 WMT copper-concentrate shipped on 30th June 2026, comprising 205 MT copper**
- **FY26 shipments totaling 39,287 WMT copper concentrate, comprising 7,230 MT copper**

The Al Wash-hi Majaza copper-concentrate plant has shipped a quantity of 1060 WMT of copper concentrate with approximately 205 MT of contained copper in its latest shipping cycle. This comprises the 51st parcel of copper-concentrate exported from the plant, departing Sohar Port on 30 June 2026.

Over the financial year ending June 2026 (FY26), the plant shipped an impressive 39,287 WMT of copper concentrate, with 7,230 MT contained copper.

A further three parcels have been delivered to Sohar Port and are awaiting vessel loading, with departure expected in early July 2026.
