52nd and 53rd Copper Concentrate Shipments Dispatched from Sohar Port

Perth, Australia: Alara Resources Limited (ASX: AUQ) (**Alara** or the **Company**), a pure-play copper producer and explorer with projects in Oman, is pleased to announce the dispatch of its **52nd** and **53rd** shipments of copper concentrate from its Al Wash-hi Majaza copper mine in Oman. The Al Wash-hi Majaza mine is operated by Alara's joint venture company Al Hadeetha Resources LLC (**AHRL**). Alara holds a 51% interest in AHRL.

Key Highlights

- **52nd shipment of 1067 WMT copper-concentrate shipped 3 July 2026, comprising 209 MT copper**
- **53rd shipment of 1056 WMT copper-concentrate shipped 3 July 2026, comprising 202 MT copper**

The Al Wash-hi Majaza copper-concentrate plant has shipped a total quantity of 2123 WMT of copper concentrate with approximately 411 MT of contained copper in its latest shipping cycle. This comprises the 52nd and 53rd parcels of copper-concentrate exported from the plant, departing Sohar Port 3 July 2026.
