South African patent grant in Fibromyalgia strengthens global intellectual property portfolio

- South African patent granted covering methods of treating fibromyalgia using psilocybin and psilocin-based treatments, significantly strengthens Entropy's global intellectual property estate
- Patent provides broad protection spanning treatment methods, dosing regimens, patient selection, clinical protocols, biomarkers, outcome measures and manufacturing
- Creates significant commercial exclusivity for psychedelic-based fibromyalgia therapies in South Africa, with claims devised to be difficult for competitors to design around
- Patent term extends to September 2043, supporting Entropy's long-term commercialisation and partnering strategy
- Grant expands Entropy's growing global IP portfolio supporting development of TRP-8803 (IV-infused psilocin) for large unmet medical needs

Melbourne, Australia – Entropy Neurodynamics Limited ('**Entropy Neurodynamics**' or the '**Company**') (**ASX: ENP**), a clinical-stage biotechnology company, is pleased to advise that it has been granted a South African patent covering methods of treating fibromyalgia using psilocybin. The patent has been granted under South African Patent No. 2025/01722, entitled "*Methods of Treating Fibromyalgia with Compositions Comprising Psilocybin.*"

The granted patent provides broad intellectual property protection covering the clinical use of psilocybin for the treatment of fibromyalgia, including therapeutic methods, dosing regimens, patient selection criteria, clinical assessment protocols, biomarkers, treatment outcome measures, integration therapy and manufacture.

Collectively, the claims establish a comprehensive intellectual property position designed to provide meaningful commercial exclusivity as Entropy advances its psychedelic development programs.

Fibromyalgia is a chronic pain disorder characterised by widespread musculoskeletal pain, fatigue, sleep disturbance and cognitive impairment. The condition affects millions of people globally and remains an area of significant unmet medical need, with currently available therapies providing limited efficacy for many patients.

The South African patent complements Entropy's broader IP strategy, which is focused on securing protection across key therapeutic indications and jurisdictions to maximise the long-term commercial value of its psychedelic medicine platform.

The South African Fibromyalgia treatment market was valued at US\$1.9Bn in 2025ⁱ, providing another potential large market opportunity for the Company. This patent



provides Entropy with IP protection until 11 September 2043, subject to the payment of annual renewal fees.

Management commentary:

CEO, Mr Jason Carroll said: *"This patent represents another important addition to Entropy's growing intellectual property portfolio and significantly strengthens our position in fibromyalgia, a large indication with substantial unmet clinical need."*

"Importantly, the claims extend well beyond simply protecting the use of psilocybin and related therapies. They encompass the broader therapeutic framework, including dosing protocols, patient selection, clinical assessments and treatment methodology, creating comprehensive, indication-level intellectual property protection that we believe will be difficult for competitors to replicate."

"As we continue to generate clinical evidence across our precision-controlled psychedelic platform, building a robust global patent estate remains a key strategic priority. Strong intellectual property enhances the long-term value of our development programs, supports future partnering opportunities and reinforces our commercial positioning as we seek to develop next-generation psychedelic therapies for patients with significant unmet medical needs."

Entropy Neurodynamics is a clinical-stage biotechnology company focused on developing proprietary, novel formulations for the administration of psilocin in combination with psychotherapy to treat diseases with unmet medical needs. The Company's lead program, TRP-8803, is a proprietary formulation of IV-infused psilocin (the active metabolite of psilocybin) with potential to alleviate numerous shortcomings of oral psilocybin including: significantly reducing the time to onset of the psychedelic state, controlling the depth and duration of the psychedelic experience, and reducing the overall duration of the intervention to a commercially feasible timeframe. Development of TRP-8803 follows a number of Phase 2a clinical trials using oral psilocybin for the treatment of Binge Eating Disorder, Irritable Bowel Syndrome and Fibromyalgia. Results from each of these trials demonstrated the clinical benefits of psychedelic therapy and will be used to further enhance the development of TRP-8803.
