Freedom Care Group Holdings Limited (**Freedom** or **the Company**) (ASX: **FCG**), is pleased to release its Appendix 4C Cashflow Report for the quarter ended 30 June 2026.

Key Highlights

- Cash balance of \$0.41 million at 30 June 2026 (versus \$0.46 million at 31 March 2026).

Outlook

KPT continues to engage with the NDIA in relation to the recovery of outstanding receivables. Despite these ongoing efforts, the NDIA has not been receptive to KPT's engagement and has continued to delay responding to queries and processing payment of outstanding amounts. KPT has repeatedly raised concerns regarding the NDIA's lack of timely responses and the ongoing delays in releasing funds, which continue to impede the recovery of receivables.

The Company continues to explore all viable pathways to facilitate a relisting.

Financial and Corporate

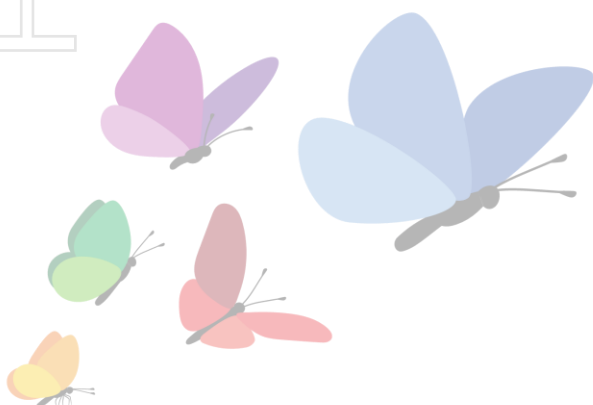
There were no payments to the Directors of the Company during the June 2026 quarter (see section 6 of the Appendix 4C).
