## SEC Form 4

Life360, Inc. ("Life360" or the "Company") (NASDAQ: LIF, ASX: 360), the San Francisco Bay Area-based leader in family safety and connection, advises that the sales announced in the attached Form 4 are US stock sales on the NASDAQ and pursuant to a Rule 10b5-1 trading plan.

A Rule 10b5-1 trading plan is a written, pre-established trading plan that provides for the automatic sale of Company stock pursuant to predetermined criteria. The Reporting Person adopted the plan at a time when they were not aware of any material non-public information about the Company.

The shares sold in connection with the option exercise were solely to cover the exercise price of the options and applicable tax withholding obligations. The Reporting Person retained all remaining net shares acquired upon exercise.

The Reporting Person adopted the plan at a time when they were not aware of any material nonpublic information about the Company.
- Includes common stock and the number of shares of common stock underlying Chess Depositary Interests ("CDIs") as converted on a 1:3 common stock to CDI ratio. The CDIs are traded on the Australian Securities Exchange (the "ASX") and are held by CHESS Depositary Nominees Pty, Limited, a subsidiary of ASX Limited, the company that operates the ASX.
- Includes 134,496 restricted stock units previously granted, each of which represents a contingent right to receive one share of the Issuer's common stock upon vesting.
- The price reported in Column 4 is the weighted average price. These shares were sold in multiple transactions at prices ranging from \$55.46 to \$56.13, inclusive, per share.
