As announced on 24 July 2026, the Company announced that as part of its strategic review, it expects to receive net proceeds of A\$400,000 from the termination of its hydrogen project.

As previously announced in September 2025, Lion announced the sale of its 2.5% interest in the Seram (Non-Bula) PSC for approximately US\$1.2 million. Completion is expected in Q3 2026 subject to customary conditions including Government approval.
