

FAR NORTHERN RESOURCES JUNE 2026 QUARTERLY REPORT

Highlights

- MRE 31% Upgrade at Bridge Creek Central Gold Deposit to 93 koz Au
- Total Northern Territory Project Contained gold ounces Increased by +23% to 117 koz Au
- Mineralisation extends from near surface and remains open along strike and down dip.
- Drill pads for diamond drilling completed on site in June.
- Drilling commenced in July 2026 for density, geotechnical and metallurgical studies.
- Extensive drilling program completed to link Bridge Creek Central to Ios.
- Review of historical Metallurgical studies on Heap Leach and Gravity CIP Leach Test by Normet 1994.

Bridge Creek

- The Diamond Drilling program (see the Company's announcements dated 12 June 2026 and 23 July 2026) commenced mid-July at Bridge Creek.
- A 6-hole program is planned for 750m.
- This drilling aims to gather core samples to test density, geotechnical, metallurgical and waste rock characteristics for the Bridge Creek Gold Deposit.

The MRE includes drilling completed up to the end of 2025.

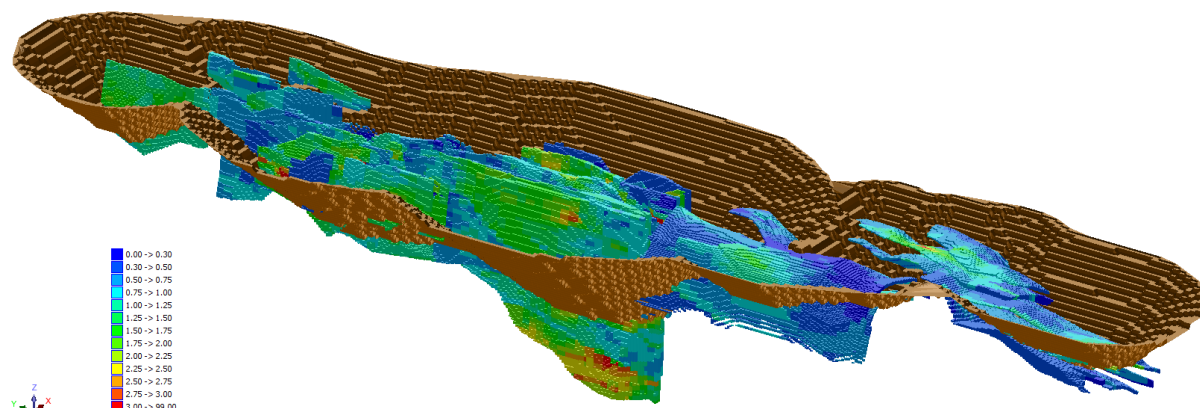


Figure 1: Bridge Creek MRE with Inferred Resource & Grade with whittle shell

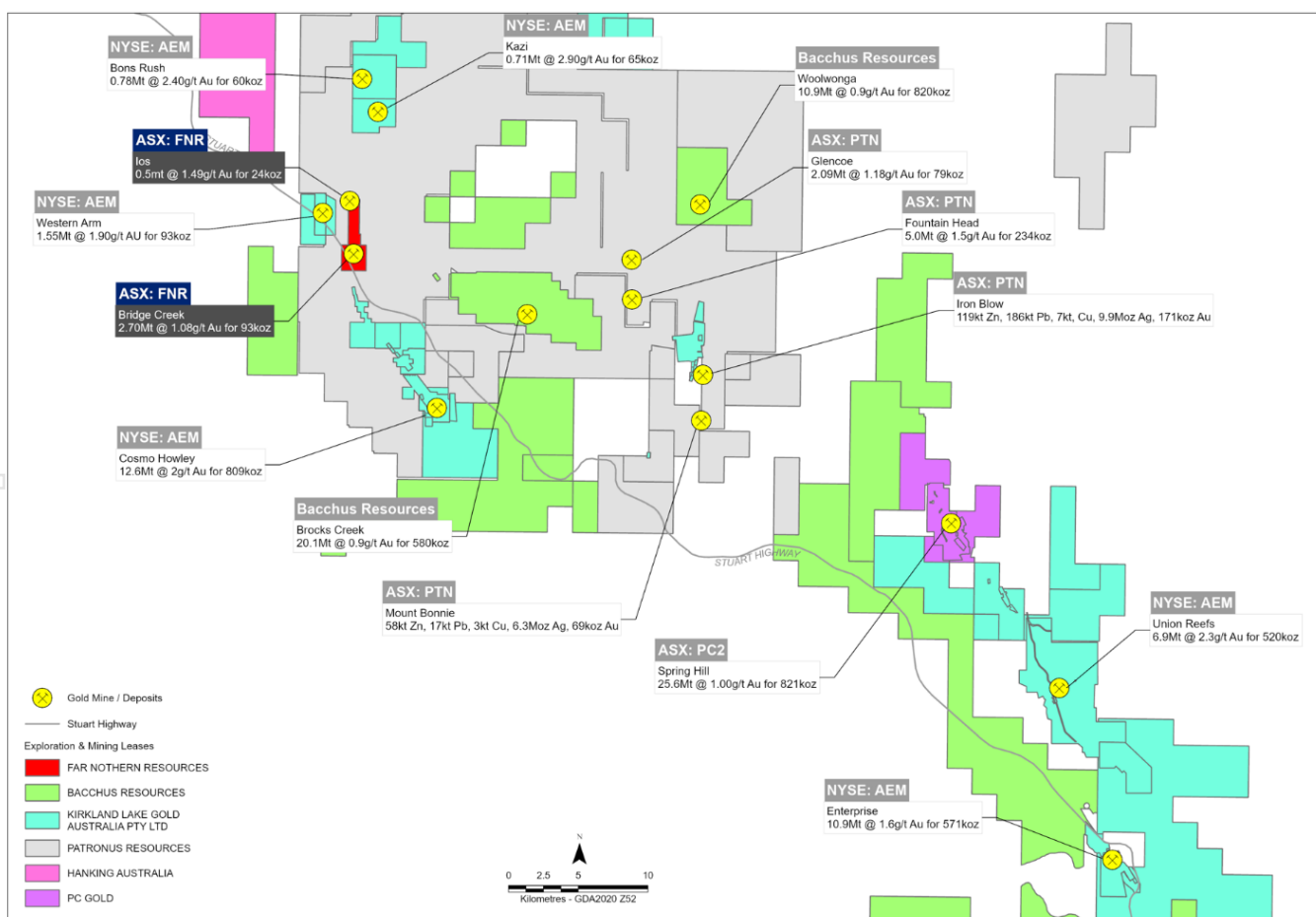


Figure 2: Project Location

During the quarter, the Company spent \$90,040 on exploration activities focussed mainly on the Bridge Creek project in the Northern Territory.

During the quarter ending 30 June 2026, the Company made payments of \$75,880 to related parties and their associates as reported in Item 6.1 of the attached Appendix 5B. The payments relate to existing remuneration arrangements including directors' fees and superannuation.
