Quarterly Activities Report 30 June 2026

Earth's Energy Limited (ASX: **EE1**) (**EE1**, **Earth's Energy** or the **Company**) provides its Quarterly Activities Report for the 3 months ending 30 June 2026 (**Quarter**).

Process to Identify new Assets

During the Quarter, the Company assessed multiple projects and assets, however, as at the date of this Quarterly Report, no opportunities suitable for a Reconciliation Transaction have been identified.

Suspension of securities

As previously advised to the market, the Company's securities were suspended from quotation on 7 May 2026. ASX had determined at that time, that based on the Company's determination that it was not in the best interests of shareholders to continue to undertake exploration expenditure on its Geothermal Exploration Licences, the Company's operations were not adequate to warrant continued quotation of its securities pursuant to Listing Rule 12.1. ASX further noted that until ASX could be satisfied that the Company was in compliance with the Listing Rules, in particular, Listing Rule 12.1, the Company's securities would remain in suspension.

Corporate

Cash balance

The Company's cash balance at 30 June 2026 was \$1.98 million.

During the Quarter, there was no expenditure on exploration and evaluation and there were no production or development activities.

Pursuant to the terms of the Deed (in respect of the settlement of dispute noted below), the Company placed an amount of \$400,000 in a trust account with the Company's lawyers in the March quarter, which was paid to the Minority Shareholders following the Company obtaining the Shareholder Approvals. This amount is a one-off payment and the Company's cash flows from operating activities (\$159,000 during the Quarter are materially lower than the March quarter.

During the Quarter, payments to related parties for directors' fees totalled \$42,000.

Mr Grant Davey, who is a Director of the Company, is a director and shareholder of Matador Capital Pty Ltd (**Matador Capital**). The Company makes payments to Matador Capital under

Shared Services and Office Use Agreements in which Matador Capital provides office space, office administration services, bookkeeping and accounting services and IT hardware and infrastructure to the Company. The services provided by Matador Capital are recovered from the Company on a cost-plus basis and totalled \$68,006.

Settlement of dispute

In March 2026, the Company reached agreement on the terms of a deed of termination, settlement and release (**Deed**) with respect to a dispute with Minority Shareholders to the joint venture that relates to the exploration and development of the Geothermal Exploration Licences (**Joint Venture**) that are the subject of the Joint Venture.

The Minority Shareholders, who are parties to the Joint Venture and the Deed, are Mimo Strategies Pty Ltd (ACN 140 796 112) as trustee for Mimo Trust, Ninety35 Pty Ltd (ACN 649 281 881) as trustee for 2Gen Family Trust and Stephen Biggins as trustee for the Rescap Family Trust (**Minority Shareholders**).

On 26 June 2026, the Company's shareholders approved the disposal of the Company's interests in the Joint Venture and making certain payments to the Minority Shareholders pursuant to Listing Rules 10.1 and 11.2 (**Shareholder Approvals**).

Details of the settlement reached with the Minority Shareholders are set out in the announcement dated 4 March 2026.
