Operations Review

The property leasing business remained stable in June 2026 Quarter. Leasing revenue totalled RMB1.1 million (AUD 243k) during the June 2026 Quarter, unchanged from RMB1.1 million (AUD 227k) in the March 2026 Quarter. The slight difference in the AUD equivalent is attributable to exchange rate movements between the two quarters.

The status of the exhibition centre remained unchanged from the March 2026 Quarter.

The existing vacancy (including areas subject to negotiation) rate being:

Warehouse (41,750m ²)	77%	(77% in March 2026)
Factories (17,784m ²)	67%	(67% in March 2026)
Exhibition Centre	95%	(95% in March 2026)
Administrative Building	46%	(46% in March 2026)

During the June 2026, a new lease of approximately 500 sqm of warehouse A was signed.

At the end of the Quarter the Group had cash at bank of \$0.086m.
