Sabres Successfully Drilled and Cased; Whalers Spudded **Production casing successfully run, cemented and tested at Sabres; drilling** **underway at Whalers**

Tulsa, Oklahoma, USA – 5 August 2026 – Brookside Energy Limited (ASX: BRK) (OTC Pink: RDFEF) (Brookside or the Company) is pleased to provide an update on drilling operations at the Suttles pad in the SWISH Area of Interest in Oklahoma's Anadarko Basin.

The Sabres 2-1-1S-3W SXH1 well has reached its planned total measured depth of approximately 14,200 feet after successfully drilling the lateral section within the targeted bench of the Sycamore Formation, in line with the well plan. The 5½-inch production casing string was then run to bottom, cemented in place and pressure tested, confirming the integrity of the installation and completing the drilling and casing phase at Sabres.

Following completion of these operations, Kenai Rig 18 walked the short distance across the Suttles pad to the Whalers 2-1-1S-3W WXH2 well location. Whalers was successfully spudded and is now drilling ahead in the surface-hole section of the wellbore, targeting the Woodford Formation.

Once Whalers has been drilled and cased, Sabres and Whalers will move into simultaneous fracture-stimulation operations.

Brookside holds an approximate 70% working interest in Sabres and Whalers. The two wells comprise the Suttles pad development program announced by Brookside on 7 July 2026.

Commenting on this announcement, Brookside Managing Director & CEO David Prentice said:

"Sabres is now drilled and cased to its planned depth, with production casing successfully run to bottom, cemented and tested. That significantly de-risks the drilling phase.

"The team executed safely and efficiently, then moved directly to Whalers, which is now drilling ahead. That is how this pad was designed to run: tight cycle times, minimal downtime and disciplined execution.

"Our focus remains clear: execute safely, control costs and bring both wells online efficiently."

Brookside looks forward to providing further updates as operations progress.

Development Unit or DSU	Development Unit or drilling spacing unit is the geographical area in which an initial oil and/or gas well is drilled and produced from the geological formation listed in a spacing order. The spacing unit communitizes all interest owners for the purpose of sharing in production from oil and/or gas wells in the unit. A spacing order establishes the size of the unit; names the formations included in the unit; divides the ownership of the unit for the formations into the "royalty interest" and the "working interest;" Only one well can be drilled and completed in each common source of supply. Additional wells may be drilled in a Development Unit, but only after an Increased Density Order is issued by the Oklahoma Corporation Commission.
Force Pooled	The Oklahoma Corporation Commission is authorized to establish well spacing and drilling units covering any common source of supply of hydrocarbons, or any prospective common source of supply. Once the unit is established, the Commission can force pool the interests of all the owners who own interests in that unit and who have not voluntarily joined in the development of that unit.
