The directors of HCW Funds Management Limited (ABN 58 104 438 100, AFSL 239882) (the Responsible Entity), present their report together with the consolidated financial statements of HealthCo Healthcare and Wellness REIT and the auditor's report thereon. The consolidated financial statements cover HealthCo Healthcare and Wellness REIT (the Trust or HCW) and the entities it controlled at the end of, or during the financial year ended 30 June 2026 (collectively referred to as the group).

HCW Funds Management Limited is ultimately owned by HMC Capital Limited (ASX: HMC).

Principal activities

The Trust is a registered managed investment scheme domiciled in Australia. The principal activity of the group is the investment in a portfolio of healthcare property assets including hospitals, aged care, government, life sciences and research, primary care and wellness property assets as well as other healthcare and wellness property adjacencies. The group did not have any employees during the year.

Review of operations and financial performance

The group's financial performance for the financial year was impacted by an asset recycling program which reduced the portfolio from 19 properties as at 30 June 2025 to 13 properties as at 30 June 2026, the group's interest in the HMC Wholesale Healthcare Fund (HWHF), which did not pay any distributions during the year ended 30 June 2026; and net unrealised fair value loss on investment properties, refer to Note 11.

In May 2025, two entities within the Healthscope group entered into receivership and administration. The group noted that the counterparties to the lease agreements that HCW and HWHF (the Landlords) contracted with were not in receivership or administration and that the existing cross default and termination rights under the lease agreements remained in place.

In December 2025, the group announced that the Landlords had entered into conditional agreements with alternative tenants for all the 11 hospitals currently tenanted by Healthscope and owned by the Landlords (the Hospitals).

In June 2026, HWHF entered into a binding agreement with an alternative tenant for The Mount Private Hospital in Western Australia. For the remaining 10 Hospitals, the Landlords and the alternative tenants have submitted an executable proposal to Healthscope's receiver, to facilitate the orderly transition to the alternative tenants. At the date of this report, commercial discussions are ongoing.

The group did not declare quarterly distributions for the year ended 30 June 2026 to preserve balance sheet liquidity. Further, the group settled on \$76.8 million of asset sales in the period. In August 2026, the group's bank loan which comprises a \$475.0 million senior secured debt facility expiring in November 2026, was extended to December 2027, refer to Note 14 Borrowings for further details.

The directors consider that the group will continue as a going concern, as explained in note 2 to the consolidated financial statements.

Property portfolio:

As at 30 June 2026, the group owned 13 (30 June 2025: 19) investment properties with a combined value of \$771.3 million (30 June 2025: \$889.2 million).

The movement in investment properties during the financial year was primarily driven by the group's asset recycling program and net unrealised fair value loss, refer to note 11.

At 30 June 2026, 7 investment properties were independently valued with the remaining investment properties being internally valued. The weighted average capitalisation rate of the portfolio was 6.2% (30 June 2025: 5.8%).

Asset recycling program:

As part of the group's asset recycling program, the group settled on the sale of 6 properties for a total consideration of \$76.8 million in the year.

Refer to note 11 to the consolidated financial statements for details of the asset sales.

Capital management:

The group had \$158.3 million in cash and undrawn debt as at 30 June 2026 (30 June 2025: \$143.7 million). As at 30 June 2026, 53.7% of drawn debt was hedged (30 June 2025: 83.9%), and the cost of debt was 6.0% per annum (30 June 2025: 5.6%).

On-market unit buy-back

In April 2024, the Responsible Entity announced an on-market unit buy-back of fully paid ordinary units in HCW for up to \$50.0 million of units. The Responsible Entity will only buy back units at such times as are considered beneficial to the efficient capital management of the group, and the Responsible Entity reserves the right to suspend or terminate the buy-back at any time. The Responsible Entity has purchased 18.2 million units on issue since the announcement. No units were purchased in the year ended 30 June 2026.

Distributions

Consistent with the group's ASX announcements on 22 September 2025 and 18 December 2025, no distributions were declared during the financial year to preserve balance sheet liquidity.

Significant changes in the state of affairs

There were no significant changes in the state of affairs of the group during the financial year.

Matters subsequent to the end of the financial year

In August 2026, the maturity date of the group's \$475.0 million senior secured debt facility was extended from November 2026 to December 2027, refer to Note 14 Borrowings for further details.

The Landlords and the alternative tenants have continued to progress commercial discussions regarding the executable proposal with Healthscope's receiver, to facilitate the orderly transition to the alternative tenants.

No other matter or circumstance has arisen since 30 June 2026 that has significantly affected, or may significantly affect the group's operations, the results of those operations, or the group's state of affairs in future financial years.

Likely developments and expected results of operations

There are no further developments that the directors of the Responsible Entity are aware of which could be expected to affect the results of the group's operations in subsequent financial years other than the information contained in the operating and financial review.

Group objectives

The group's objective is to provide exposure to a diversified portfolio underpinned by healthcare sector megatrends, targeting stable and growing distributions, long-term capital growth and positive social impact.

A key economic risk for the group relates to interest rate movements and the impact of this on property capitalisation rates and the cost of debt funding. The group seeks to mitigate this risk by investing in quality properties and, maintaining an appropriate capital structure with a target gearing ratio of 30% - 40% (Target Range).

Sustainability and climate-related and environmental risks

Sustainability is a key element of the group's business approach, driven by the belief that sustainable investments are aligned to long-term value creation and should not be dilutive to returns. HMC Capital Limited has established a sustainability subcommittee of the HMC Capital Board that governs HMC Capital's sustainability strategy and initiatives across its managed funds, including the group. HMC Capital are signatory to the United Nations Principles for Responsible Investing (UNPRI) and a Global Real Estate Sustainability Benchmark (GRESB) participating member. These two organisations provide an investment and reporting framework to help shape the group's future strategies and risk framework.

The geographic diversity of the group's portfolio limits the exposure to physical climate events to localised occurrences. The group also undertakes detailed due diligence on property acquisitions to assess environmental risks including contamination as well as any potential exposure to climate related events.

The group has considered the impact of environmental, social and governance (ESG) risk as well as the volatile economic environment in preparing its consolidated financial statements and in the exercise of critical accounting assumptions and estimates, including impacts occurring during the reporting period and the uncertainty of future effects. The group will continue to monitor these risks and the impact they have on the consolidated financial statements.

The Australian Sustainability Reporting Standards (ASRS), comprising *AASB S1 General Requirements for Disclosure of Sustainability-related Financial Information* – a voluntary standard and *AASB S2 Climate-related Disclosures* – a mandatory standard. *AASB S2 'Climate-related Disclosures'* sets out specific climate related disclosures and applies to entities required to prepare and lodge a financial report with ASIC under Chapter 2M. This mandatory sustainability reporting is expected to be applicable for the group for the first time for the year ending 30 June 2028.

Environmental regulation

The directors of the Responsible Entity are satisfied that adequate systems are in place to manage the group's environmental responsibility and compliance with regulations. The directors of the Responsible Entity are not aware of any material breaches of environmental regulations and, to the best of their knowledge and belief, all activities have been undertaken in compliance with environmental requirements.

Fees paid to and interests held in the group by the Responsible Entity

Fees paid to the Responsible Entity and its associates by the group during the year are disclosed in note 24 to the consolidated financial statements. The Responsible Entity was reimbursed \$0.8 million (2025: \$0.8 million) relating to Non-Executive Directors' remuneration. 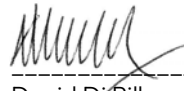

Note 1. General information

The consolidated financial statements cover HealthCo Healthcare and Wellness REIT (the Trust or HCW) as a consolidated entity consisting of HealthCo Healthcare and Wellness REIT and the entities it controlled at the end of, or during, the year (collectively referred to hereafter as the group). The consolidated financial statements are presented in Australian dollars, which is the group's functional and presentation currency.

HCW is a listed for-profit managed investment scheme, incorporated and domiciled in Australia. Its registered office and principal place of business is:

A description of the nature of the group's operations and its principal activities is included in the directors' report, which is not part of the consolidated financial statements.

HCW Funds Management Limited (ABN 58 104 438 100) (AFSL 239882) ('Responsible Entity') is the responsible entity of the Trust.

The Responsible Entity has appointed HMC Property Management Pty Ltd (the 'Property Manager') and HMC Investment Management Pty Ltd (the 'Investment Manager') to provide certain asset management, investment management, development management, leasing and property management services to the group in accordance with the Investment Management Agreement and Property Management Agreement ('Management Agreements'). The Responsible Entity, Property Manager and Investment Manager are ultimately owned by HMC Capital Limited (ASX: HMC).

The consolidated financial statements were authorised for issue, in accordance with a resolution of directors, on 17 August 2026.

Note 2. Material accounting policy information

The accounting policies that are material to the group are set out below. The accounting policies adopted are consistent with those of the previous financial year, unless otherwise stated.

New or amended Accounting Standards and Interpretations adopted

The group has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period, which are applicable to the group. The adoption of these Accounting Standards and Interpretations did not have any significant impact on the financial performance or position of the group for the financial year.

Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

Note 2. Material accounting policy information (continued)

Going concern

The consolidated financial statements have been prepared on a going concern basis.

At 30 June 2026, the group was in a net asset position of \$744.4 million and net current liability position of \$344.0 million. The net current liability position was driven by the classification of the \$372.3 million loan which was due to expire in November 2026. As set out in Note 29 Events after the reporting period, the term of the debt facility has subsequently been extended to December 2027, refer to Note 14 Borrowings for further details.

At 30 June 2026, cash and cash equivalents were \$55.6 million. Net operating cash inflows for the period was \$19.3 million. Net investing cash inflows for the period was \$71.8 million and net financing cash outflows for the period was \$76.0 million.

Cash and cash equivalents and undrawn debt at 30 June 2026 were \$158.3 million. To preserve balance sheet liquidity, the group did not declare quarterly distributions during the year. The group also settled on \$76.8 million of asset sales during the year ended 30 June 2026.

In May 2025, two entities within the Healthscope group entered into receivership and administration. The group noted that the counterparties to the lease agreements that HCW and HWHF (the Landlords) contracted with were not in receivership or administration and that the existing cross default and termination rights under the lease agreements remained in place.

In December 2025, the group announced that the Landlords had entered into conditional agreements with alternative tenants for all 11 hospitals currently tenanted by Healthscope and owned by the Landlords (the Hospitals).

In June 2026, HWHF entered into a binding agreement with an alternative tenant for The Mount Private Hospital in Western Australia. For the remaining 10 Hospitals, the Landlords and the alternative tenants have submitted an executable proposal to Healthscope's receiver, to facilitate the orderly transition to the alternative tenants. At the date of this report, commercial discussions are ongoing.

Healthscope continues to operate and remains compliant with all of its lease obligations as at 30 June 2026, and at the date of this report. In the event Healthscope were to become noncompliant with these obligations and alternative tenant arrangements are not in place, there is a possibility of negative impacts to the group's operating cashflow and increased risk of not meeting debt covenants. The effect of this would represent a material uncertainty as to whether the group would continue as a going concern.

Management has prepared cashflow forecasts that support the going concern basis of preparation and that the group can pay its debts as and when they become due and payable. The forecasts assume that the assets remain tenanted and those tenants remain compliant with their lease obligations. The group expects to comply with all covenants associated with the extended facility for the next 12 months after the reporting date.

The directors of the HCW Funds Management Limited, as Responsible Entity for the group, consider that the group will continue to fulfil all obligations as and when they fall due for the foreseeable future and accordingly consider that the group's consolidated financial statements should be prepared on a going concern basis.

Note 2. Material accounting policy information (continued)

Basis of preparation

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') and the *Corporations Act 2001*, as appropriate for for-profit oriented entities. These consolidated financial statements also comply with IFRS Accounting Standards as issued by the International Accounting Standards Board ('IASB').

Historical cost convention

The consolidated financial statements have been prepared under the historical cost convention, except for, where applicable, the revaluation of investment properties and derivative financial instruments at fair value through profit or loss.

Critical accounting estimates

The preparation of the consolidated financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements, are disclosed in note 3.

Parent entity information

In accordance with section 295(2)(b) of the *Corporations Act 2001*, these financial statements present the consolidated results of the group. Supplementary information about the parent entity is disclosed in note 25.

Principles of consolidation

The consolidated financial statements incorporate the assets and liabilities of all subsidiaries of HealthCo Healthcare and Wellness REIT ('Trust', 'HCW' or 'parent entity') as at 30 June 2026 and the results of all subsidiaries for the year then ended.

Subsidiaries are all those entities over which the group has control. The group controls an entity when the group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the group. They are de-consolidated from the date that control ceases.

Intercompany transactions, balances and unrealised gains on transactions between entities in the group are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of the impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the group.

The acquisition of subsidiaries is accounted for using the acquisition method of accounting. A change in ownership interest, without the loss of control, is accounted for as an equity transaction, where the difference between the consideration transferred and the book value of the share of the non-controlling interest acquired is recognised directly in equity attributable to the parent.

Non-controlling interest in the results and equity of subsidiaries are shown separately in the consolidated statement of profit or loss and other comprehensive income, consolidated statement of financial position and consolidated statement of changes in equity of the group. Losses incurred by the group are attributed to the non-controlling interest in full, even if that results in a deficit balance.

Note 2. Material accounting policy information (continued)

Where the group loses control over a subsidiary, it derecognises the assets including goodwill, liabilities and non-controlling interest in the subsidiary together with any cumulative translation differences recognised in equity. The group recognises the fair value of the consideration received and the fair value of any investment retained together with any gain or loss in profit or loss.

Operating segments

Operating segments are presented on the same basis as the internal reports provided to the Chief Operating Decision Makers ('CODM'), which is the Board of Directors of the Responsible Entity. The CODM is responsible for the allocation of resources to operating segments and assessing their performance.

Revenue recognition

The group recognises revenue as follows:

Property rental income

Property rental income is recognised on a straight-line basis over the lease term for leases with fixed rate or guaranteed minimum rent review clauses, net of incentives.

Other property income

Other property income represents direct and indirect outgoings recovered from tenants. The group recognises direct and indirect outgoings based on actual costs incurred in accordance with the terms of the related leases. Actual costs reflect the service provided. The amount of recoveries revenue is determined by the actual cost incurred and the terms in the lease. The outgoings recovered are recognised over the period the services are provided.

Interest

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

Leasing costs and tenant incentives

Leasing costs

Leasing costs are costs that are directly associated with negotiating and arranging an operating lease (including commissions, fees and costs of preparing and processing documentation for new leases). These costs are capitalised and amortised on a straight-line basis over the term of the lease.

Tenant incentives

Incentives such as cash, rent-free periods, lessee or lessor owned fit-outs may be provided to lessees to enter into a lease. These incentives are capitalised and are amortised on a straight-line basis over the term of the lease as a reduction of rental income. The carrying amount of tenant incentives is reflected in the fair value of investment properties.

Management fees and other expenses

All expenses are recognised on an accrual basis. Management fees are recognised as the services are rendered. The services relate to property and fund management roles provided by the Property Manager and Investment Manager collectively known as the Manager(s). Management fees are charged in accordance with the management fee arrangements.

Note 2. Material accounting policy information (continued)

Income tax

The Trust is intended to be treated as a 'flow-through' entity for Australian income tax purposes under the Attribution Managed Investment Trust rules such that the net income of the Trust will be taxable in the hands of the unitholders on an attribution basis.

Current and non-current classification

Assets and liabilities are presented in the consolidated statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in the group's normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the group's normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no right at the end of the reporting period to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

Trade and other receivables

Trade receivables are initially recognised at fair value and subsequently measured at amortised cost using the effective interest method, less any allowance for expected credit losses. Trade receivables are generally due for settlement within 30 days.

The group has applied the simplified approach to measuring expected credit losses, which uses a lifetime expected loss allowance. To measure the expected credit losses, trade receivables have been grouped based on days overdue.

Other receivables are recognised at amortised cost, less any allowance for expected credit losses. Debts that are known to be uncollectable are written off when identified.

Derivative financial instruments

Derivatives are initially recognised at fair value on the date a derivative contract is entered into and are subsequently remeasured to their fair value at each reporting date. Movements in fair value are recognised directly in profit or loss. Derivatives are classified as current or non-current depending on the expected period of realisation.

Investment in joint ventures

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

Note 2. Material accounting policy information (continued)

The group's investment in its joint venture is accounted for using the equity method. Under the equity method, the investment in the joint venture is initially recognised at cost. The carrying amount of the investment is adjusted to recognise changes in the group's share of net assets of the joint venture since the acquisition date. Goodwill relating to the joint venture is included in the carrying amount of the investment and is not tested for impairment separately. The consolidated statement of profit or loss reflects the group's share of the results of operations of the joint venture. Any change in other comprehensive income ('OCI') of those investees is presented as part of the group's OCI. In addition, when there has been a change recognised directly in the equity of the joint venture, the group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the group and the joint venture are eliminated to the extent of the interest in the joint venture. The financial statements of the joint venture are prepared using the same accounting policies and for the same reporting period as the group.

Investment properties

Investment properties comprise of freehold investment properties held at fair value through profit or loss.

Freehold properties are held for long-term rental yields and capital appreciation. Investment properties are initially recognised at cost, including transaction costs, and are subsequently remeasured to fair value at each reporting date. Movements in fair value are recognised directly to profit or loss. Investment properties are derecognised when disposed of or when the investment property is permanently withdrawn from use and there is no future economic benefit expected from its disposal. Gains or losses resulting from the disposal of freehold property are measured as the difference between the carrying value of the asset and disposal proceeds at the date of disposal and are recognised when control over the property has been transferred.

The group recognises the right-of-use asset as investment property. Right-of-use assets are measured at fair value which reflects the expected cash flows, including variable lease payments that are expected to become payable. The value of any recognised lease liability is then added back to the fair value to determine the carrying value of the investment property.

Rental guarantees

Rental guarantees income relating to investment property are capitalised in the consolidated statement of financial position. They are measured at fair value, equal to the net present value of expected future cash flows under the guarantee arrangements. The guarantee payments relating to the property are recorded in FFO as an adjustment to net profit over the period of the guarantee.

Trade and other payables

Trade and other payables represent liabilities for goods and services provided to the group prior to the end of the financial year and which are unpaid. Due to their short-term nature, they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

Borrowings

Loans and borrowings are initially recognised at the fair value of the consideration received, net of transaction costs. They are subsequently measured at amortised cost using the effective interest method. Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan and amortised over the period of the facility to which it relates.

Note 2. Material accounting policy information (continued)

Lease liabilities

A lease liability is recognised at the commencement date of a lease. The lease liability is initially recognised at the present value of the lease payments to be made over the term of the lease, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the group's incremental borrowing rate. Lease payments comprise of fixed payments less any lease incentives receivable, variable lease payments that depend on an index or a rate, amounts expected to be paid under residual value guarantees, exercise price of a purchase option when the exercise of the option is reasonably certain to occur, and any anticipated termination penalties. The variable lease payments that do not depend on an index or a rate are expensed in the period in which they are incurred.

Lease liabilities are measured at amortised cost using the effective interest method. The carrying amounts are remeasured if there is a change in the following: future lease payments arising from a change in an index or a rate used; residual guarantee; lease term; the certainty of a purchase option and termination penalties. When a lease liability is remeasured, an adjustment is made to the corresponding right-of-use asset, or to profit or loss if the carrying amount of the right-of-use asset is fully written down.

Finance costs

Finance costs are expensed in the period in which they are incurred.

Fair value measurement

When an asset or liability, financial or non-financial, is measured at fair value for recognition or disclosure purposes, the fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date; and assumes that the transaction will take place either: in the principal market; or in the absence of a principal market, in the most advantageous market.

Fair value is measured using the assumptions that market participants would use when pricing the asset or liability, assuming they act in their economic best interests. For non-financial assets, the fair value measurement is based on its highest and best use. Valuation techniques used to measure fair value are those that are appropriate in the circumstances and which maximise the use of relevant observable inputs and minimise the use of unobservable inputs.

Assets and liabilities measured at fair value are classified into three levels, using a fair value hierarchy that reflects the significance of the inputs used in making the measurements. Classifications are reviewed at each reporting date and transfers between levels are determined based on a reassessment of the lowest level of input that is significant to the fair value measurement.

For reoccurring and non-recurring fair value measurements, external valuers may be used with all investment properties having an external valuation at least once every two years. External valuers are selected based on market knowledge and reputation. Under the group's valuation policy, where there is a significant change in the fair value of an asset or liability from one period to another, an analysis is undertaken, which includes verification of major inputs applied to the latest valuation and comparison, where applicable with external sources of data.

Contributed capital

Units issued by the Trust are classified as equity.

Incremental costs directly attributable to the issue of new units or options are shown in equity as a deduction from the proceeds.

Note 2. Material accounting policy information (continued)

Distributions

Distributions are recognised when declared during the financial year and no longer at the discretion of the Trust.

Earnings per unit

Basic earnings per unit

Basic earnings per unit is calculated by dividing the profit attributable to the owners of HealthCo Healthcare and Wellness REIT, excluding any costs of servicing equity other than ordinary units, by the weighted average number of ordinary units outstanding during the financial year, adjusted for bonus elements in ordinary units issued during the financial year.

Diluted earnings per unit

Diluted earnings per unit adjusts the figures used in the determination of basic earnings per unit to take into account the effect of interest and other financing costs associated with dilutive potential ordinary units and the weighted average number of units assumed to have been issued for no consideration in relation to dilutive potential ordinary units.

Goods and Services Tax ('GST') and other similar taxes

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the tax authority. In this case it is recognised as part of the cost of the acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the tax authority is included in other receivables or other payables in the consolidated statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the tax authority, are presented as operating cash flows.

AASB 18 Presentation and Disclosure in Financial Statements

AASB 18 will replace *AASB 101 Presentation of Financial Statements* and applies for annual reporting periods beginning on or after 1 January 2027. The new standard introduces the following key requirements:

- Entities are required to classify all income and expenses into five categories in the consolidated statement of profit or loss, namely operating, investing, financing, discontinued operations and income tax categories. Entities are also required to present a newly-defined operating profit subtotal. Entities' net profit will not change;
- Management-defined performance measures (MPMs) are disclosed in a single note to the consolidated financial statements; and
- Enhanced guidance is provided on how to group information in the consolidated financial statements.

Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. There are no critical accounting judgements, estimates and assumptions that are likely to affect the current or future financial years.

Measuring fair value of investment property

The fair value assessment of investment property as at 30 June 2026 has been conducted using the information available at the time of the preparation of the consolidated financial statements and best estimates of future performance including the continued performance of the assets currently tenanted by Healthscope. Key inputs into the valuation included the discount rate, terminal yield, capitalisation rate, expected vacancy rates and rental growth rates. Refer to note 19 for details of valuation techniques used.

Note 4. Operating segments

The group's operating segments are based on the internal reports that are reviewed and used by the board of directors of the Responsible Entity (who are identified as the Chief Operating Decision Makers ('CODM')) in assessing performance and in determining the allocation of resources. The directors of the Responsible Entity have determined that there is one operating segment being its Australian operations.

The CODM monitors the performance of the business on the basis of Funds from Operations (FFO). FFO represents the group's underlying and recurring earnings from its operations, and is determined by adjusting the statutory profit or loss for items which are non-cash, unrealised or capital in nature. The accounting policies adopted for internal reporting to the CODM are consistent with those adopted in the consolidated financial statements.

The information reported to the CODM is on a quarterly basis.

Interest rate sensitivity

An official increase/decrease in interest rates of 50 (2025: 50) basis points would have an adverse/favourable effect on the profit for the year of \$0.9 million (2025: \$0.4 million) per annum. The group has adopted a lifetime expected loss allowance in estimating expected credit losses to trade receivables through the use of a provisions matrix using fixed rates of credit loss provisioning. These provisions are considered representative across all customers of the group based on recent sales experience, historical collection rates and forward-looking information that is available.

Generally, trade receivables are written off when there is no reasonable expectation of recovery. Indicators of this include the failure of a debtor to engage in a repayment plan, no active enforcement activity and a failure to make contractual payments for a period greater than 1 year.

Liquidity risk

A 25 basis point increase in capitalisation rate would result in a decrease in the fair value of investment property by \$30.9 million (30 June 2025: \$36.5 million) and a 25 basis point decrease in capitalisation rate would result in an increase in the fair value of investment properties by \$33.6 million (30 June 2025: \$39.8 million).

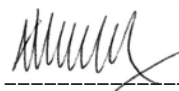

Independent Auditor's Report

Opinion

We have audited the **Financial Report** of HealthCo Healthcare and Wellness REIT (the Trust).

In our opinion, the accompanying Financial Report of the Trust gives a true and fair view, including of the **Group's** financial position as at 30 June 2026 and of its financial performance for the year then ended, in accordance with the *Corporations Act 2001*, in compliance with *Australian Accounting Standards* and the *Corporations Regulations 2001*.

The **Financial Report** comprises:

The **Group** consists of the Trust and the entities it controlled at the year end or from time to time during the financial year.

Basis for opinion

We conducted our audit in accordance with *Australian Auditing Standards*. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Our responsibilities under those standards are further described in the *Auditor's responsibilities for the audit of the Financial Report* section of our report.

We are independent of the Trust and HCW Funds Management Limited (the Responsible Entity) in accordance with the auditor independence requirements of the *Corporations Act 2001* and the ethical requirements of the APES 110 *Code of Ethics for Professional Accountants (including Independence Standards)* issued by the Accounting Professional & Ethical Standards Board Limited (the Code) that are relevant to audits of the financial report of public interest entities in Australia. We have fulfilled our other ethical responsibilities in accordance with these requirements.

Material uncertainty related to going concern

We draw attention to Note 2 "Going Concern" in the Financial Report. The events or conditions in Note 2 indicate a material uncertainty exists that may cast significant doubt on the Group's ability to continue as a going concern and, therefore, whether it will realise its assets and discharge its liabilities in the normal course of business, and at the amounts stated in the Financial Report. Our opinion is not modified in respect of this matter.

In concluding that there is a material uncertainty relating to going concern, we evaluated the extent of uncertainty regarding events or conditions casting significant doubt on the Group's assessment of going concern. Our approach to this involved:

- Assessing the Group's cash flow forecasts for incorporation of the Group's operations and plans to address going concern, in particular in light of the recent history of announcements regarding the Healthscope tenancy;
- Evaluating the Group's rights under existing lease arrangements to terminate those leases and replace the existing tenant, Healthscope;
- Evaluating the feasibility and the timing of the possibility to replace the existing tenant, Healthscope, with alternative hospital operators, including evaluating the executable proposal submitted to Healthscope's receiver;
- Obtaining and inspecting the debt facility extension agreement which was extended from November 2026 to December 2027; and
- Determining the completeness of the Group's going concern disclosures for the principal matters casting significant doubt on the Group's ability to continue as a going concern, the Group's plans to address these matters and the material uncertainty.

Key Audit Matters

Key Audit Matters are those matters that, in our professional judgement, were of most significance in our audit of the Financial Report of the current period.

These matters were addressed in the context of our audit of the Financial Report as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

In addition to the matter described in the *Material uncertainty related to going concern* section, we have determined the matter described below to be the Key Audit Matter.

Valuation of investment properties (\$771.3m), including investment properties in equity accounted investments (\$319.9m)

The valuation of these properties requires significant judgement and is based on assumptions not directly observable in the market. Key assumptions include capitalisation rate, discount rate, terminal yield and future rental income. These assumptions are influenced by market and economic conditions, which may change over time. At each reporting date, the Directors of the Responsible Entity determine the fair value of the investment property portfolio in accordance with the Group's valuation policy. The policy requires each property to be externally valued by an independent valuation expert at least once every two years. Between external valuations, properties are valued using an internal valuation model. The valuation of investment property was a key audit matter because: • Investment properties, including the Group's share of investment properties held in investments accounted for using the equity method, is a significant balance in the Consolidated Statement of Financial Position. These assets represent 95% of the Group's total assets. • Changes in property valuations can have a significant impact on the Group's total comprehensive income for the year. • Property valuations involve significant judgement and are sensitive to changes in key assumptions. • The valuation methodology incorporates unobservable inputs, increasing the level of estimation uncertainty. In assessing this key audit matter, we involved our real estate valuation specialists, who understand the Group's investment property portfolio and business and the economic environment it operates in.	methodologies adopted by the Group with accounting standards, industry practice and the Group's policies; • Assessing the competence, capabilities and objectivity of the external valuers engaged by the Group, as well as internal valuers involved in the valuation process; • Working with our real estate valuation specialists, we read published reports and industry commentary to gain an understanding of prevailing property market conditions; • Enquiring with management regarding the specifics of the investment property portfolio including, amongst other things, any significant leasing activity, capital expenditure or vacancies impacting the portfolio; • Working with our real estate valuation specialists, we performed a risk assessment over the Group's investment property portfolio to identify higher risk properties. Our risk assessment was informed by our understanding of each property, key valuation assumptions including capitalisation rate, discount rate, terminal yield and future rental income, and our understanding of current market conditions; • For properties identified as higher risk, we performed the following procedures, where relevant: – Testing, on a sample basis, the mathematical accuracy of the valuation methodologies; – Enquiring, on a sample basis, with the external valuers to understand the valuation methodologies and key assumptions applied in the external valuations; – With the assistance of our real estate valuation specialists, challenged key assumptions, including capitalisation rate, discount rate, terminal yield and future rental income. We did this by comparing them to industry data, recent market transactions, historical asset performance and property-specific characteristics such as location, condition, land area and passing income. We also applied our industry knowledge and experience, with a focus on outlier
