DSO Operations Commence at Horseshoe Lights Copper Project WA

- Direct Shipping Ore ('DSO') preparation activities to commence this month including initial hand held XRF grade control to consolidate high-grade DSO stockpiles ready for immediate sale.
- Appointment of Senior Site Executive completed along with lodgement of Notice of Operations commencement.
- Mobilisation of operations personnel to site in early September.
- Horseshoe will stockpile 500 tonnes of DSO material progressively ready for sale. The first stockpile will be ready for sale in October and the second in December of this year (*see timeline below*) with additional stockpiles defined thereafter.
- Multiple buyers have been identified and engaged. Horseshoe will manage the full process from stockpiling, loading and delivery to purchasers.
- Strengthening copper price has recently sustained a price above \$US6.50/lb being the base at which DSO sales are being targeted.
- Growing demand for high-grade copper concentrates provides buoyant demand for the DSO product. Precious metal credits will add materially to the value of DSO stockpiles.
- Revenue from DSO sales will provide Horseshoe with the funds to progress Scoping Study on planned small and large scale oxide heap/vat leach and cementation operations and further exploration drilling to define the extended depths and potential strike of the HSL and Motters resources.

Horseshoe Metals Limited (ASX: HOR) (the 'Company') is pleased to confirm commencement of Direct Shipping Ore ('DSO') operations at the Company's 100%-owned Horseshoe Lights Copper-Gold Project (HSL) in Western Australia where the Company plans to stockpile and sell high grade DSO material in 500 tonne batches at a time.

The first two stockpiles are expected to be sold in October and December respectively, with additional sales expected to materialise thereafter once the extent of the material is defined. This is a very pleasing development for the Company and represents a key milestone in bringing the under-developed HSL project back into production with a staged and low capex/opex operation planned.

A key development and catalyst has been the appointment of the SSE and the lodgement of the Mining Commencement Notice which allows Horseshoe to mobilise additional key work personnel to site in early September. Grade control work on site and operations ramp up plans will commence prior to this.

Precious metal credits are expected to add significant value to the Copper DSO (see release dated 28 April 2026).

GM – Oxide Copper Operations Steven Sickerdick commented: *“Today’s announcement represents the first step in bringing HSL back into production. When mining operations ceased at the project over 32 years ago, extensive remnant stockpiles of DSO material have remained onsite and untouched and they hold considerable unlocked value, particularly at the current copper price. Whilst we have had good engagement with multiple offtake partners, the level of demand means that it makes better economic sense for Horseshoe to commence DSO operations, quickly establish sales channels and advance the operations ourselves and book revenue in the very near term. We are encouraged by the level of interest from a large number of potential buyers.*

Revenue from the DSO operations provides the catalyst to prepare a scoping study and potentially fund a larger but low-cost small and large scale oxide heap/vat leach and cementation operation, and we are confident of advancing this very rapidly and permitting it accordingly. As we have previously stated, HSL is vastly underdeveloped and underexplored and the project has lots of upside from staged production and further exploration that is also being considered where we will look to define the extent of the oxide and sulphide material along strike and the sulphide material beyond the current 200m depth of the historical pit.”

The Company will provide a further update from the outcomes of the DSO XRF grade control results prior to personnel commencing on site.

Horseshoe Lights Copper-Gold Project Summary

The Horseshoe Lights Copper-Gold Project is the original Cu/Au VMS discovery in the Bryah Basin and is located approx. 60 km west of DeGrussa Copper Mine owned by Sandfire Resources (ASX: SFR). Past production from Horseshoe Lights includes around **316,000 oz Au & 55 kt Cu metal** in two phases of mining, and the deposit contains a current *in situ* resource **128 kt Cu metal @ 1.0% (0.5% cut-off) and 36,000 oz Au** (refer Table 1).

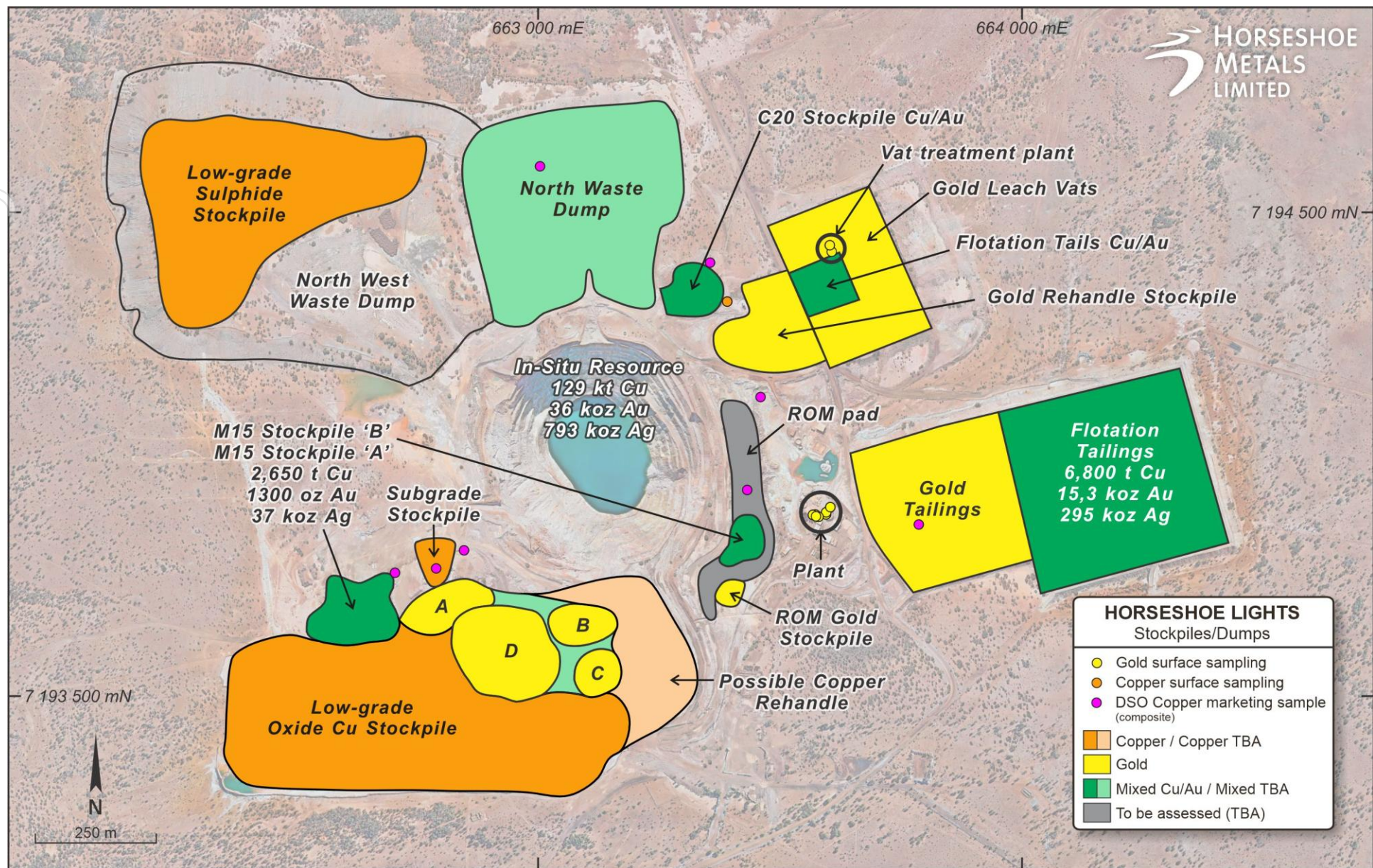


Figure 1 – Surface Stockpiles and Dumps showing Sample Locations

The surface materials have previously been broadly grouped as follows (Figure 1):

Copper - Gold	Flotation tailings, Vat 2, M15/C20 Stockpiles and North Dump
Copper	Subgrade, rehandle, Low-grade oxide and sulphide stockpiles
Gold	Gold tailings, leach vats, low grade, rehandle and ROM stockpiles

Activities have focussed on the following potential development sequence utilising copper oxide surface materials:

- 1. Copper concentrate offtake discussions including potential for offtake funding*
- 2. Scavenging of remnant coarse DSO material, bagging and transport*
- 3. Heavy Media Separation of fine DSO material from select stockpiles*
- 4. Small Scale Heap/Vat Leach of oxide material followed by cementation*
- 5. Large Scale Heap/Vat leach of surface oxide material followed by cementation*

The above are subject to any statutory and regulatory approvals that may be required.

HSL Copper Surface Materials: DSO Scavenging Coarse Material

The copper phase of mining included early DSO copper production that has left subgrade and rehandle DSO material around the site. Areas identified and assessed as having strong DSO potential include M15, Subgrade and C20 stockpiles along with rehandle and surface pimple dumps located on the North Waste dump, Gold tailings and Southern low-grade stockpile (Figure 1 – see release dated 31 October 2023). The coarse material is easily scavenged utilising loaders and excavators equipped with sieve buckets.

About Horseshoe Metals Limited

Horseshoe Metals Limited (ASX:HOR) is a copper and gold-focused Company with a package of tenements covering approximately 500km² in the highly prospective Peak Hill Mineral Field, located north of Meekatharra in Western Australian and mineral interests in South Australia. The Company manages the Horseshoe Lights Project and the Kumarina Project in Western Australia, and the Glenloth Gold Project in South Australia.

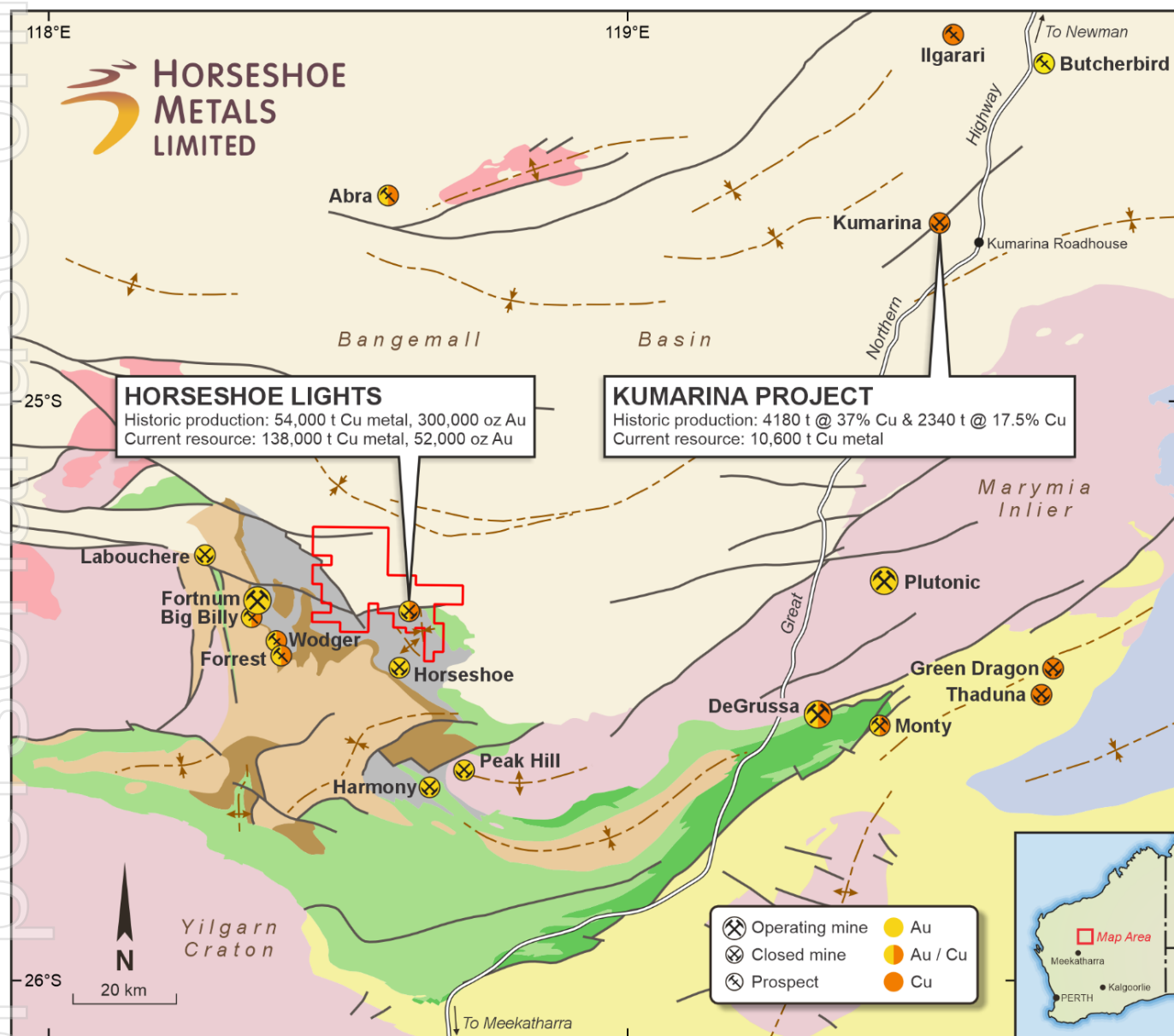


Figure 2: Location of Horseshoe Lights Copper-Gold Project and Kumarina Project in the Murchison, WA

About the Horseshoe Lights Project

The Horseshoe Lights Project includes the historic open pit of the Horseshoe Lights copper-gold mine which operated up until 1994, producing over 300,000 ounces of gold and 54,000 tonnes of contained copper, including over 110,000 tonnes of Direct Shipping Ore (DSO) which graded between 20-30% copper.

The Horseshoe Lights ore body is interpreted as a deformed Volcanogenic Hosted Massive Sulphide (VMS) deposit that has undergone supergene alteration to generate the gold-enriched and copper-depleted cap that was the target of initial mining. The deposit is hosted by quartz-sericite and quartz-chlorite schists of the Lower Proterozoic Narracoota Formation.

Past mining was focused on the Main Zone, a series of lensoid ore zones, which passed with depth from a gold-rich oxide zone through zones of high-grade chalcocite mineralisation into massive pyrite-chalcopyrite. To the west and east of the Main Zone, copper mineralisation in the Northwest Stringer Zone and Motters Zone consists of veins and disseminations of chalcopyrite and pyrite and their upper oxide copper extensions. Table 1 summarises the total Mineral Resources for the Horseshoe Lights Project.

About the Kumarina Project

The copper deposits at the Kumarina Project were discovered in 1913 and worked intermittently until 1973. The workings extend over nearly 5km as a series of pits, shafts and shallow open cuts. At the main Kumarina Copper Mine, the workings are entirely underground with drives from the main shaft extending for some 200m in the upper levels and for about 100m in the lower levels at a depth of 49m below surface.

Incomplete records post-1960s make it difficult to estimate the total copper production from the workings. However, indications are that the Kumarina Copper Mine was the second largest producer in the Bangemall Basin group of copper mines. Recorded production to the late 1960s is 481t of copper ore at a high-grade of 37.0% Cu and 2,340t at a grade of 17.51% Cu. An initial Mineral Resource Estimate for the Rinaldi deposit was completed by the Company in 2013 (see 30 June 2013 Quarterly Report announced on 31 July 2013). The total Measured, Indicated and Inferred Mineral Resource Estimate is shown in Table 2 below.
