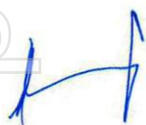

<sup>5</sup> The Vicinity Centres Distribution Reinvestment Plan (**DRP**) will apply to the final distribution for the six-month period to 30 June 2026. Election to participate in the **DRP** must be received by 27 August 2026. In accordance with the **DRP** rules, the acquisition price will be equal to the arithmetic average of the daily volume weighted average market price for stapled securities sold through normal trade from 28 August to 3 September 2026. The **DRP** will operate at a 1% discount. Stapled securities issued under the **DRP** will rank equally with existing stapled securities.
