Dear Shareholder

On behalf of the Directors, I am pleased to invite you as a valued Shareholder of SQX Resources Limited (**Company**) to participate in a non-renounceable pro rata entitlement offer of new fully paid ordinary shares in the Company (**New Shares**) at an issue price of \$0.04 per New Share (**Issue Price**) to raise up to approximately \$2,468,000 (**Entitlement Offer**).

Entitlement Offer

Pursuant to the Entitlement Offer, the Company intends to raise up to approximately \$2,468,000 (before costs) by the issue of up to 61,700,000 New Shares.

Under the Entitlement Offer, Eligible Shareholders are entitled to acquire 2 New Shares for every 3 Shares held at 7:00pm (AEST) on the Record Date. New Shares issued under the Entitlement Offer will rank equally with existing Shares.

Underwriting

The Entitlement Offer is fully underwritten by Alpine Capital Pty Ltd (ABN 96 155 409 653) (AFSL 422477) (**Underwriter**) for \$2,468,000 (**Underwritten Amount**). In addition to committing to take up their full Entitlements, the Directors have agreed to sub-underwrite the Entitlement Offer up to a total of \$130,000. For more details regarding the Underwriter, the control implications of the Entitlement Offer and the terms of the Underwriting Agreement, please refer to Sections 3.4, 5.1 and 5.3.

Actions required to take up your Entitlement

As an Eligible Shareholder, subject to the terms in this Offer Booklet, you may choose one of the following options:

- (a) apply for all of your Entitlement under the Entitlement Offer;
- (b) apply for all of your Entitlement and apply for additional shares under the Shortfall Facility;
- (c) apply for part of your Entitlement and allow the balance to lapse; or
- (d) take no action.

The Entitlement Offer closes at **5.00pm (AEST)** on the Closing Date. To participate in the Entitlement Offer, your application for New Shares must be received before this time in accordance with the instructions in the accompanying Entitlement and Acceptance Form and in Section 4.

The Directors reserve the right not to proceed with the whole or part of the Entitlement Offer at any time prior to issue of the Offer Shares. In that event, Application Monies (without interest) will be returned in full to the Applicants. An extension of the Closing Date for the Entitlement Offer will delay the anticipated date for issue of the Offer Shares. The commencement of quotation of Offer Shares is subject to confirmation from ASX.

Unless otherwise stated, references to times in this document are to times in Brisbane, Australia for holders of Shares on ASX.

Eligible Shareholders wishing to participate in the Entitlement Offer are encouraged to submit their Entitlement and Acceptance Form and Application Monies as soon as possible after the Entitlement Offer opens.

3. Details of the Entitlement Offer

3.1 Overview of the Entitlement Offer

The Company proposes to raise up to approximately \$2,468,000 under the Entitlement Offer through the issue of up to approximately 61,700,000 New Shares. Under the Entitlement Offer, the Company is offering Eligible Shareholders the opportunity to subscribe for 2 New Shares for every 3 existing Shares held at the Record Date, at the Issue Price of \$0.04 per New Share (**Entitlement Offer**).

The Issue Price represents a discount of approximately 31.0% to the Company's closing price of Shares on Thursday, 20 August 2026, of \$0.0580 being the last trading day prior to the announcement of the Entitlement Offer and a 19.3% discount to the Company's 10-day VWAP on the ASX of \$0.0496.

Where fractions arise in the calculation of an Entitlement, they have been rounded up to the next whole number of New Shares.

The Entitlement Offer also comprises a shortfall facility under which New Shares attributable to Entitlements:

- (a) not taken up by Eligible Shareholders; and
- (b) that would have been offered to Ineligible Shareholders if they had been entitled to participate in the Entitlement Offer,

will be offered to Eligible Shareholders that have accepted their Entitlement in full (**Shortfall Facility**).

3.2 Eligible Shareholders

This Offer Booklet contains an offer of New Shares to Eligible Shareholders. Eligible Shareholders are those holders of Shares who:

- (a) are registered as a holder of Shares on the Record Date;
- (b) have a registered address in Australia or New Zealand;
- (c) are not in the United States and are not a person (including a nominee or custodian) acting for the account or benefit of a person in the United States (to the extent such person holds Shares for the account or benefit of such person in the United States); and
- (d) are eligible under all applicable laws to receive an offer under the Entitlement Offer without any requirement for a prospectus or similar disclosure document to be lodged or registered.

Shareholders that are not Eligible Shareholders are **Ineligible Shareholders**. The Company reserves the right to determine whether a Shareholder is an Eligible Shareholder or an Ineligible Shareholder.

The Company has determined that it is unreasonable to extend to Ineligible Shareholders the opportunity to participate in the Entitlement Offer because of the limited expected take-up from these holders and the cost of complying with the applicable regulations in jurisdictions outside Australia and New Zealand.

The Entitlements of Eligible Shareholders who also hold options to acquire Shares will be calculated on the basis of the number of Shares they hold on the Record Date, disregarding any options which have not been exercised or converted before that time.

3.3 Shortfall Facility

A Shortfall Facility will allow Eligible Shareholders that have fully subscribed for their Entitlements under the Entitlement Offer to subscribe for additional New Shares in excess of their Entitlement (**Shortfall Shares**). Eligible Shareholders can apply for Shortfall Shares by completing the relevant part of the Entitlement and Acceptance Form, or (where relevant, through BPAY®). Refer to Section 4.3 for further details. The final quantity of Shortfall Shares and the results of the applications will be calculated and finalised on the Entitlement Offer Shortfall Notification Date.

Any Shortfall Shares will be limited to the extent there are sufficient New Shares from Eligible Shareholders who do not take up their full Entitlements or from New Shares that would have been offered to Ineligible Shareholders if they had been entitled to participate in the Entitlement Offer.

In addition, preferential allocations of Shortfall Shares will be given to Eligible Shareholders to the extent required to bring their holding of Shares at close of the Entitlement Offer up to a marketable parcel of \$2,000 based on the Issue Price (**Marketable Parcel Preference**).

Aside from the Marketable Parcel Preference, there is no guarantee that those Eligible Shareholders will receive the number of Shortfall Shares applied for. The Company's decision on the number of New Shares and Shortfall Shares to be allocated to you will be based on the allocation policy in Section 3.4 and be final.

In the event of a scale back, the difference between the Application Monies received, and the number of New Shares allocated to you multiplied by the Issue Price, will be refunded by the Company, without interest, following allotment, as required by the Corporations Act.

3.4 Shortfall Facility allocation policy

Unless otherwise determined by the Underwriter and the Company, the Shortfall Shares will be allocated according to the following priority:

- (a) firstly, pursuant to the Marketable Parcel Preference; and
- (b) secondly, at the discretion of the Company and the Underwriter, to Sub-Underwriters pro rata to their respective Sub-Underwriting Commitments (noting that the Underwriter has procured sub-underwriting commitments for its full underwriting obligation - refer to Sections 5.1 to 5.3).

This shortfall allocation policy has been structured to allow the Underwriter to disperse Shortfall Shares across a broad number of Sub-Underwriters.

In the event it is necessary to scale back applications for Shortfall Shares by Eligible Shareholders, then the scale back will be at the discretion of the Company and the Underwriter.

The Directors are not entitled to participate in the Shortfall Facility without Shareholder approval under Listing Rule 10.11. However, the Underwriter is entitled to subscribe for Shares pursuant and up to the Underwritten Amount without Shareholder approval, and the Directors (or their related entities) may subscribe for Shortfall Shares as Director Sub-Underwriters to the Entitlement Offer in reliance on the exception in Listing Rule 10.12 (exception 2), in addition to taking up their Entitlements. Details of the Underwriting are set out in Section 5.1.

No Shortfall Shares will be issued to an applicant if doing so would, to the extent of the knowledge of the Company, result in a breach of the ASX Listing Rules or the restrictions on obtaining or increasing voting power under Chapter 6 of the Corporations Act, or would be otherwise contrary to the Corporations Act or ASX Listing Rules (in this regard, refer to Section 5.3).

3.5 Ranking of New Shares

New Shares issued under the Entitlement Offer will rank equally with existing Shares.

3.6 Effect of the Entitlement Offer capital structure

(a) Share capital

3.9 Impact of the Entitlement Offer on your Shareholding and Possible Dilutive Effect

The dilutionary effect of the Entitlement Offer on your shareholding will depend on whether you are an Eligible Shareholder and if so, whether you elect to subscribe for some or all of your Entitlement.

If an Eligible Shareholder does not take up its entitlement under the Entitlement Offer or a Shareholder is an Ineligible Shareholder, the shareholder will suffer a dilution of up to approximately 40% of its interest in the Company assuming the Entitlement Offer is fully subscribed.

Refer to Section 5.2 for information about the effect of the Entitlement Offer and Underwriting on control of the Company.

3.10 Withdrawal of Entitlement Offer

The Board reserves the right to withdraw all or part of the Entitlement Offer at any time before the issue of New Shares, in which case the Company will refund Application Money without payment of interest in accordance with the Corporations Act.

3.11 No cooling off rights

Cooling off rights do not apply to a subscription for New Shares under the Entitlement Offer. You cannot withdraw your application or payment once it has been accepted, except as allowed by law.

3.12 Minimum subscription

There is no minimum subscription for the Entitlement Offer.

3.13 Rounding of Entitlements

Where fractions arise in the calculation of Entitlements, they will be rounded up to the nearest whole number of New Shares.

3.14 **Opening and Closing Date for applications**

The Entitlement Offer opens for acceptances on the Opening Date and all Entitlement and Acceptance Forms and payments of Application Money must be received by no later than 5.00pm (AEST) on the Closing Date, subject to the Company varying the Closing Date in accordance with the ASX Listing Rules.

3.15 **Quotation of New Shares and Admission of New Shares to trading on ASX**

The Company intends to apply within seven (7) days of the Closing Date of the Entitlement Offer to the ASX for the New Shares issued pursuant to the Entitlement Offer to be granted official quotation by ASX.

Should the New Shares not be granted official quotation on the ASX within 3 months after the date of this Booklet, none of the New Shares offered under this Booklet will be issued and all Application Monies will be refunded without interest to Applicants within the time prescribed by the Corporations Act.

3.16 **Allotment of New Shares**

It is expected that allotment of the New Shares will take place as soon as practicable after the Closing Date. It is expected that the New Shares will be allotted no later than the date specified in the Timetable. However, if the Closing Date is extended, the date for allotment may also be extended.

No allotment of New Shares will be made until permission is granted for their quotation by ASX.

Holding statements for New Shares issued under the Entitlement Offer will be mailed in accordance with the ASX Listing Rules and timetable at the commencement of this Offer Booklet as soon as practicable after their issue.

3.17 **Shareholders outside Australia**

(a) **General restrictions**

The Entitlement Offer is not extended to, and no New Shares are offered or will be issued to, persons who do not meet the requirements in this section.

- (b) amounts received by the Company in excess of the Issue Price multiplied by your Entitlement (**Excess Amount**) may be treated as an application to apply for as many Additional Shares as your Excess Amount will pay for in full; and
- (c) if you do not pay for your full Entitlement, you are deemed to have taken up your Entitlement in respect of such whole number of New Shares as is covered in full by your Application Money.

If you do not take up your Entitlement to New Shares under the Entitlement Offer by the Closing Date, the Entitlement Offer to you will lapse.

4.7 **If you do not wish to accept all or any part of your Entitlement**

To the extent you do not accept all or any part of your Entitlement, it will lapse. Any New Shares that you would have otherwise been entitled to under the Entitlement Offer (or New Shares that relate to the portion of your Entitlement that has not been accepted) may be offered as Shortfall Shares. Any offer of Shares not issued under the Entitlement Offer and the Shortfall Facility may be placed to new professional and sophisticated investors by the Board of the Company in accordance with the ASX Listing Rules within 3 months of the Closing Date.

If you do not take up your Entitlement, those Entitlements that you do not take up will lapse and you will not receive any payment or value for them.

5. Effect of the Entitlement Offer on Control of the Company

5.1 Underwriting Agreement

The Entitlement Offer is fully underwritten by Alpine Capital Pty Ltd (ABN 96 155 409 653) (AFSL 422477) (**Underwriter**). To this end, the Company has entered into an underwriting agreement (**Underwriting Agreement**) with the Underwriter who has agreed to fully underwrite the Entitlement Offer, representing the maximum 61,700,000 New Shares offered under the Entitlement Offer (**Underwritten Shares**). In addition, the Directors have agreed, in their capacities as Shareholders (either directly or through their nominated entities) to take up their full respective Entitlements, and in their separate capacities as Director Sub-Underwriters, to sub-underwrite 3,250,000 Shortfall Shares as part of the Entitlement Offer.

Under the Underwriting Agreement, the Underwriter may procure sub-underwriting commitments (**Sub-Underwriting Commitments**) for the Entitlement Offer and is responsible for negotiating and paying any sub-underwriting fees. The Company is advised that the Underwriter has entered into sub-underwriting agreements (each, a **Sub-Underwriting Agreement**) with the Director Sub-Underwriters (see below) and a number of the Underwriter's clients (each, a **Broker Sub-Underwriter**), none of whom (except the Director Sub-Underwriters) is a related party of the Underwriter or the Company, for an aggregate amount equal to the full amount of the Entitlement Offer (representing 61,700,000 New Shares).

The Directors Sub-Underwriters (being the Directors or their related entities) have agreed to sub-underwrite the Entitlement Offer for a total of \$130,000 (representing 3,250,000 Shortfall Shares) in the following proportions:

- (a) Mr Julian Stephens: \$50,000 (1,250,000 Shortfall Shares, which with his Entitlement, implies a maximum voting power at close of the Entitlement Offer, of 9.27%);
- (b) Vanguard Superannuation Pty Ltd (an entity related to Mr Bevan Tarratt): \$50,000 (1,250,000 Shortfall Shares, which with his Entitlement, implies a maximum voting power at close of the Entitlement Offer, of 2.02%);
- (c) Mr David Sanders: \$20,000 (500,000 Shortfall Shares, implying a maximum voting power at close of the Entitlement Offer, of 0.32%)); and
- (d) Mr Brent van Staden: \$10,000 (250,000 Shortfall Shares, implying a maximum voting power at close of the Entitlement Offer, of 0.16%).

The Underwriter has dispersed the remaining 58,450,000 Underwritten Shares to Broker Sub-Underwriters.

The effect of the Underwriting Agreement is that the Underwriter is obligated to subscribe (or to procure subscriptions from the Sub-Underwriters (consisting of the Broker Sub-Underwriters and Director Sub-Underwriters)), in the proportions set out above, for the number of Shortfall Shares remaining after the allocation of the Shortfall Shares under the Shortfall Facility, up to the number of Underwritten Shares.

In consideration for the Underwriting, the Company will pay the Underwriter an underwriting management fee of 2.0% of the Underwritten Amount (plus GST) and an underwriting selling fee of 4.0% of the Underwritten Amount (plus GST). In addition, on the Entitlement Offer Settlement Date, the Company will issue to the Underwriter (or its nominees) options in the Company on the basis of 1 option for every 5 New Shares offered under the Entitlement Offer (being up to 12,340,000 unquoted options), each with an exercise price of \$0.10 and a term of 3 years from the issue date, subject to any necessary approvals. The Underwriter will pay to the Director Sub-Underwriters a sub-underwriting fee of 4.0% (inclusive of any applicable GST) of

the amount sub-underwritten by the Director Sub-Underwriters, as payment for their respective sub-underwriting commitments. No sub-underwriting fees will be paid by the Company.

The Underwriter may also, in certain circumstances, terminate its obligations under the Underwriting Agreement on the occurrence of certain termination events (in some circumstances, having regard to the materiality or reasonableness of the relevant event). The termination events under the Underwriting Agreement have been summarised below:

- (e) **Entitlement Offer Certificate or misleading statement:** an Entitlement Offer Certificate required to be given by SQX is not furnished when required, or any statement in it is untrue, inaccurate, incomplete, misleading or deceptive in a material respect.
- (f) **Unable to issue Offer Shares:** SQX is prevented from allotting and issuing the Offer Shares within the time required by the ASX Listing Rules, applicable laws, or an order of a court or government agency.
- (g) **ASX announcement or Cleansing Notice:** SQX fails to lodge the required ASX announcement or the Entitlement Offer Cleansing Notice by 9.30am on the Announcement Date.
- (h) **Offer Documents fail to comply:** the Offer Documents or any aspect of the Entitlement Offer does not comply in a material respect with the Corporations Act, the ASX Listing Rules or any other applicable law, including because a statement in the Offer Documents is or becomes misleading or deceptive, omits required information, or a forecast or opinion is not based on reasonable assumptions.
- (i) **Withdrawal of Offer:** SQX withdraws the Entitlement Offer.
- (j) **Corrective notice:** SQX becomes required to give, or gives, a correcting notice under section 708AA(10) of the Corporations Act, other than as a result of a new circumstance arising.
- (k) **ASIC action:** ASIC makes an application for an order, or commences an investigation or hearing, in relation to the Entitlement Offer or the Offer Documents which becomes public or is not withdrawn within the timeframes specified in the Underwriting Agreement.
- (l) **Regulatory action:** an application is made to a government agency (including the Takeovers Panel) for an order, declaration or other remedy, or a government agency commences or announces an investigation or hearing, in connection with the Entitlement Offer.
- (m) **Listing and quotation:** approval for quotation of the Shares by ASX is refused, not granted, granted subject to non-customary conditions, or is subsequently withdrawn or qualified.
- (n) **Offences or disqualification of Directors:** a Director is charged with an indictable offence, becomes the subject of public regulatory action, or is disqualified from managing a corporation.
- (o) **Insolvency:** the Company or a related entity becomes Insolvent, or an act or omission occurs which may result in the Company or a related entity becoming Insolvent.
- (p) **Takeovers Panel application:** a Shareholder applies to the Takeovers Panel in connection with the Entitlement Offer, the Takeovers Panel elects to hear the application, and the application is not withdrawn or rejected.
- (q) **ASX approval for Offer Shares:** unconditional (or acceptably conditional) approval for official quotation of the Offer Shares is refused, not granted by the Entitlement Offer Settlement Date, or withdrawn.

- (r) **Timetable delay:** any event in the Timetable is delayed by more than 2 Business Days without the Underwriter's prior written consent.
- (s) **New circumstance or notifications:** a new circumstance arises that would have required disclosure in the Offer Documents had it arisen earlier, or ASIC issues an order or holds a hearing under sections 739 in relation to the Offer.
- (t) **Misleading disclosures or breach** (subject to a reasonableness qualification in favour of the Underwriter): the Public Information or any information provided by SQX is or becomes misleading or deceptive, SQX contravenes the Corporations Act, its constitution or the ASX Listing Rules, SQX breaches any obligation or representation under the Underwriting Agreement, or a representation or warranty proves untrue or incorrect.
- (u) **Hostilities, change of law or market disruption** (subject to a reasonableness qualification): the outbreak or material escalation of hostilities, the introduction or announcement of adverse legislation or policy, or a suspension, material limitation or adverse disruption to financial markets, occurs and has a material effect.
- (v) **Change in management or adverse change** (subject to a reasonableness qualification): a change in SQX's senior management or Board is announced or occurs, or there is an adverse change, or an event likely to give rise to an adverse change, in SQX's financial position, results, operations or prospects.
- (w) **Constitution, capital or charges** (subject to a reasonableness qualification): SQX varies its constitution, alters its issued capital, disposes of a substantial part of its business or property, or charges the whole or a substantial part of its business or property, in each case without the Underwriter's prior written consent (subject to certain exceptions).
- (x) For the termination events described as subject to a reasonableness qualification, the Underwriter may only exercise its right to terminate if, in its reasonable opinion, the event has, or is likely to have, a material adverse effect on the success, marketing or settlement of the Entitlement Offer, the value of the Shares, or investor demand, or is likely to lead to a contravention of, or liability under, the Corporations Act or other applicable law.

5.2 Effect on Control and Dilution

The potential effect that the Entitlement Offer will have on the control of the Company and the consequences of that effect will depend on a number of factors, including investor demand, participation by existing Shareholders, the extent to which Shortfall Shares are applied for under the Shortfall Facility (in accordance with the shortfall allocation policy detailed in Section 3.3 and Section 3.4), and the extent to which any remaining Shortfall Shares are ultimately taken up by the Underwriter, the Broker Sub-Underwriters, and the Director Sub-Underwriters pursuant to their respective underwriting and sub-underwriting agreements.

In aggregate, the Entitlements of the substantial Shareholders above represent approximately 29.76% of the maximum approximate Entitlement Offer raising of \$2,468,000.

(b) Underwriting

As at the date of this Offer Booklet, the Company understands that the Underwriter has no relevant interest in securities of the Company.

If no Shareholders subscribe for their Entitlements, the maximum number of Shares for which the Underwriter would be obliged to subscribe for under the Underwriting Agreement is 61,700,000, representing 40% of Shares on issue at close of the Offer.

However, the Company understands that the Underwriter has entered into binding sub-underwriting agreements to allocate 100% of its underwriting obligation, comprising the Director Sub-Underwriters (for an aggregate of \$130,000, representing 3,250,000 Shortfall Shares) and the balance of 58,450,000 Underwritten Shares to various clients of the Underwriter (the Broker Sub-Underwriters).

As a result, the Underwriter will not acquire any relevant interests as a result of the Offer and no Sub-Underwriter will, as a result of the Offer, increase its relevant interest in the Company's Shares from less than 20% to more than 20% and no single Shareholder will, after completion of the Entitlement Offer, hold more than 19.99% Voting Power in the Company.

Accordingly, no nominee has been appointed pursuant to section 615 of the Corporations Act to dispose of Entitlements that would have accrued to Ineligible Shareholders and the limitation set out in Section 5.3 below applies to the Underwriter, Broker Sub-Underwriters and Director Sub-Underwriters.

The final voting power acquired by any individual Sub-Underwriter will reduce proportionately to the extent that Eligible Shareholders take up their Entitlements or apply for extra shares under the Shortfall Facility.

(c) Other Shareholders

The potential effect which the issue of New Shares pursuant to the Entitlement Offer (including the Shortfall Shares) will have on the control of the Company is as follows:

- (i) if all Eligible Shareholders take up their full entitlements under the Entitlement Offer, the New Shares issued under the Entitlement Offer will have no dilutive effect on the control or percentage interests of those participating Shareholders; and
- (ii) in the more likely event that there is a shortfall in the Entitlement Offer, Eligible Shareholders who do not subscribe for their full Entitlement of New Shares under the Entitlement Offer will be diluted relative to those Eligible Shareholders who subscribe for some or all of their Entitlement and will be diluted by any take up of Shortfall Shares.

Control of the Company will ultimately be affected by the level of participation under the Entitlement Offer. The final percentage interests held by Shareholders of the Company are dependent on, among other things, the extent to which Eligible Shareholders take up their Entitlements.

The following examples illustrate how your percentage interest will be diluted if you do not participate in the Entitlement Offer, assuming the maximum number of New Shares are issued and assuming no Options are exercised before the Record Date:

5.3 Entitlement Cap

No Shortfall Shares will be issued to an Eligible Shareholder if, in the view of the Directors, to do so would increase that Eligible Shareholder's voting power in the Company from less than 20% to above 20%. Additionally, the Directors reserve the right to refuse to approve a particular issue of Shortfall Shares if (without limitation) such issue would, in the view of the Directors, result in a breach of the ASX Listing Rules, the Corporations Act, *Foreign Acquisitions and Takeovers Act 1975* (Cth) or any other applicable law.

For completeness, it is noted that as stated in Section 5.2(b), neither the Underwriter nor Sub-Underwriters will increase voting power in the Company from less than 20% to above 20% as a result of the underwriting of the Entitlement Offer.

6. Important information for Shareholders

6.1 No prospectus or product disclosure statement and not investment advice

The Entitlement Offer complies with the requirements of section 708AA of the Corporations Act as modified by ASIC Corporations (Non-Traditional Rights Issues) Instrument 2016/84. Accordingly, neither this Offer Booklet nor the Entitlement and Acceptance Form are required to be lodged or registered with ASIC.

It is also not investment advice and does not take into account your investment objectives, financial situation, tax position and particular needs. Before deciding whether to apply for New Shares, you should consider whether they are a suitable investment for you in light of your personal circumstances (including financial and taxation issues) and seek professional guidance before deciding whether to invest.

6.2 Rights issue exception not available

No nominee has been appointed for Ineligible Shareholders under section 615 of the Corporations Act and, as such, Eligible Shareholders will not be able to rely on the exception for entitlement issues set out in item 10 of Section 611 of the Corporations Act. Accordingly, when an Eligible Shareholder applies for some or all of their Entitlement, they must have regard to section 606 of the Corporations Act. Eligible Shareholders who may be at risk of exceeding the 20% voting power threshold in Section 606 as a result of acceptance of the Entitlement Offer should seek professional advice before completing and returning the Entitlement Offer and Acceptance Form. The Company will not allocate any securities where it has reasonable grounds to believe that such allocation would breach section 606 of the Corporations Act.

6.3 Notice to nominees and custodians

The Company is not required to determine whether or not any registered holder is acting as a nominee or the identity or residence of any beneficial owners of securities. Where any nominee or custodian is acting on behalf of a foreign person, that holder, in dealing with its beneficiary, may only participate on behalf of beneficiaries who are resident in Australia and New Zealand. Any person in the United States with a holding through a nominee may not participate in the Entitlement Offer. Nominees and custodians may not distribute any part of this Offer Booklet in the United States or in any other country outside of Australia and New Zealand.

6.4 Continuous disclosure

The Company is a 'disclosing entity' under the Corporations Act and is subject to regular reporting and disclosure obligations under the Corporations Act and the ASX Listing Rules, including the preparation of annual reports and half-yearly reports.

The Company is required to notify the ASX of information about specific events and matters as they arise for the purposes of the ASX making that information available to the stock markets conducted by the ASX. In particular, the Company has an obligation under the ASX Listing Rules (subject to certain exceptions) to notify the ASX immediately of any information which it is or becomes aware which a reasonable person would expect to have a material effect on the price value of its Shares. That information is available to the public from the ASX.

6.5 Information excluded from continuous disclosure notices

There is no information which has been excluded from a continuous disclosure notice in accordance with the Listing Rules other than as is set out in this Offer Booklet.

6.6 Taxation consequences

The taxation consequences of any investment in New Shares will depend upon your particular circumstances. Potential investors must make their own enquiries concerning the taxation consequences of an investment in the Company. The risks set out in this section are not exhaustive. Other risks may materially affect the future performance of the Group and the price of the Shares. Additional risks and uncertainties not presently known to management or that management currently believe not to be material may also affect the Company’s business. Accordingly, no assurances or guarantees of future performance, profitability, distributions, or returns of capital are given by SQX or any other person.

Risks relating to SQX may impact SQX, its business, financial position and performance as well as the businesses, financial position and performance of its subsidiaries which, in turn impacts SQX. Accordingly, a reference to a risk impacting SQX, should be taken to be a reference to a risk which may also impact its subsidiaries.

7.1 Underwriting risk

The Entitlement Offer is fully underwritten by Alpine Capital Pty Ltd. The Underwriting Agreement is subject to certain conditions and termination events, which are summarised in Section 5.1. If a termination event occurs and the Underwriter terminates its obligations under the Underwriting Agreement, and the Entitlement Offer is not otherwise fully subscribed, the Company may raise less than the amount sought under the Entitlement Offer, which may adversely affect the Company’s ability to fund the activities described in this Offer Booklet and may require the Company to seek alternative funding.

7.2 Share Market Risk

The market price of listed securities can be expected to rise and fall in accordance with general market conditions and factors specifically affecting the Australian resources sector and exploration companies in particular. There are a number of factors (both national and international) that may affect the share market price and neither the Company nor its Directors have control of those factors.

7.3 General Economic Conditions

Changes in the general economic climate in which the Company operates may adversely affect the financial performance of the Company. Factors that may contribute to that economic climate include the general level of economic activity, interest rates, inflation, supply and demand, industrial disruption and other economic factors. The price of commodities will also be of particular relevance to the Company. These factors are beyond the control of the Company and the Company cannot, with any degree of certainty, predict how they will impact on the Company.

7.4 **Share Price Fluctuations**

The market price of the Company's securities will be subject to varied and often unpredictable influences in the share market. Both domestic and world economic conditions may affect the performance of the Company. Factors such as the level of industrial production, inflation and interest rates impact all commodity prices.

7.5 **Legislative Change**

Changes in government regulations and policies may adversely affect the financial performance or the current and proposed operations generally of the Company.

7.6 **Unforeseen Expenses**

While the Company is not aware of any expenses that may need to be incurred that have not been taken into account, if such expenses were subsequently incurred, the expenditure proposals of the Company may be adversely affected.

7.7 **Not taking up Entitlement Offer**

Entitlements cannot be traded on ASX or privately transferred. If eligible retail shareholders do not take up all or part of their available entitlements, individuals' percentage shareholding in SQX will be diluted. In addition, investors may have their investment diluted by future capital raisings by SQX.

7.8 **Current and future sources of funding**

- (a) The Company's ability to effectively implement its business strategy over time may depend in part on its ability to raise additional funds. There can be no assurance that any such equity or debt funding will be available to the Company on favourable terms or at all. If adequate funds are not available on acceptable terms, the Company may not be able to take advantage of opportunities or otherwise respond to competitive pressures.
- (b) Although the Directors believe that on completion of the Entitlement Offer the Company will have sufficient working capital to carry out its short-term business objectives, there can be no assurance that such objectives can be met without further financing or, if additional financing is necessary, that financing can be obtained on favourable terms or at all. Further, if additional funds are raised by issuing equity securities, this may result in dilution for some or all of the Shareholders.
- (c) The Company's ability to raise further funding to meet both its development and capital expenditure requirements, depends upon a number of different factors. The Company's ability to raise further equity financing is very sensitive to negative market sentiment. Accordingly, there is no guarantee that the Company will be able to secure additional funding on terms favourable to the Company. If the Company is unable to obtain additional financing as required, it will be unable to continue to fund its existing projects, or take advantage of opportunities as they arise. Further, without additional funding the Company may not have sufficient working capital to be able to meet day to day expenses as and when needed.

7.9 **Environmental Regulations and Risks**

National and local environmental laws and regulations affect nearly all of the operations of the Company. These laws and regulations set various standards regulating certain aspects of health and environmental quality, provide for penalties and other liabilities for the violation of such standards and establish, in certain circumstances, obligations to remediate current and former facilities and locations where operations are or were conducted. The Company will

minimise the potential impact of these laws and regulations by taking steps to ensure compliance occurs and, where possible, by carrying appropriate insurance. Significant liability could be imposed on the Company for damages, clean-up costs or penalties in the event of certain discharges into the environment, environmental damage caused by previous owners of properties acquired by the Company or non-compliance with environmental laws or regulations.

7.10 **Foreign Jurisdiction Risk – United States Government Regulation**

The Company's operating activities in the United States will be subject to laws and regulations governing exploration of property, health and worker safety, employment standards, waste disposal, protection of the environment, land and water use, prospecting, taxes, labour standards, occupational health standards, toxic wastes, the protection of endangered and protected species and other matters.

While the Company understands that it is in substantial compliance with all material current laws and regulations affecting its activities, future changes in applicable laws, regulations, agreements or changes in their enforcement or regulatory interpretation could result in changes in legal requirements or in the terms of existing permits and agreements applicable to the Company or its properties, which could have a material adverse impact on the Company's current operations or planned development project.

Where required, obtaining necessary permits and licences can be a complex, time consuming process and the Company cannot be sure whether any necessary permits will be obtainable on acceptable terms, in a timely manner or at all. The costs and delays associated with obtaining necessary permits and complying with these permits and applicable laws and regulations could stop or materially delay or restrict the Company from proceeding with any future exploration or development of its properties. Any failure to comply with applicable laws and regulations or permits, even if inadvertent, could result in interruption or closure of exploration, development or other activities and could result in material fines, penalties or other liabilities.

Adverse changes in US government policies or legislation may affect ownership of mineral interests, taxation, royalties, land access, labour relations, and mining and exploration activities of the Company. It is possible that the current system of exploration and mine permitting in the US may change, resulting in impairment of rights and possibly expropriation of the Company's properties without adequate compensation.

7.11 **Insurance Arrangements**

The Company intends to maintain insurance within ranges of coverage the Company believes to be consistent with industry practice and having regard to the nature of activities being conducted. No assurance however, can be given that the Company will be able to obtain such insurance coverage at reasonable rates or that any coverage it arranges will be adequate and available to cover any such claims.

7.12 **Exploration and Evaluation Risks**

Investors should understand that mineral exploration and development can potentially be high risk undertakings. Even if an apparently viable deposit is identified, there is no guarantee that it can be economically exploited. The circumstances in which a mineral deposit becomes or remains commercially viable depend on a number of factors. These include the particular attributes of the deposit, such as size, grade and proximity to infrastructure, as well as SQX successfully obtaining all necessary consents and approvals and the successful design, construction and operation of extracting, processing and transportation facilities. A combination of these factors may result in projects not being developed, or operations becoming unprofitable. Delays or difficulties in obtaining relevant approvals, or obtaining

conditional or limited approvals, may interfere with the Company's operations which could materially impact the business, financial position and performance of the Company.

7.13 Technical Studies Risk

Subject to the results of exploration and testing programs to be undertaken, the Company may progressively undertake a number of studies relating to its projects, . Any studies will be completed within parameters designed to determine the economic feasibility of a project within certain limits. There can be no guarantee that any of the studies will confirm the economic viability of the Company's projects. Even if a study confirms the economic viability of a project, there can be no guarantee the Company will be able to raise the development funding, or that the project will be successfully brought into production as assumed or within the estimated parameters once production commences.

7.14 Mine Development Risk

- (a) Future development of SQX's current or future projects is dependent on a number of factors including, but not limited to, the acquisition and/or delineation of economically recoverable mineralisation, favourable geological conditions, receiving the necessary approvals from all relevant authorities and parties, seasonal weather patterns, unanticipated technical and operational difficulties encountered in extraction and production activities, mechanical failure of operating plant and equipment, shortages or increases in the price of consumables, spare parts and plant and equipment, cost overruns, access to the required level of funding and contracting risk from third parties providing essential services.
- (b) If the Company discovers an economically viable mineral deposit that it intends to develop, it will, among other things, require various approvals, licences and tenements before it will be able to mine the deposit. There is no guarantee that the Company will be able to obtain all required approvals, licences and tenements. To the extent that required authorisations are not obtained or are delayed, the Company's operational and financial performance may be materially adversely affected.
- (c) If SQX commences production, its operations may be disrupted by a variety of risks and hazards which are beyond its control, including environmental hazards, industrial accidents, technical failures, labour disputes, unusual or unexpected rock formations, flooding and extended interruptions due to inclement or hazardous weather conditions and fires, explosions, pandemics or accidents.
- (d) The risks outlined above mean that there can be no assurances as to the future development of a mining operation on the Company's projects or that SQX will achieve commercial viability through the development or mining of any its projects.

7.15 Commodity Prices

The Company's prospects will be influenced from time to time by the prevailing short-term prices of the commodities targeted in its exploration programs. Commodity prices fluctuate and are affected by factors including supply and demand, hedge activities associated with commodity markets, the costs of production and general global economic and financial market conditions. These factors may cause volatility which in turn, may affect the viability of the Company's projects. The events relating to the Russia/Ukraine war and the USA-Iran war have had an impact on global demand for the Company's target commodities. It is difficult if not impossible to accurately predict the direction of those markets in the short or medium terms.

7.16 Tenement Risks

The rights to resource tenements carry with them various obligations which the holder is required to comply with in order to ensure the continued good standing of the tenement and, specifically, obligations in regard to minimum expenditure levels and responsibilities in respect of the environment and safety. Failure to observe these requirements could prejudice the right to maintain title to a given area and result in government action to forfeit a permit or permits.

There is no guarantee that current or future exploration permit applications or existing permit renewals will be granted, that they will be granted without undue delay, or that the holder of the mineral tenements can economically comply with any conditions imposed on any granted exploration permits.

7.17 Land Access Risk

Land access is critical for exploration and evaluation to succeed. In all cases the acquisition of prospective tenements is a competitive business, in which propriety knowledge or information is critical and the ability to negotiate satisfactory commercial arrangements with other parties is often essential. Access to land for exploration purposes can be affected by land ownership, including private (freehold) land, pastoral lease and regulatory requirements within the jurisdictions where the Company, its subsidiaries or companies it holds interests in operate.

7.18 Native Title and Heritage Risk

The *Native Title Act 1993* (Cth) recognises certain rights of indigenous Australians over land where those rights have not been extinguished. These rights, where they exist, may impact on the ability of the Company to carry out exploration and in future, mining activities, or obtain exploration or mining licences in Australia. In applying for licences over crown land, the Company must observe the provisions of Native Title legislation. There are also laws of the States and Territories which impose duties of care which require persons, including the Company, to take all reasonable and practical measures to avoid damaging or destroying Aboriginal cultural heritage. In carrying out exploration and/or mining operations, the Company must observe Native Title legislation (where applicable), Aboriginal heritage legislation and heritage legislation which protects sites and objects of significance, and these may delay or impact adversely on the Company's operations in Australia.

7.19 First Nations

In relation to tenements which the Company has an interest in or will in the future acquire such an interest in the United States and any other foreign jurisdictions, there may be areas of first nations land. Where such rights exist, the ability of the Company to gain access to tenements (through obtaining consent of any relevant right holder), or to progress from the exploration phase to the development and mining phases of operations, may be delayed or adversely affected. The Directors will closely monitor the potential effect of first nation claims where relevant, and will seek such consents as are required to comply with obligations to first nation claimants or right holders.

7.20 Title Risk

The exploration and prospecting permits and claims in which either the Company, its subsidiaries or companies it holds interests in has now, or may, in the future, acquire an interest, are subject to applicable local laws and regulations. There is no guarantee than any such claims, applications or conversions in which the Company, its subsidiaries or companies it holds interests in has a current or potential interest will be granted. All of the projects in which the Company, its subsidiaries or companies it holds interests in has an interest will be subject to application for claim renewal from time to time. Renewal of the term of each claim

is subject to applicable legislation. If the claim is not renewed for any reason, the Company may suffer significant damage through loss of the opportunity to develop and discover any mineral resources on that claim.

7.21 **Contractual and Joint Venture Risks**

The Company's ability to efficiently conduct its operations in a number of respects depends upon a third party product and service providers and contracts have, in some circumstances, been entered into by the Company and its subsidiaries in this regard. As in any contractual relationship the ability for the Company to ultimately receive benefits from these contracts are dependent upon the relevant third party complying with its contractual obligations. To the extent that such third parties default in their obligations, it may be necessary for the Company to enforce its rights under any of the contracts and pursue legal action. Such legal action may be costly, and no guarantee can be given by the Company that a legal remedy will ultimately be granted on appropriate terms. The Company may wish to develop its projects or future projects through joint venture arrangements. Any joint ventures entered into by, or interests in joint ventures assigned to the Company, could be affected by the failure or default of any of the joint venture participants. Additionally, failure by contractors to perform in accordance with required timelines, may expose any project in which the Company its subsidiaries or companies it has an interest, to risk of forfeiture under applicable laws.

7.22 **Operational Risks and Costs**

Prosperity for the Company will depend largely upon an efficient and successful implementation of all the aspects of exploration, developments, business activities and management of commercial factors. Exploration has been and will continue to be hampered on occasions by unforeseen weather events, accidents, unforeseen cost changes, environmental considerations, natural events and other incidents beyond the control of the Company. By its nature, the business of exploration is a highly speculative endeavour and involves significant risks. The Company's performance depends on the successful exploration and/or acquisition of resources or reserves, competent operational management and efficient financial management. Further, the nature of exploration can sometimes result in industrial accidents and other incidents beyond the control of the Company. There can be no assurances that the Company's exploration programs, will result in the discovery of a satisfactory resource. Even if a resource is identified, there is no guarantee that it will be viable for economic exploitation. Ultimate success depends on the discovery and delineation of economically recoverable mineral resources, establishment of efficient exploration operations, obtaining necessary titles and access to projects, as well as government and other regulatory approvals. The exploration and mining activities of the Company may be affected by a number of factors, including but not limited to geological conditions, seasonal weather patterns, technical difficulties and failures, continued availability of the necessary technical equipment, plant and appropriately skilled and experienced technicians, adverse changes in government policy or legislation and access to the required level of funding.

If the Company decides to develop and commission a mine, the operations of the Company including mining and processing may be affected by a range of factors. These include failure to achieve the predicted grades and quality in exploration, mining and processing, technical difficulties encountered in commissioning and operating plant and equipment, mechanical failure, metallurgical problems which affect extraction rates and costs, adverse weather conditions, industrial and environmental accidents, industrial disputes, unexpected shortages or increase in the costs of consumables, spare parts, plant and equipment.

7.23 **Climate Change Risk**

The operations and activities of SQX are subject to changes to local or international compliance regulations related to climate change mitigation efforts, specific taxation or

penalties for carbon emissions or environmental damage and other possible restraints on industry that may further impact the Company. While the Company will endeavour to manage these risks and limit any consequential impacts, there can be no guarantee that the Company will not be impacted by these occurrences. Climate change may also cause certain physical and environmental risks that cannot be predicted by the Company, including events such as increased severity of weather patterns, incidence of extreme weather events and longer-term physical risks such as shifting climate patterns. All these risks associated with climate change may significantly change the industry in which the Company operates.

7.24 **Management Actions**

The Directors of the Company will, to the best of their knowledge, experience and ability (in conjunction with their management) endeavour to anticipate, identify and manage the risks inherent in the activities of the Company, but without assuming any personal liability for same, with the aim of eliminating, avoiding and mitigating the impact of risks on the performance of the Company and its Securities. However, there is no assurance that the Directors will be able to successfully avoid circumstances giving rise to an adverse effect on the assets, operations and ultimately the financial performance of the Company and the market price of its securities.

7.25 **International Conflicts Risk**

The ongoing military conflict between Russia and Ukraine, conflict in Israel and Gaza, and conflict between the United States and Iran, are having a material effect on the global economy. These hostilities have created uncertainty for capital markets around the world, and this uncertainty may lead to adverse consequences for the Company's business operations. Measures taken by governments around the world to end these conflicts (such as imposing tariffs on Russian exports and other economic sanctions) may cause disruptions to the Company's supply chains and adversely impact commodity prices.

7.26 **Government Policy**

Changes in relevant taxation, interest rates, other legal, legislative and administrative regimes, and Government policies in Australia or any other jurisdiction in which the Company, its subsidiaries or companies it holds interests in undertakes or may undertake operations, may have an adverse effect on the assets, operations and ultimately the financial performance of the Company. These factors may ultimately affect the financial performance of the Company and the market price of its securities. In addition to the normal level of income tax imposed on all industries, the Company its subsidiaries or companies it holds interests in may be required to pay government royalties, indirect taxes, GST and other imposts which generally relate to revenue or cash flows. Industry profitability can be affected by changes in government taxation policies. Changing attitudes to environmental, land care, cultural heritage and indigenous land rights' issues, together with the nature of the political process, provide the possibility for future policy changes. There is a risk that such changes may affect the Company's, its subsidiaries or companies it holds interests in exploration plans or, indeed, its rights and/or obligations with respect to the tenements.

7.27 **Reliance on Key Personnel**

The Company's progress in pursuing its exploration and evaluation programmes within the time frames and within the costs structure as currently envisaged could be dramatically influenced by the loss of existing key personnel or a failure to secure and retain additional key personnel as the Company's exploration programme develops. The resulting impact from such loss would be dependent upon the quality and timing of the employee's replacement. Although the key personnel of the Company have a considerable amount of experience and have previously been successful in their pursuits of acquiring, exploring, evaluating and operating resource projects, there is no guarantee or assurance that they will be successful in

their objectives. Shareholders should consider that the investment in the Company is speculative and should consult their professional advisers before deciding whether to apply for the New Shares.
