PC Gold Limited ACN 609 609 047 (ASX:PC2) – REQUEST FOR A TRADING HALT

PC Gold Limited (**Company or PC Gold**) requests that the Company's securities be placed in a trading halt effective immediately in accordance with ASX Listing Rule 17.1, pending the release of an announcement by the Company in relation to a capital raising.

PC Gold provides the following information in relation to its request:

1. The trading halt is requested to assist the Company in managing its continuous disclosure obligations pending the announcement in relation to a capital raising;
2. PC Gold requests that the trading halt end on the earlier of the commencement of normal trading on Thursday 27 August 2026, or when the anticipated announcement referred to in paragraph 1 above is released to the market; and
3. PC Gold is not aware of any reason why the trading halt should not be granted, nor of any other information necessary to inform the market about the trading halt.
