Dear Shareholders,

FY26 has been a year of real and measurable progress for Carbonxt. Our established operations delivered positive operating cash flow across the full year on gross margins of approximately 50%; we secured significant new commercial contracts that underpin FY27 revenue growth, and, subsequent to the end of the reporting period, we agreed to a two-stage restructuring of the Company's balance sheet with our two largest financial stakeholders. As at the date of this letter, the Kentucky facility is in the final stages of kiln finalisation and commissioning has recommenced.

Kentucky has taken longer to bring online than we anticipated at the start of the year, caused by an equipment issue that is being resolved with the full support of the kiln manufacturer.

The Company enters FY27 in a materially stronger position than a year ago: existing operations substantially improved, with an agreed pathway to lower senior debt subject to the conditions set out below, and with our flagship growth asset close to first production.

Kentucky – Approaching Commercial Production

Our Kentucky activated carbon facility, developed alongside our partners at Kentucky Carbon Processing, LLC through our jointly owned company New Carbon Processing, LLC, progressed substantially during FY26. Construction of the kiln was completed, refractory lining installed and heat treatment undertaken. The back-end infrastructure, bagging station, conveyors, additional storage silos, and the onsite power station were installed and brought online. All outside works are now complete.

We had targeted first revenues from the facility in early calendar 2026 and have not met that timetable. As the plant moved into early commissioning, remediation requirements were identified in the kiln, and further inspection established that the affected equipment needed to be replaced rather than repaired. The kiln manufacturer agreed to replace the equipment at their cost and facilitate the repairs and has remained constructive and supportive throughout.

Replacement parts began arriving during the June quarter. Subsequent to the end of the reporting period, kiln finalisation has continued and is nearing finalisation. Identifying and correcting these issues before sustained production begins is the right outcome for the plant's long-term reliability.

We continued to build our position in the project throughout the year, lifting our interest in New Carbon Processing from 43.7% at 30 June 2025 to 48.1% at 30 June 2026. Two further incremental investments of US\$250,000 each, made subsequent to year-end, have since taken our interest to 49.4%, bringing us closer to our stated 50% objective.

Once operational, and on the basis of current internal estimates, the facility is expected to increase group sales by approximately 200% over two years and take Carbonxt into the liquid-phase activated carbon market, a segment several times larger than our current air-phase focus, with a corresponding uplift in both revenue and margin.

Operational Performance and Commercial Momentum

The underlying business showed further improvements over FY25. Full-year customer receipts were A\$16.99 million and net operating cash flow was positive at A\$492,000. Gross margins were strong at 52.4% in the June quarter, with the full year at approximately 47%.

Activated Carbon Pellet (ACP) volumes recovered strongly in the second half following a planned maintenance outage at our Black Birch plant, with June quarter sales 37% higher than the March quarter. Powdered Activated Carbon (PAC) sales rose 10% over the same period as volumes from our largest PAC customer returned to prior levels. Capacity utilisation was around 57.3% of maximum capacity at Arden Hills and 73% at Black Birch.

Three commercial developments during the year position us well for FY27:

- A three-year extension of one of our principal ACP customer contracts on higher pricing and improved payment terms, with expected annual revenue from that contract increasing by over 30%. That customer has indicated an intention to increase volumes, which if realised would be worth approximately A\$2.0 million of additional revenue in FY27.
- A first purchase order from a new customer for a new ACP product entering a new market segment. The product performed well and was well received, and, as at the date of this letter, discussions to finalise a long-term supply agreement are advancing.
- Agreement to relocate our Minnesota pellet operations to a new site, reducing monthly operating costs by over US\$10,000 and enabling future expansion at a much lower cost. The move is expected to complete in the September 2026 quarter, after the end of the reporting period.

PAC volumes continue to be underpinned by long-term contracts with ReWorld and Wisconsin Public Service, providing a stable base of contracted revenue.

Balance Sheet Restructuring Agreed After the End of the Reporting Period

Shortly after year-end, on 3 July 2026, we agreed to a two-stage balance sheet restructuring with our two largest financial stakeholders - Phelbe Pty Ltd, our major shareholder and noteholder, and Pure Asset Management, our senior lender - designed to substantially strengthen the Company's balance sheet as Kentucky enters commercial production. The agreement was reached after the end of the reporting period and is not reflected in the FY26 financial statements. Refer to Note 36 Events after the reporting period.

Stage 1 completed on 3 July 2026, comprising A\$3.5 million of new convertible notes: A\$2.0 million of new cash from Phelbe and A\$1.5 million from Pure set off against senior debt and accrued interest. Pure has also agreed to provide any required covenant waivers to 31 December 2026 i.e. the next covenant test date is 31 December 2026.

Stage 2 is conditional on (a) shareholder approval at an Extraordinary General Meeting expected in September 2026 (b) the Company's share price closing at or above \$0.09 for five consecutive trading days before 31 December 2026 (c) on the commencement of Kentucky operations (defined as receipt of an independent engineer certification attesting to the plant being operational, together with the achievement of US\$1 million in initial revenue from the facility) and (d) no material adverse effect. On satisfaction of those conditions, Phelbe will convert existing notes and exercise options, and Pure will exercise its warrants and options. Pure's proceeds of approximately A\$5.0 million will be applied directly to reduce the senior facility from A\$15.0 million to approximately A\$10.0 million, with all financial covenants removed for the remaining life of that loan, which matures on 31 May 2027.

In aggregate, the plan, if both stages complete, would deliver a cash injection of up to A\$11 million and a net reduction in debt of approximately A\$5 million, while simplifying the Company's capital structure. Every conversion and exercise price sits above the A\$0.068 share price on 6 July 2026, being the date of the agreement. That both parties are committing capital at prices above the market is a clear and welcome expression of confidence in Carbonxt's strategy and in the value of the Kentucky investment.

Strategic Positioning – Ongoing Regulatory and Market Tailwinds

The regulatory case for our products was maintained during FY26. In May 2026, the US EPA proposed a rule that upholds the Maximum Contaminant Levels for PFOA and PFOS at 4 parts per trillion, together with an application-based two-year extension of the compliance deadline to April 2031 that gives utilities more time to plan, fund and deploy treatment infrastructure. In the same package the EPA proposed to rescind the drinking water regulations for PFHxS, PFNA, GenX and the related Hazard Index mixture. Neither rule is final. The PFOA and PFOS standards that drive our addressable market are unchanged. The EPA released nearly US\$1 billion in new grant funding to states to address PFAS in drinking water, bringing that programme to US\$5 billion over five years, alongside US\$4 billion through the Drinking Water State Revolving Funds and more than US\$6.5 billion in low-interest financing.

In June, the EPA signed the proposed Sixth Unregulated Contaminant Monitoring Rule, which was published in the Federal Register on 1 July 2026, widening the occurrence-monitoring net that drives future regulation. On 24 June

2026, the Department of Justice, the EPA and the West Virginia Department of Environmental Protection announced a proposed US\$450 million settlement with Chemours, the first comprehensive federal enforcement settlement with a PFAS manufacturer. That settlement is a proposed consent decree and remains subject to court approval.

The standards that drive procurement in our addressable market remain in place, the proposed compliance timetable now extends to 2031, and the capital to meet those standards is flowing. Activated carbon, and powdered and granular activated carbon in particular, remains the most widely adopted treatment technology for PFOA and PFOS removal at scale. Combined with a projected 5–9% compound annual growth rate in activated carbon demand through 2030, these trends support a long and visible growth runway for Carbonxt.

Outlook for FY 27

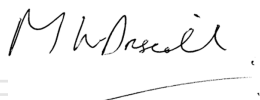
An operational base that generated positive operating cashflow during FY26, a restructured balance sheet and Kentucky approaching first production, FY27 is set to be a defining year. Our priorities are:

- Completing Kentucky commissioning, achieving the initial revenue milestone and entering the liquid-phase market.
- Completing Stage 2 of the restructuring, reducing senior debt to approximately A\$10 million and removing all financial covenants.
- Converting the new ACP purchase order into a long-term supply agreement and delivering the volume growth indicated by our existing customers.
- Completing the Minnesota relocation and maintaining the operational discipline that delivered positive operating cash flow in FY26.

On behalf of the Board, I would like to thank our shareholders for their continued support and for their patience as Kentucky has worked through to completion, our lenders and noteholders at Pure Asset Management and Phelbe Pty Ltd for their substantial and constructive partnership through the restructuring, and most importantly our employees, whose expertise and dedication delivered the operational recovery and new business wins that defined the year.

FY26 has put the pieces in place for a step change in the scale of this business, and we look forward to updating you as we deliver on the opportunities ahead.

The directors present their report, together with the financial statements, on the consolidated entity (referred to hereafter as the 'Group') consisting of Carbonxt Group Limited (referred to hereafter as the 'Company' or 'parent entity') and the entities it controlled at the end of, or during, the year ended 30 June 2026.

Directors

Principal activities

During the financial year the principal continuing activities of the Group consisted of the development and sale of specialised Activated Carbon ('AC') products, including Powdered Activated Carbon ('PAC') and AC pellets for the removal of pollutants and toxins in industrial processes.

These products are used in industrial air purification, waste water treatment and other liquid and gas phase markets, primarily for the capture of mercury and sulphur in order to reduce harmful emissions into the atmosphere, as required by global regulations.

Dividends

There were no dividends paid, recommended or declared during the current or previous financial year.

Review of operations

The loss for the Group after providing for income tax amounted to \$4,629,000 (30 June 2025: \$6,761,000).

The decrease in loss for the Group compared to prior year is primarily due to the gain on remeasurement of royalty payables of \$2,262,000.

Revenue for the year was \$15,694,000 (before other income) and \$15,844,000 (after other income) representing a decrease of 3.1% and 3.8% respectively on the prior year's revenue of \$16,195,000 (before other income) and \$16,464,000 (after other income). In US dollars, revenue was US\$10,649,000 (before other income) and US\$10,750,000 (after other income) representing an increase of 1.4% and 0.7% respectively on the prior year's revenue of US\$10,498,000 (before other income) and US\$10,672,000 (after other income).

Revenues decreased 3.1% compared to prior year primarily due to the lower foreign exchange rate of Australian Dollar against US Dollar.

Liquidity

During the financial year ended 30 June 2026, the Group incurred a net loss after tax of \$4,629,000 (30 June 2025: \$6,761,000) and a cash inflow from operating activities of \$492,000 (30 June 2025: outflow of \$4,752,000). As at 30 June 2026, the Group had net assets of \$5,645,000 (30 June 2025: \$9,223,000), net current liability of \$22,004,000 (30 June 2025: \$15,120,000) and cash and cash equivalents of \$553,000 (30 June 2025: \$481,000).

As a result of the loss incurred for the year ended 30 June 2026 and the liquidity at the reporting date, there is a material uncertainty on whether the Group can continue as a going concern. The directors consider that the Group will continue as a going concern, as explained in note 2 to the financial statements.

Business risks

The following is a summary of material business risks that could adversely affect the Group's financial performance and growth potential in future years and how the Group proposes to mitigate such risks:

Climate Risk

The Group takes climate risk into account in its investment decisions. There is the possibility that such decisions have underestimated the severity of climate change. The bio-char input at Black Birch is a renewable source and has a lower footprint than most Activated Carbon manufacturing facilities, but it is feasible that climate change affects the availability of the input source.

Construction Risk

The NewCarbon investment is in construction phase. As with all construction activities there is the possibility of delays to completion or issues during the start-up phase. Given the plant has operated for a number of years as a waste-to-energy plant that start-up risk is reduced, compared to a greenfields construction site, but nevertheless there is a potential for construction issues.

Competition risk

The Group operates in a dynamic AC market. There is a possibility that existing or new competitors may increase competitive pressure through technological advancements, volume increases or pricing and other strategies. Any significant advancements in technology for producing AC have the potential to change the competitive environment in which the Group operates.

Ability to retain existing clients or attract new clients

The Group's business depends on its ability to retain contracts with existing customers and to attract further business from existing customers or attract new customers. The loss of existing customers or the inability to attract new customers would have an adverse impact on the financial position of the Group.

Regulatory risk

The Group is heavily reliant on US environmental policies and regulation. Any change to or reversal of current legislation would have a significant negative effect on the Group's business model and financial performance.

Intellectual property risk

The Group relies on its intellectual property (including technology, know how, trademarks, designs and patents) and there can be no assurance that competitors or other parties will not imitate or develop technology and know-how that challenges or competes with the Group or supersedes the Group's intellectual property. In addition, any unauthorised use or disclosure of the Group's intellectual property may also have an adverse effect on the Group's financial performance.

Reliance on key personnel

The Group employs, or engages as consultants, a number of key management and scientific personnel. The inability of the Group to retain and attract highly qualified and experienced personnel could have a material adverse impact on the Group's business and financial performance.

Safety and industrial accidents

The manufacture and supply of the Group's products are subject to safety related risks, which are managed carefully by the Group. Despite the relevant safety guards there is no guarantee a serious accident will not occur in the future, which may negatively affect the financial performance of the Group.

Brand establishment and maintenance

Establishing and maintaining its brand in the industry is critical to growing the Group's customer base and product acceptance. Prior to entering into supply agreements, the Group is required to undertake vigorous testing of its Activated Carbon solutions. Any unsuccessful tests for potential customers could adversely affect the Group's brand, and its business and operating results could be adversely affected. The Group must also maintain and support its existing customer relationships to maintain its brand and attract further customers.

Offshore operations

While the Group's corporate management is in Australia, its operations are based in the United States. The global nature of the pollution control business may result in the Group's activities extending to other countries in the future. Geographic diversity adds risk to the ability of the Group to manage its operations and employees, and introduces additional risks relating to the general economic, regulatory, legal, social and political environment in the jurisdictions in which it intends to operate, which may in turn adversely affect the Group's business and financial condition.

Exchange rate risk

The Group is exposed to movements in exchange rates as the vast majority of the Group's revenue and expenses are denominated in USD. Adverse movements in the AUD/USD exchange rate may have an adverse effect on the reported financial performance and/or financial position of the Group.

Product liability and uninsured risks

The Group is exposed to potential product liability risks, which are inherent in the research and development, manufacturing, marketing and use of its products or products that are developed in the future. Whilst the Group has liability insurance to help manage such risks, the Group may not be able to maintain insurance for product or service liability on reasonable terms in the future and/or the Group's insurance may not be sufficient to cover large claims, or the insurer could disclaim coverage on any such claims.

Concentration risk

The Group has significant dependence on a limited number of customers. The loss of a major customer could materially affect revenue, operations, profitability, and cash flow. Management continuously monitors concentration exposures and seeks to mitigate these risks through customer diversification, expansion into new markets, and ongoing assessment of key business relationships.

Significant changes in the state of affairs

Capital raising

On 17 October 2025, the Company announced the completion of the share placement of 8,000,000 fully paid shares at \$0.075 per share before issue costs.

On 6 January 2026, the Company issued 6,666,667 ordinary shares at \$0.09 per share raising \$600,000 before issue costs.

Loyalty Option

On 22 August 2025, the Company announced a non-renounceable pro-rata entitlement offer to Eligible Shareholders of one (1) Option to acquire a fully paid ordinary share in the Company ('Loyalty Option') for every six (6) shares held by shareholders registered at 7.00pm (AEST) on 27 August 2025 ('Record Date') at an issue price of \$0.01 and exercise price of \$0.07 per Loyalty Option ('Entitlement Offer'). The Offer was fully underwritten by Chaleyer Holdings Pty Ltd, an existing shareholder of the Company. A total of 58,776,787 options were issued, raising a total of \$587,769 before issue costs.

On 26 September 2025, the Company issued 8,000,000 Loyalty Option to the directors at an issue price of \$0.01 in lieu of compensation totalling to \$80,000.

Investment in NewCarbon

The contributions to NewCarbon for the year totalled to US\$1,500,000 (30 June 2025: US\$2,250,000) which increased the ownership in NewCarbon to 48.05% as at 30 June 2026 (30 June 2025: 43.66%).

Convertible notes

On 25 September 2025, the Company issued additional 400,000 convertible notes with a face value of \$1 exercisable at \$0.08 and expiring on 17 October 2027. The convertible notes will convert to a total of 5,000,000 ordinary shares. The convertible note has 1 attaching option with every 1 share issued to the noteholders upon conversion.

On 18 February 2026, the Company issued additional 500,000 convertible notes with a face value of \$1 exercisable at \$0.10 and expiring on 18 February 2029. The convertible notes will convert to a total of 5,000,000 ordinary shares. The convertible note has 1 attaching option with every 3 shares issued to the noteholders upon conversion.

On 9 April 2026, the Company issued additional 750,000 convertible notes with a face value of \$1 exercisable at \$0.10 and expiring on 9 April 2029. The convertible notes will convert to a total of 7,500,000 ordinary shares. The convertible note has 1 attaching option with every 3 shares issued to the noteholders upon conversion.

There were no other significant changes in the state of affairs of the Group during the financial year.

Matters subsequent to the end of the financial year

On 6 July 2026, the Company announced a restructuring agreement with its major shareholders Phelbe Pty Ltd ('Phelbe') and Pure Asset Management ('Pure') to strengthen the Group's financial position to support the growth of the production facility in Kentucky through its investment in NewCarbon. This will be facilitated through issuance of \$3,500,000 convertible notes. Phelbe will contribute \$2,000,000 cash, while Pure's contribution of \$1,500,000 will be set-off against Pure's senior debt facility.

The notes carry a three-year term and a conversion price of \$0.10 per share, with 17,500,000 attaching options. Reflecting their support for the Company through this transition, Pure has agreed to provide any required covenant waivers to 31 December 2026 i.e. the next covenant test date is 31 December 2026.

In addition to the convertible notes, and subject to (a) the shareholders' approval in an EGM expected to occur in late September 2026; (b) the Company's share price closing at or above \$0.09 for five consecutive trading days before 31 December 2026; (c) the commencement of Kentucky operations including independent engineer certification and US\$1,000,000 of third-party revenue; and (d) no material adverse effect, Pure will exercise its outstanding warrants and options with the proceeds to be applied to reduce the debt facility from \$15,000,000 to approximately \$10,000,000 and Pure to waive all the covenants for the remaining life of the debt facility. Phelbe will convert the \$2,000,000 convertible notes to share capital and exercise all options raising approximately \$3,400,000 in cash. All options and convertible notes related to Pure and Phelbe will be offered a 10% per annum discount as early conversion incentive. Even after the discount, all conversion and exercise prices remain above the Company's current share price of \$0.068.

On 6 July 2026, the Company made a US\$250,000 contribution to NewCarbon. On 13 August 2026, the Company made an additional US\$250,000 contribution to NewCarbon increasing the Group's ownership to 49.4% after these contributions.

No other matter or circumstance has arisen since 30 June 2026 that has significantly affected, or may significantly affect the Group's operations, the results of those operations, or the Group's state of affairs in future financial years.

Likely developments and expected results of operations

The Group will continue to expand its industrial AC pellet business in vapour control, liquid solvent recovery and other specific industrial uses of pellets. In line with this expansion, the Group shall make the remaining contributions of US\$750,000 in stages, subject to completion of milestones, to increase its ownership in NewCarbon to 50%. The expansion will significantly increase production capacity and gross margins and will allow existing capacity to be repositioned to produce more specialised technologies.

The Group will continue to provide its PAC solution for emission capture and wastewater treatment and will leverage the competitive advantage of its non-brominated PAC, that does not cause corrosion and damage to plant equipment. Furthermore, there is a renewed and continuing emphasis from a majority of US companies on ESG objectives. Carbonxt's PAC products made at its Black Birch plant utilise renewable feedstock and thus would satisfy the needs of those who are seeking focus on renewable feedstocks.

The Group's current and prospective customers continue to emphasise a desire for US-made pellets. Carbonxt is the only activated carbon industrial pellet developer and producer located in the United States, and this is expected to continue to drive both revenue and margin growth.

Environmental regulation

The Group is not subject to any significant environmental regulation under Australian Commonwealth or State law.

Sustainability reporting

AASB S1 'General Requirements for Disclosure of Sustainability-related Financial Information' provides a set of disclosure requirements designed to enable companies to communicate to investors about the sustainability-related risks and opportunities they face over the short, medium and long term. Principles used to determine the nature and amount of remuneration

The framework aligns executive reward with the achievement of strategic objectives and the creation of value for shareholders, and it is considered to conform to the market best practice for the delivery of reward. The Board of Directors ('the Board') ensures that executive reward satisfies the following key criteria for good reward governance practices:

Note 1. General information

The financial statements cover Carbonxt Group Limited as a Group consisting of Carbonxt Group Limited ('Company' or 'parent entity') and the entities it controlled at the end of, or during, the year (referred to in these financial statements as the 'Group'). The financial statements are presented in Australian dollars, which is Carbonxt Group Limited's functional and presentation currency.

Carbonxt Group Limited is a listed public company limited by shares, incorporated and domiciled in Australia. Its registered office and principal place of business are:

A description of the nature of the Group's operations and its principal activities are included in the directors' report, which is not part of the financial statements.

The financial statements were authorised for issue, in accordance with a resolution of directors, on 31 August 2026. The directors have the power to amend and reissue the financial statements.

Note 2. Material accounting policy information

The accounting policies that are material to the Group are set out below. The accounting policies adopted are consistent with those of the previous financial year, unless otherwise stated.

New or amended Accounting Standards and Interpretations adopted

The Group has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period. The adoption of these Accounting Standards and Interpretations did not have any significant impact on the financial performance or position of the Group during the full financial year ended 30 June 2026.

Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

Going Concern

The financial statements have been prepared on a going concern basis, which assumes that the Group will be able to realise its assets and discharge its liabilities in the ordinary course of business and at the amounts stated in the financial statements.

For the year ended 30 June 2026, the Group reported a net loss after tax of \$4,629,000 (30 June 2025: \$6,761,000) and had a net cash from operating activities of \$492,000 (30 June 2025: net cash used in operating activities of \$4,752,000). At 30 June 2026, the cash and cash equivalents were \$553,000 (30 June 2025: \$481,000), net current liabilities of \$22,004,000 (30 June 2025: \$15,120,000) and the Group reported net assets of \$5,645,000 (30 June 2025: \$9,223,000).

The Group's net current liabilities include the Pure Asset Management Pty Ltd ('Pure') senior debt facility, which matures on 31 May 2027 and has been classified as a current liability with carrying value of \$13.2 million (excluding accrued interest) at reporting date. The total undiscounted principal and interest payable is \$18.1 million at the reporting date.

During the year, the Group was in breach of certain financial covenants under the Pure senior debt facility, including the minimum cash balance covenant and EBITDA-related covenants. The lender has provided waivers in respect of events of default up to 30 June 2026 (refer to note 17).

Note 2. Material accounting policy information (continued)

The Group also has \$3.1 million of convertible notes on issue (refer note 18), including \$0.3 million of unpaid interest as at 30 June 2026, which is included in the Group's net current liabilities. Under the terms of the convertible notes, an event of default may arise if amounts due and payable remain unpaid following notice from the relevant noteholder. As at the date of this report, no such notice has been received.

Subsequent to year end, on 3 July 2026 the Group entered into a waiver and amendment deed and recapitalisation agreement with Pure and Phelbe Pty Ltd ('Phelbe'). The first stage of the recapitalisation completed on 3 July 2026 and included the issue of \$3.5 million of convertible notes, comprising \$2.0 million of new cash funding from Phelbe Pty Ltd and \$1.5 million in convertible notes to Pure set off against senior debt and accrued interest. Pure has also agreed to provide any required covenant waivers for the 30 September 2026 quarter.

The second stage of the recapitalisation remains conditional on shareholder approval, the Company's share price achieving the agreed threshold before 31 December 2026, commissioning of the NewCarbon Activated Carbon Plant and the generation of US\$1.0 million of third-party revenue from that facility, and no material adverse event occurring. If completed, the second stage is expected to result in a reduction of the Pure senior debt facility and further cash funding from Phelbe Pty Ltd. Refer to note 36 for further details.

The Directors have prepared cash flow forecasts for the period to 30 September 2027. These forecasts indicate that the Group is expected to maintain positive cash balances throughout the forecast period. The forecasts are dependent on a number of key assumptions, including:

- Continued support from Pure Asset Management and other lenders and noteholders, including no enforcement action being taken in respect of existing or future events of default;
- Successful completion of the remaining conditions under the recapitalisation agreement;
- Commissioning of the NewCarbon Activated Carbon Plant and generation of forecast operating cash flows from NewCarbon Processing LLC commencing in the December 2026 quarter;
- Achievement of forecast revenue, gross margins and cost savings in the Group's existing activated carbon business;
- The Group's ability to raise additional debt or equity capital, if required; and
- If necessary, the ability to realise value from the Group's interest in NewCarbon Processing LLC as a contingency funding option

The Directors acknowledge that the matters described above give rise to a material uncertainty that may cast significant doubt on the Group's ability to continue as a going concern and, therefore, whether it will be able to realise its assets and discharge its liabilities in the ordinary course of business.

Notwithstanding this material uncertainty, the Directors have reasonable ground to believe the Group will be able to achieve the matters noted above, and consider that the going concern basis of preparation remains appropriate. In reaching this conclusion, the Directors have considered:

- The support from lenders received to date;
- The successful completion of the first stage of the recapitalisation which occurred in July 2026;
- The expected benefits of the recapitalisation if the remaining conditions are satisfied;
- The status of commissioning activities at the NewCarbon facility and expectation it will generate \$1.0 million of third-party revenues by 30 November 2026 and achieve positive net cash inflows by 30 November 2026; and
- The existing customer contracts and opportunity pipeline, the Group's recent history of raising capital, and management's ability to manage operating cash flows and defer certain payments where required.

Should the Group be unable to achieve the matters described above, it may be required to seek additional funding, defer expenditure, renegotiate existing financing arrangements, realise assets, or pursue other strategic alternatives. If the Group is unable to continue as a going concern, it may not be able to realise its assets and discharge its liabilities in the ordinary course of business, and adjustments may be required to the carrying amounts and classification of assets and liabilities reported in these financial statements.

Note 2. Material accounting policy information (continued)

Basis of preparation

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') and the Corporations Act 2001, as appropriate for for-profit oriented entities. These financial statements also comply with International Financial Reporting Standards ('IFRS') Accounting Standards as issued by the International Accounting Standards Board ('IASB').

Historical cost convention

The financial statements have been prepared under the historical cost convention, except for the royalty payable and derivatives measured at fair value.

Critical accounting estimates

The preparation of the financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements, are disclosed in note 3.

Parent entity information

In accordance with the Corporations Act 2001, these financial statements present the results of the Group only. Supplementary information about the parent entity is disclosed in note 35.

Principles of consolidation

The consolidated financial statements incorporate the assets and liabilities of all subsidiaries of Carbonxt Group Limited as at 30 June 2026 and the results of all subsidiaries for the year then ended.

Subsidiaries are all those entities over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date that control ceases.

Intercompany transactions, balances and unrealised gains on transactions between entities in the Group are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of the impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

The acquisition of businesses is accounted for using the acquisition method of accounting. A change in ownership interest, without the loss of control, is accounted for as an equity transaction, where the difference between the consideration transferred and the book value of the share of the non-controlling interest acquired is recognised directly in equity attributable to the parent.

Where the Group loses control over a subsidiary, it derecognises the assets including goodwill, liabilities and non-controlling interest in the subsidiary together with any cumulative translation differences recognised in equity. The Group recognises the fair value of the consideration received and the fair value of any investment retained together with any gain or loss in profit or loss.

Operating segments

Operating segments are presented using the 'management approach', where the information presented is on the same basis as the internal reports provided to the Chief Operating Decision Makers ('CODM'). The CODM is responsible for the allocation of resources to operating segments and assessing their performance.

Foreign currency translation

Foreign currency transactions

Foreign currency transactions are translated into the Company's functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at financial year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss.

Note 2. Material accounting policy information (continued)

Foreign operations

The assets and liabilities of foreign operations are translated into Australian dollars using the exchange rates at the reporting date. The revenues and expenses of foreign operations are translated into Australian dollars using the average exchange rates, which approximate the rates at the dates of the transactions, for the period. All resulting foreign exchange differences are recognised in other comprehensive income through the foreign currency translation reserve in equity.

The foreign currency translation reserve is recognised in profit or loss when the foreign operation or net investment is disposed of.

Revenue recognition

The Group recognises revenue as follows:

Revenue from contracts with customers

Revenue is recognised at an amount that reflects the consideration to which the Group is expected to be entitled in exchange for transferring goods or services to a customer. For each contract with a customer, the Group: identifies the contract with a customer; identifies the performance obligations in the contract; determines the transaction price which takes into account estimates of variable consideration and the time value of money; allocates the transaction price to the separate performance obligations on the basis of the relative stand-alone selling price of each distinct good or service to be delivered; and recognises revenue when or as each performance obligation is satisfied in a manner that depicts the transfer to the customer of the goods or services promised.

Variable consideration within the transaction price, if any, reflects concessions provided to the customer such as discounts, rebates and refunds, any potential bonuses receivable from the customer and any other contingent events. Such estimates are determined using either the 'expected value' or 'most likely amount' method. The measurement of variable consideration is subject to a constraining principle whereby revenue will only be recognised to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur. The measurement constraint continues until the uncertainty associated with the variable consideration is subsequently resolved. Amounts received that are subject to the constraining principle are recognised as a refund liability.

Sale of activated carbon

Revenue from the sale of activated carbon is recognised at a point in time when the activated carbon is delivered in accordance with agreements with customers.

Consultancy fees

Consultancy fees which includes on site testing are recognised at a point in time as the service has been provided.

Grant income

Grants from the government are recognised at their fair value when there is reasonable assurance that the grant will be received and that the Group will comply with all attached conditions. Government grants relating to costs are deferred and recognised in profit or loss as other income over the periods necessary to match them with the costs that they are intended to compensate.

Other revenue

Other revenue is recognised when it is received or when the right to receive payment is established.

Interest income

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

Cost of goods sold

Cost of goods sold includes purchase and production testing costs, milling, blending and bagging costs.

Note 2. Material accounting policy information (continued)

Income tax

The income tax expense or benefit for the period is the tax payable on that period's taxable income based on the applicable income tax rate for each jurisdiction, adjusted by the changes in deferred tax assets and liabilities attributable to temporary differences, unused tax losses and the adjustment recognised for prior periods, where applicable.

Deferred tax assets and liabilities are recognised for temporary differences at the tax rates expected to be applied when the assets are recovered or liabilities are settled, based on those tax rates that are enacted or substantively enacted, except for:

- when the deferred income tax asset or liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and that, at the time of the transaction, affects neither the accounting nor taxable profits; or
- when the taxable temporary difference is associated with interests in subsidiaries, associates or joint ventures, and the timing of the reversal can be controlled and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred tax assets are recognised for deductible temporary differences and unused tax losses only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

The carrying amount of recognised and unrecognised deferred tax assets are reviewed at each reporting date. Deferred tax assets recognised are reduced to the extent that it is no longer probable that future taxable profits will be available for the carrying amount to be recovered. Previously unrecognised deferred tax assets are recognised to the extent that it is probable that there are future taxable profits available to recover the asset.

Deferred tax assets and liabilities are offset only where there is a legally enforceable right to offset current tax assets against current tax liabilities and deferred tax assets against deferred tax liabilities; and they relate to the same taxable authority on either the same taxable entity or different taxable entities which intend to settle simultaneously.

Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

Trade and other receivables

Other receivables are recognised at amortised cost, less any provision for impairment.

Inventories

Inventories are stated at the lower of cost and net realisable value at average cost including haulage.

Cost comprises direct materials and delivery costs, direct labour, import duties and other taxes, an appropriate proportion of variable and fixed overhead expenditure based on normal operating capacity. Cost is determined after deducting rebates and discounts received or receivable

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

Derivative financial instruments

Derivatives are initially recognised at fair value on the date a derivative contract is entered into and are subsequently remeasured to their fair value at each reporting date. The accounting for subsequent changes in fair value depends on whether the derivative is designated as a hedging instrument, and if so, the nature of the item being hedged.

Derivatives are classified as current or non-current depending on the expected period of realisation.

Note 2. Material accounting policy information (continued)

Associates

Associates are entities over which the Group has significant influence but not control or joint control. Investments in associates are accounted for using the equity method. Under the equity method, the share of the profits or losses of the associate is recognised in profit or loss and the share of the movements in equity is recognised in other comprehensive income. Investments in associates are carried in the statement of financial position at cost plus post-acquisition changes in the Group's share of net assets of the associate. Goodwill relating to the associate is included in the carrying amount of the investment and is neither amortised nor individually tested for impairment. Dividends received or receivable from associates reduce the carrying amount of the investment.

When the Group's share of losses in an associate equals or exceeds its interest in the associate, including any unsecured long-term receivables, the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the associate.

The Group discontinues the use of the equity method upon the loss of significant influence over the associate and recognises any retained investment at its fair value. Any difference between the associate's carrying amount, fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

Plant and equipment

Plant and equipment is stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items. Cost of property, plant and equipment constructed includes the cost of materials, direct labour and borrowing costs.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are charged to profit or loss in the period incurred.

Depreciation is calculated on a straight-line basis to write off the net cost of each item of plant and equipment over their expected useful lives as follows:

The residual values, useful lives and depreciation methods are reviewed, and adjusted if appropriate, at each reporting date.

An item plant and equipment is derecognised upon disposal or when there is no future economic benefit to the Group. Gains and losses between the carrying amount and the disposal proceeds are taken to profit or loss.

Right-of-use assets

A right-of-use asset is recognised at the commencement date of a lease. The right-of-use asset is measured at cost, which comprises the initial amount of the lease liability, adjusted for, as applicable, any lease payments made at or before the commencement date net of any lease incentives received, any initial direct costs incurred, and, except where included in the cost of inventories, an estimate of costs expected to be incurred for dismantling and removing the underlying asset, and restoring the site or asset.

Right-of-use assets are depreciated on a straight-line basis over the unexpired period of the lease or the estimated useful life of the asset, whichever is the shorter. Where the Group expects to obtain ownership of the leased asset at the end of the lease term, the depreciation is over its estimated useful life. Right-of use assets are subject to impairment or adjusted for any remeasurement of lease liabilities. Depreciation is calculated as follows:

The Group has elected not to recognise a right-of-use asset and corresponding lease liability for short-term leases with terms of 12 months or less and leases of low-value assets. Lease payments on these assets are expensed to profit or loss as incurred within the cost of goods sold.

Intangible assets

Intangible assets acquired as part of a business combination, other than goodwill, are initially measured at their fair value at the date of the acquisition. Intangible assets acquired separately are initially recognised at cost. Finite life intangible assets are subsequently measured at cost less amortisation and any impairment. The gains or losses recognised in profit or loss arising from the derecognition of intangible assets are measured as the difference between net disposal proceeds and the carrying amount of the intangible asset. The method and useful lives of finite life intangible assets are reviewed annually. Changes in the expected pattern of consumption or useful life are accounted for prospectively by changing the amortisation method or period.

Research and development

Research costs are expensed in the period in which they are incurred. Development costs are capitalised when it is probable that the project will be a success considering its commercial and technical feasibility; the Group is able to use or sell the asset; the Group has sufficient resources and intent to complete the development; and its costs can be measured reliably. Capitalised development costs are amortised on a straight-line basis over the period of their expected benefit, being their finite life of 20 years.

Engineering Performance Solutions ('EPS') patents

Significant costs associated with the acquisition of the patents rights owned by EPS are deferred and amortised on a straight-line basis over the period of their expected benefit, being their finite useful life of 16 years.

Other patents

Significant costs associated with owned, pending and licensed patents are deferred and amortised on a straight-line basis over the period of their expected benefit, being their finite useful life of 20 years.

Impairment of non-financial assets

Non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

Recoverable amount is the higher of an asset's fair value less costs of disposal and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

Trade and other payables

Trade and other payables represent liabilities for goods and services provided to the Group prior to the end of the financial year and which are unpaid. Due to their short-term nature they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

Borrowings

Loans and borrowings are initially recognised at the fair value of the consideration received, net of transaction costs. They are subsequently measured at amortised cost using the effective interest method.

Convertible notes issued by the Group include embedded derivatives that gives the holder the option to convert into a variable number of shares. The derivative liability embedded in the host contract is accounted for separately at fair value through profit or loss. On initial recognition, the difference between the fair value of the embedded derivative and the proceeds is recognised as a financial liability and is subsequently measured at amortised cost. The corresponding interest on convertible notes is expensed to profit or loss.

Warrants

Warrants issued by the Group in connection with bank loans or issued capital are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangement. Where the warrants meet the definition of equity, they are initially measured at fair value and recognised in a warranty reserve. Where the warrants do not meet the definition of equity, they are initially measured at fair value with a corresponding reduction to the associated borrowings if associated with bank loans or as an allocation of proceeds received if associated with a share issue. Subsequent to initial recognition, the liability is fair valued until the warrant either converts or expires, with gains or losses recognised in the profit or loss.

Note 2. Material accounting policy information (continued)

Warrants issued to compensate the lender for the set-up of the loan are recognised as share-based payment transaction.

Lease liabilities

A lease liability is recognised at the commencement date of a lease. The lease liability is initially recognised at the present value of the lease payments to be made over the term of the lease, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Group's incremental borrowing rate. Lease payments comprise of fixed payments less any lease incentives receivable, variable lease payments that depend on an index or a rate, amounts expected to be paid under residual value guarantees, exercise price of a purchase option when the exercise of the option is reasonably certain to occur, and any anticipated termination penalties.

Lease liabilities are measured at amortised cost using the effective interest method. The carrying amounts are remeasured if there is a change in the following: future lease payments arising from a change in an index or a rate used; residual guarantee; lease term; certainty of a purchase option and termination penalties. When a lease liability is remeasured, an adjustment is made to the corresponding right-of use asset, or to profit or loss if the carrying amount of the right-of-use asset is fully written down.

Finance costs

Finance costs attributable to qualifying assets are capitalised as part of the asset. All other finance costs are expensed in the period in which they are incurred.

Employee benefits

Short-term employee benefits

Liabilities for wages and salaries, including non-monetary benefits, and annual leave expected to be settled wholly within 12 months of the reporting date are measured at the amounts expected to be paid when the liabilities are settled.

Share-based payments

Equity-settled share-based compensation benefits are provided to employees.

Equity-settled transactions are awards of shares, or options over shares, that are provided to employees in exchange for the rendering of services.

The cost of equity-settled transactions are measured at fair value on grant date. Fair value is independently determined using either the Binomial or Black-Scholes option pricing model that takes into account the exercise price, the term of the option, the impact of dilution, the share price at grant date and expected price volatility of the underlying share, the expected dividend yield and the risk free interest rate for the term of the option, together with non-vesting conditions that do not determine whether the Group receives the services that entitle the employees to receive payment. No account is taken of any other vesting conditions.

The cost of equity-settled transactions are recognised as an expense with a corresponding increase in equity over the vesting period. The cumulative charge to profit or loss is calculated based on the grant date fair value of the award, the best estimate of the number of awards that are likely to vest and the expired portion of the vesting period. The amount recognised in profit or loss for the period is the cumulative amount calculated at each reporting date less amounts already recognised in previous periods.

Market conditions are taken into consideration in determining fair value. Therefore any awards subject to market conditions are considered to vest irrespective of whether or not that market condition has been met, provided all other conditions are satisfied.

If equity-settled awards are modified, as a minimum an expense is recognised as if the modification has not been made. An additional expense is recognised, over the remaining vesting period, for any modification that increases the total fair value of the share-based compensation benefit as at the date of modification.

Note 2. Material accounting policy information (continued)

If the non-vesting condition is within the control of the Group or employee, the failure to satisfy the condition is treated as a cancellation. If the condition is not within the control of the Group or employee and is not satisfied during the vesting period, any remaining expense for the award is recognised over the remaining vesting period, unless the award is forfeited.

If equity-settled awards are cancelled, it is treated as if it has vested on the date of cancellation, and any remaining expense is recognised immediately. If a new replacement award is substituted for the cancelled award, the cancelled and new award is treated as if they were a modification.

Issued capital

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

Earnings per share

Basic earnings per share

Basic earnings per share is calculated by dividing the profit attributable to the owners of Carbonxt Group Limited, excluding any costs of servicing equity other than ordinary shares, by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the financial year.

Diluted earnings per share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account the after income tax effect of interest and other financing costs associated with dilutive potential ordinary shares and the weighted average number additional ordinary shares that would have been outstanding assuming conversion of all dilutive potential ordinary shares.

Rounding of amounts

The Company is of a kind referred to in Corporations Instrument 2026/183, issued by the Australian Securities and Investments Commission, relating to 'rounding-off'. Amounts in this report have been rounded off in accordance with that Corporations Instrument to the nearest thousand dollars, or in certain cases, the nearest dollar.

Comparatives

Comparatives in the statement of profit or loss and other comprehensive income have been realigned to the current year presentation. There was no effect on the results of operations for the year.

New Accounting Standards and Interpretations not yet mandatory or early adopted

Australian Accounting Standards and Interpretations that have recently been issued or amended but are not yet mandatory, have not been early adopted by the Group for the annual reporting period ended 30 June 2026. The Group has assessed that there will be no significant impact on adoption of these new or amended Accounting Standards and Interpretations, except for AASB 18, as explained below. The new or amended Accounting Standards and Interpretations, most relevant to the Group, are set out below.

AASB 18 Presentation and Disclosure in Financial Statements

This standard is applicable to annual reporting periods beginning on or after 1 January 2027, with early adoption permitted. The standard replaces AASB 101 'Presentation of Financial Statements'. The implementation of this standard will introduce new categories in the statement of profit and loss and will require additional disclosures about management-defined performance measures ('MPMs'). The full impact of this standard is still being considered and will first apply to the Group for the financial year ending 30 June 2028.

AASB 2024-2 Amendments to the Classification and Measurement of Financial Instruments

AASB 2024-2 is applicable for annual reporting periods beginning from 1 January 2026, with early adoption permitted. This standard makes amendments to AASB 9 'Financial Instruments' and AASB 7 'Financial Instruments: Disclosures' to clarify how the contractual cash flows from financial assets should be assessed in determining how they should be classified.

Note 3. Critical accounting judgements, estimates and assumptions

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgements and estimates will seldom equal the related actual results. The judgements, estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

Royalty payable

This is remeasured at each reporting period for changes to cashflows which requires estimation and judgement. The judgements include considerations of forecasted sales volumes and price assumptions. The Company reviews any changes in assumptions and this is done for each reporting period until the end of the contract period. Changes in assumptions about these factors could affect the reported value of the amount payable.

Development costs

The Group capitalises costs for product development projects. Initial capitalisation of costs is based on management's judgement that technological and economic feasibility is confirmed, usually when the product has consistently met the defined specifications at commercial-scale throughputs. At 30 June 2026, the carrying amount of capitalised development costs was \$3,250,000 (2025: \$3,655,000).

Impairment of non-financial assets

The Group assesses impairment of non-financial assets at each reporting date by evaluating conditions specific to the Group based on known information and to the particular asset that may lead to impairment. If an impairment trigger exists, the recoverable amount of the asset is determined. This involves assessing the value of the asset at fair value less costs of disposal and using value-in-use models which incorporate a number of key estimates and assumptions.

Impairment indicator assessment for investment in associate

The investments in associates are carried at the lower of the equity-accounted amount and the recoverable amount. The carrying amounts of investments in associates and joint ventures are reviewed at each reporting date to determine whether there is any indication of impairment. There is significant judgement involved in determining whether indicators of impairment exist. If any such indication exists, the Group estimates the recoverable amount of the asset. An impairment loss is recognised if the carrying amount of the investment in associates exceeds its recoverable amount.

Convertible notes

The Company has issued convertible notes payable that contain both a debt component and an embedded derivative liability associated with the conversion feature. The carrying amount of the debt component of the convertible notes is determined based on the present value of future cash flows, discounted at the market interest rate for similar debt instruments without conversion features.

The embedded derivative liabilities, representing the conversion option and free attaching options, are valued using a Black-Scholes option pricing model taking into account the terms and conditions upon which the instruments were granted. Key assumptions used include: stock price volatility, expected term of the conversion option, risk-free interest rate and level of dividends expected to be paid.

Note 4. Operating segments

Identification of reportable operating segments

The Group only has one reportable segment being the development and sale of specialised Activated Carbon ('AC') products, principally in the United States of America. This is based on the internal reports that are reviewed and used by the Board of Directors (who are identified as the Chief Operating Decision Makers ('CODM')) in assessing performance and in determining the allocation of resources. There is no aggregation of operating segments.

The information reported to the CODM is on a monthly basis.

Interests in NewCarbon

On 31 May 2023, the Group executed an agreement with KCP to establish a new state-of-the-art activated carbon plant in Kentucky, USA which resulted in the formation of a Kentucky limited liability entity named NewCarbon Processing, LLC ("NewCarbon"). The Group has agreed to contribute US\$10,000,000 in cash to NewCarbon while KCP agreed to contribute US\$10,000,000 in value of assets, infrastructure and equipment. The contributions will result to a 50:50 ownership between the two parties.

The contributions to NewCarbon for the year totalled to US\$1,500,000 (30 June 2025: US\$2,250,000) which increased the ownership in NewCarbon to 48.05% as at 30 June 2026 (30 June 2025: 43.66%). The future contributions are disclosed as commitment in note 28.

Impairment indicators assessment

The activated carbon plant in Kentucky ('the plant') has taken longer to bring into operation than anticipated at the start of the year, caused by an equipment issue that is being resolved with the full support of the kiln manufacturer.

As of 30 June 2026, the construction of the kiln was completed, refractory lining installed and heat treatment undertaken. The back-end infrastructure, bagging station, conveyors, additional storage silos, and the onsite power station were installed and brought online. All outside works have been completed.

The Group targeted first revenues from the plant in early calendar year 2026 and have not met that timetable. As the plant moved into early commissioning, remediation requirements were identified in the kiln, and further inspection established that certain affected equipment needed to be replaced, as well as certain equipment that needed to be repaired. The kiln manufacturer agreed to replace the equipment at their cost and facilitate the repairs and has remained constructive and supportive throughout.

Replacement parts began arriving during the June 2026 quarter. Subsequent to 30 June 2026, the kiln finalisation has continued and is nearing finalisation. Identifying and correcting these issues before sustained production begins is the right outcome for the plant's long-term reliability.

Note 12. Investments accounted for using the equity method (continued)

The carrying amount of the equity-accounted investment in NewCarbon continues to be assessed and monitored for impairment indicators at each reporting date. Factors considered included the construction delays at the Kentucky facility, root cause analysis for the delays in commissioning, remediation and recommissioning plans, forecast operating performance post commissioning, market demand for activated carbon products, technological changes and external market conditions. The Kentucky facility is expected to function as intended once the above mentioned remediation works and commissioning have been completed. Based on this assessment, the Directors concluded that no indicators of impairment existed at the reporting date.

Office Space Lease: The Group has entered into a non-cancellable lease agreement for office space that has been renewed until 31 March 2028.

Blackbirch Facility Lease: On 15 July 2018, the Group entered into a lease for an industrial facility in Swainsboro, Georgia, USA which serves as one of the Group's activated carbon production sites. The facility has an annual production capacity of up to 10,000 tonnes of activated carbon products. The lease has an initial term of 50 years and includes options to extend for up to three additional 10-year periods.

Albertville Minnesota Lease: On 1 March 2026, the Group entered into a lease for an industrial facility in Albertville, Minnesota, USA which serves as one of the Group's activated carbon production sites and replaced the Arden Hills facility. The facility has an annual production capacity of up to 7,000 tonnes of activated carbon products. The lease has an initial term of eight years and includes an option to renew for a further eight-year period.

Arden Hills Facility Lease: On 1 January 2019, the Group entered into a lease for an industrial facility in Arden Hills, Minnesota, USA which served as one of the Group's activated carbon production sites. The lease term ends on the 31st of August 2026. The facility was subsequently replaced by the Albertville Minnesota facility following the expiry of the original lease term.

Pure loan payable

The Group entered into an agreement with Pure Asset Management Pty Ltd ('Pure') on 23 May 2023 to amend and restate the Facility Agreement dated 24 May 2019 with effect on and from 31 May 2023. Under the amended and restated loan facility agreement, the existing loan of \$5,500,000 was refinanced and an additional \$9,500,000 was drawn from the facility which will be used to fund the NewCarbon Processing LLC, acquisitions and product development, and for working capital purposes. In consideration of entering the amended and restated facility agreement, the Group paid establishment fee of \$450,000 resulting in net proceeds from borrowings of \$9,050,000 and subject to the Shareholders' Approval, the Group was required to issue warrant shares of 64,000,000 in different tranches to Pure (see note 34) which have been recognised as transaction cost of \$2,339,000 and capitalised against the loan. At the inception of the loan in 2023, the Group also agreed to pay Pure a royalty for which the present value of future cash flows is of \$2,957,000 and was recorded against the loan. As at 30 June 2026, the loan balance is \$13,156,000 which includes accretion of interest expense of \$1,592,000 during the period (2025: \$983,000). As of 30 June 2026, accrued interest payable (including penalty interest) in relation to the loan amounts to \$3,216,000 (2025: \$1,409,000) see note 16.

The new facility is payable on 31 May 2027, which is 48 months after the date of utilisation. The facility accrues an interest of 9.5% per annum (14% per annum at the event of default).

The Group has an exclusive licence from EPS to use its patented technology up to 17 March 2028. Royalties are payable to EPS out of revenue received by the Group from the sale of products using the EPS technology, as follows:

- sale price below US\$2,000 per ton - 1% of revenue;
- sale price of US\$2,000 to US\$2,500 per ton - 2% of revenue;
- sale price of US\$2,500 to US\$3,000 per ton - 3% of revenue; and
- sale price above US\$3,000 per ton - 4% of revenue.

The royalty payable balance as of 30 June 2026 from EPS license is \$21,000 (2025: \$39,000).

Royalty payable with Pure Asset Management

As disclosed in note 17, the Company's agreement with Pure includes a royalty payable. The term of the royalty is from 31 May 2023 until the royalty is bought out. The Group may only elect to purchase the royalty if the loan obtained from Pure including any unpaid royalty is less than \$7,500,000 on the earlier of the date that is any point in time after 31 May 2026 and the date on which a board recommended takeover occurs in respect of the Group. Credit risk

These provisions are considered representative across all customers of the Group based on recent sales experience, historical collection rates and forward-looking information that is available.

Generally, trade receivables are written off when there is no reasonable expectation of recovery. Indicators of this include the failure of a debtor to engage in a repayment plan, no active enforcement activity and a failure to make contractual payments for a period greater than 1 year.

Liquidity risk

Vigilant liquidity risk management requires the Group to maintain sufficient liquid assets (mainly cash and cash equivalents) and available borrowing facilities to be able to pay debts as and when they become due and payable.

The Group manages liquidity risk by maintaining adequate cash reserves and available borrowing facilities by continuously monitoring actual and forecast cash flows and matching the maturity profiles of financial assets and liabilities.

This will be facilitated through issuance of \$3,500,000 convertible notes. Phelbe will contribute \$2,000,000 cash, while Pure's contribution of \$1,500,000 will be set-off against Pure's senior debt facility.

The notes carry a three-year term and a conversion price of \$0.10 per share, with 17,500,000 attaching options. Reflecting their support for the Company through this transition, Pure has agreed to provide any required covenant waivers to 31 December 2026 i.e. the next covenant test date is 31 December 2026.

In addition to the convertible notes, and subject to (a) the shareholders' approval in an EGM expected to occur in late September 2026; (b) the Company's share price closing at or above \$0.09 for five consecutive trading days before 31 December 2026; (c) the commencement of Kentucky operations including independent engineer certification and US\$1,000,000 of third-party revenue; and (d) no material adverse effect, Pure will exercise its outstanding warrants and options with the proceeds to be applied to reduce the debt facility from \$15,000,000 to approximately \$10,000,000 and Pure to waive all the covenants for the remaining life of the debt facility. Phelbe will convert the \$2,000,000 convertible notes to share capital and exercise all options raising approximately \$3,400,000 in cash. All options and convertible notes related to Pure and Phelbe will be offered a 10% per annum discount as early conversion incentive. Even after the discount, all conversion and exercise prices remain above the Company's current share price of \$0.068.

On 6 July 2026, the Company made a US\$250,000 contribution to NewCarbon. On 13 August 2026, the Company made an additional US\$250,000 contribution to NewCarbon increasing the Group's ownership to 49.4% after these contributions.

No other matter or circumstance has arisen since 30 June 2026 that has significantly affected, or may significantly affect the Group's operations, the results of those operations, or the Group's state of affairs in future financial years.

At 30 June 2026, the Group's consolidated statement of financial position included a \$13.7m investment in associate being an investment in NewCarbon Processing LLC ("NewCarbon"). This investment represents 45.9% and 40.7% of the Group's total non-current assets and total assets respectively. As disclosed in Note 12 of the financial report, the Group assesses investments in associates for indicators of impairment at each balance date in line with the requirements of AASB 128 Investments in Associates and Joint Ventures and AASB 136 Impairment of Assets. Where such events are identified, a full impairment test is required. The Group's assessment of indicators of impairment included consideration of the construction delays, rectification plans and associated costs, expected plant functionality, whether there is any physical damage of the plant or changes in the plant's fair value and technological and market developments. At 30 June 2026, the Group concluded no impairment indicators were present. Due to the size of the investment relative to the Group's total assets, strategic importance of the investment in associate for financing and future profitability of the Group, and the significant judgement involved in the impairment indicator assessment, this was considered a key audit matter.	Our audit procedures included the following: • Evaluated the appropriateness of the Group's classification of its investment in NewCarbon as an investment in associate. This included assessing the relevant contractual arrangements and considering the extent of the Group's ability to exercise significant influence over NewCarbon. • Validated the Group's ownership interest in NewCarbon as at 30 June 2026, with reference to executed agreements, bank records and share certificates issued to the Group. • Validated the carrying amount of the investment as at 30 June 2026, taking into account the Group's share of the associate's profit and loss. • With the assistance of our capital equipment valuation specialists, evaluated management's assessment of impairment indicators in relation to the NewCarbon facility under construction.
