The Share Rights were satisfied by allocating ordinary shares from the Endeavour Group Employee Equity Plan Trust (the Trust), which were purchased on-market. The ordinary shares are held by Pacific Custodians Pty Limited as trustee for the Trust, for Joanne Pollard, until the end of the nominated restriction period.
