CHAIR'S LETTER

Dear Shareholders,

I am pleased to present Ordell Minerals' 2026 Annual Report following another active and productive year for the Company, during which we continued to unlock the value of our high-quality Western Australian gold portfolio.

The standout has been the progress achieved at our flagship Barimaia Gold Project in the Murchison region, where sustained drilling has continued to demonstrate the scale and quality of the emerging gold system while progressively advancing the project towards a maiden Mineral Resource Estimate and potential future development opportunity.

Importantly, Ordell has now entered an exciting new phase in the evolution of Barimaia.

We have recently commenced a major new ~14,000m drilling campaign designed to fast-track the definition of a maiden Mineral Resource at the advanced McNabs East prospect, targeted for the December Quarter of 2026, while simultaneously pursuing new discoveries across the broader Barimaia mineralised intrusive system.

This reflects the two-pronged strategy that will guide our activities over the coming year: advancing the potential near-term development opportunity at McNabs East while continuing to systematically explore the broader Barimaia Project for additional discoveries and resource growth.

Sustained Exploration Success at Barimaia

Over the course of FY2026, Ordell maintained an intensive exploration effort at Barimaia, systematically testing for gold mineralisation at shallow depths across the broader +7km prospective intrusive system.

These programs comprised approximately 25,000m of air-core, Reverse Circulation (RC) and diamond drilling. Our activities focused primarily on McNabs East, McNabs and The Furnace, while also testing the broader intrusive trend for potential new discoveries.

At McNabs East, drilling has defined gold mineralisation over an interpreted strike extent of more than 800m, delivering numerous high-grade intersections and defining a shallow zone of mineralisation that commences from approximately 10m below surface and remains open along strike and at depth.

The combination of shallow mineralisation, high-grade zones and demonstrated continuity has reinforced our view that McNabs East has the potential to underpin a future open-pit development opportunity.

At the same time, air-core drilling has continued to systematically test for new felsic intrusions along the broader Barimaia mineralised intrusive system. This is an important component of our strategy, ensuring we continue to build a pipeline of new exploration opportunities.

Building the Foundations for Development

As Barimaia has advanced, our activities have increasingly extended beyond exploration drilling.

During the year, Ordell commenced a range of technical work to support the potential future development of the Project, including ground and surface water studies, environmental studies, geological modelling and geotechnical work.

These activities represent an important step in the maturation of Barimaia and will provide the technical foundation for future mining, Scoping and Feasibility studies. This work will continue alongside our resource definition drilling as we systematically evaluate the potential pathway towards development at McNabs East.

A Strong Growth Pipeline

While Barimaia remains our clear strategic priority, Ordell also continued to advance its broader Western Australian exploration portfolio during FY2026.

At the Goodia Project near Norseman, two large soil geochemical sampling programs were undertaken, with the initial phase defining three strong and coherent surface gold anomalies. Follow-up sampling subsequently confirmed further extensive surface anomalism to the south, providing an exciting target for first-pass air-core drilling.

At Fisher South in the Northeastern Goldfields, a maiden air-core drilling program confirmed gold anomalism over approximately 2km of strike, while anomalous tungsten results have provided an additional attractive follow-up opportunity.

Both projects are located within proven mineral provinces and provide Ordell with valuable longer-term exploration optionality alongside the rapidly advancing Barimaia Project.

Strong Financial Position

Importantly, Ordell enters FY2027 in a strong financial position to execute its exploration and growth strategy, with \$8.2 million in cash at the end of the reporting period.

During FY2026, the Company completed capital raisings totalling \$10.85 million, strengthening our balance sheet and providing the financial capacity to maintain an aggressive exploration program.

We were particularly pleased with the strong participation of both existing and new shareholders in these raisings. This support has enabled Ordell to accelerate drilling and technical activities at Barimaia at an important stage in the Project's evolution, and we are committed to deploying that capital in a disciplined manner with the objective of creating long-term shareholder value.

Looking Ahead

FY2027 has the potential to be a defining year for Ordell Minerals.

Our priority is the successful execution of the major drilling campaign now underway at Barimaia and delivery of our first Mineral Resource Estimate for McNabs East in Q4 2026.

From there, our objective is to progressively advance the technical and development work required to better understand the potential for a future open-pit mining operation at McNabs East.

At the same time, we will maintain our strong exploration focus across the broader Barimaia system. With a prospective intrusive trend extending for more than 7km and significant areas remaining comparatively lightly tested, we believe there is potential for further discoveries that could significantly expand the scale of the overall Project.

Follow-up exploration at Goodia and Fisher South provides an additional layer of growth potential across our portfolio.

Acknowledgements

In closing, I would like to acknowledge Ordell's management team, employees and contractors for their commitment and outstanding efforts over the course of what has been an exceptionally active year.

I would also like to thank my fellow Directors for their valuable contribution, wise counsel and commitment to maintaining the highest standards of governance as the Company continues to grow.

Finally, on behalf of the Board, I would like to thank our shareholders for their continued support. Your backing has enabled us to pursue an ambitious exploration and growth strategy, and we greatly appreciate the confidence you have placed in Ordell and our team.

We enter FY2027 with considerable momentum and an exciting program ahead of us. I look forward to reporting on our progress as we work to realise the full potential of Barimaia and build long-term value for all Ordell shareholders.

Company Secretary

Mr James is an experienced Company Secretary with more than 20 years' experience working for listed companies in the resources industry. He is a Chartered Accountant and Associate of the Governance Institute of Australia. Most recently Mr James was Company Secretary for Genesis Minerals Limited (2015 – 2024).

Meetings of Directors

During the year ended 30 June 2026, the directors held four meetings with all board members attending.

Due to the size of the Company, no committees have been established by the Board.

Principal Activities

The principal activities of the Group during the year were mineral exploration activities in Western Australia.

Dividends

No dividend was declared or paid during the current or previous year.

Finance Review

The operating loss of the Group after providing for income tax amounted to \$6,007,751 (2025: loss of \$3,380,409).

The loss for the year arose from expenditure on exploration activities and share based payments expense as part of the Group's strategy to achieve exploration success through new discoveries.

At the end of the year the Group held cash reserves of \$8,215,042 (30 June 2025: \$2,759,055).

The net assets of the Group increased from \$4,269,564 to \$9,549,368 at 30 June 2026.

Issues of equity during the year totalled \$10,781,641 (net of costs) which was offset by the operating loss recorded for the year.

Basic and diluted loss per share for the year was 9.55 cents per share (2025: 6.95 cents).

In accordance with ASX Listing Rule 4.10.19, the Company confirms that it has used the cash it had at the date of admission to ASX on 17 July 2024 for the period to 30 June 2026 consistent with its business objectives of mineral exploration in Western Australia.

Operating Review

During the year, the Group continued its strategy to unlock the potential of our gold assets in Western Australia through disciplined, systematic exploration programs. Our projects include the Barimaia JV Project near Mount Magnet, the Goodia Project near Norseman and the Fisher South Project situated in the North Eastern Goldfields region of Western Australia (see Figure 1). Exploration has been focused on the Company's flagship Barimaia JV Project.

Barimaia JV Project

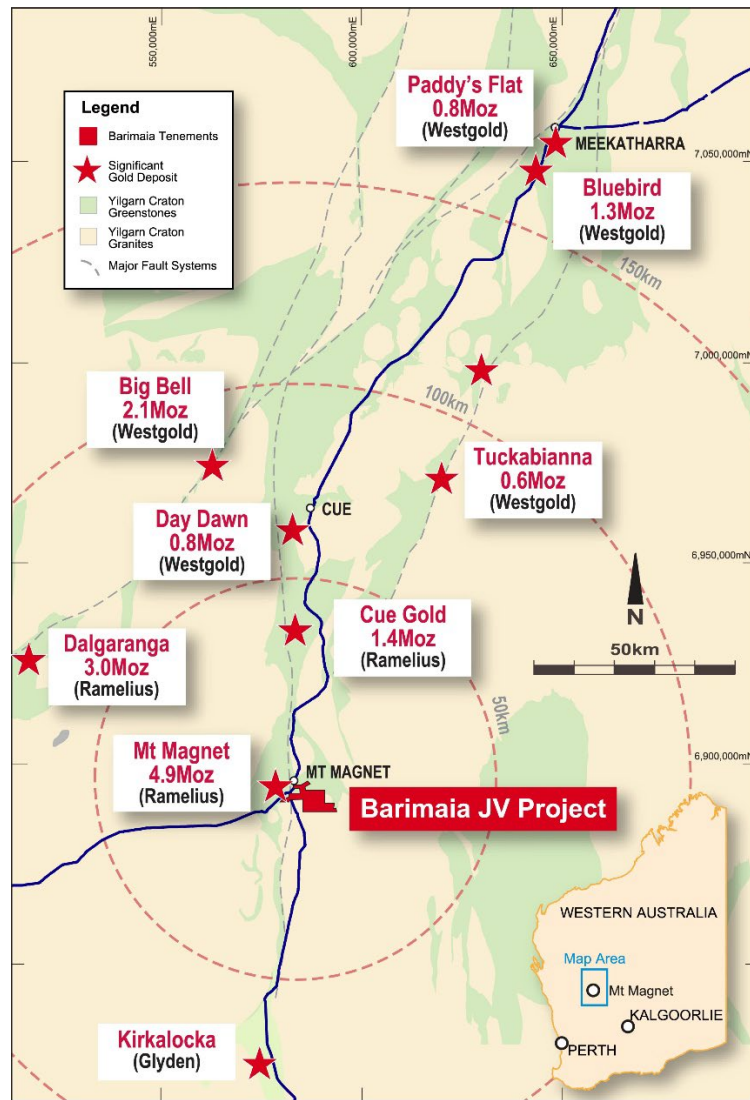


Figure 2: Location of the Barimaia Project and other nearby deposits. See Table 1 for source data for Mineral Resources of Gold Deposits in the Murchison District.

The Company holds an 80.3% interest in the Barimaia Gold Project ("Barimaia"), located near Mount Magnet in the Murchison district of Western Australia. Barimaia is located in a Tier-1 mining jurisdiction in close proximity to several gold processing plants, adjacent to Ramelius Resources' (ASX: RMS) Mount Magnet Gold Project (see Figure 2).

Barimaia hosts similar geology (including interpreted felsic intrusion host rocks of granodiorite composition) to the Eridanus gold deposit, which forms part of Ramelius Resources' Mount Magnet gold mining operations. Eridanus lies approximately 6km north-west of Barimaia and hosts a current Mineral Resource Estimate of 30Mt @ 1.6g/t Au for 1,500,000oz of contained gold¹, with an additional +300,000 ounces of gold already mined from the open pit.

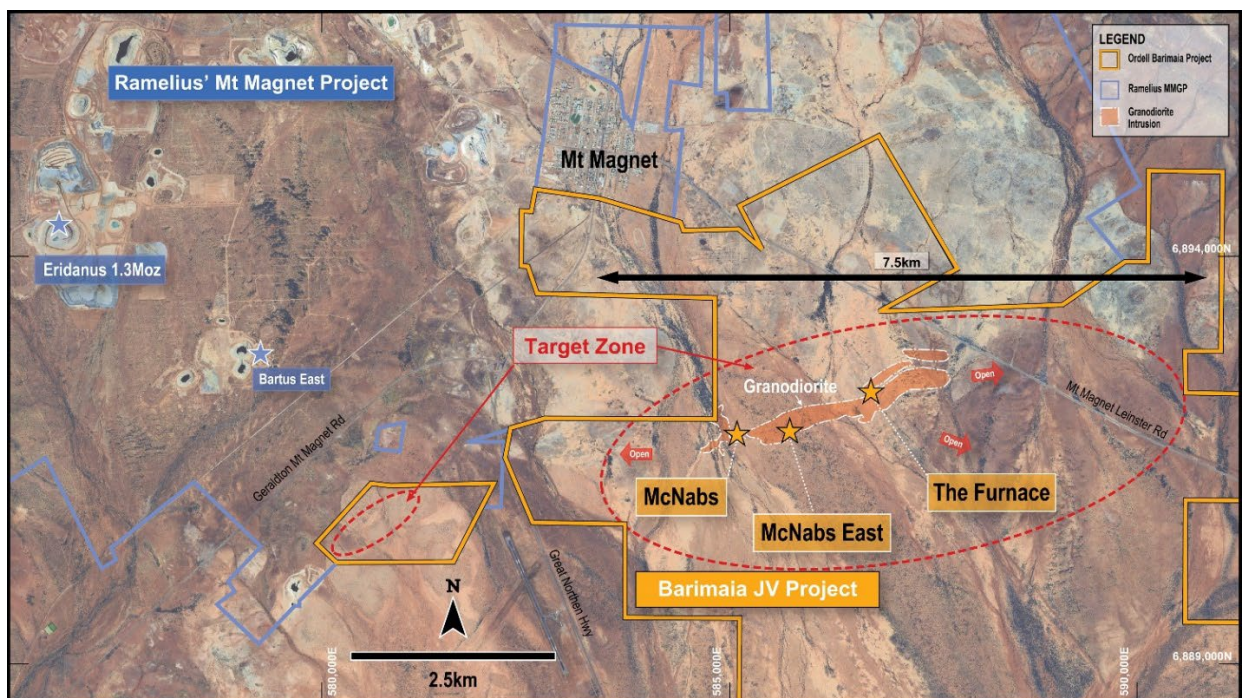


Figure 3: Barimaia Project outlines showing target granodiorite host rock and prospects.

Ordell is undertaking systematic drilling over 7.5km of strike extent at Barimaia to target Eridanus-style discoveries (Figure 3).

FY2026 Drilling Programs

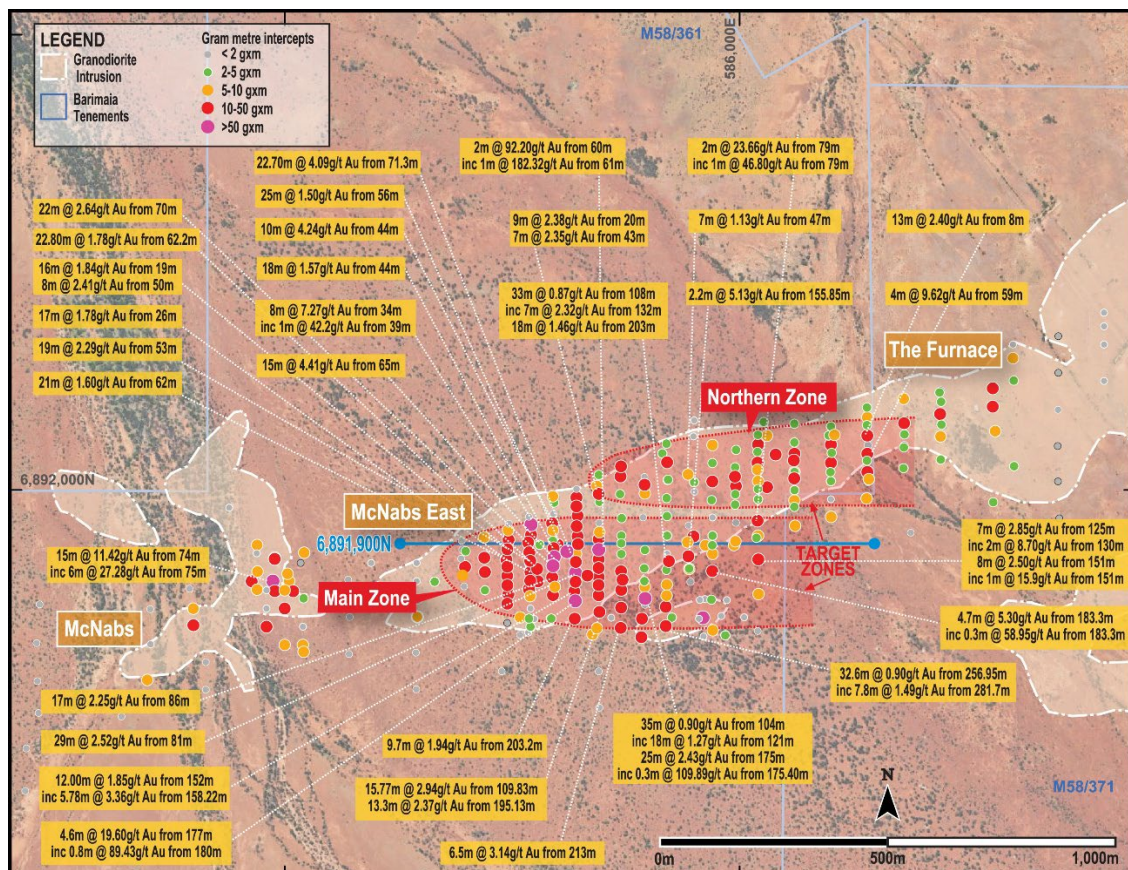


Figure 4: Results from drilling at Barimaia centred on the McNabs East Prospect. The location of the section for Figure 5 is shown in light blue.

During the year, Ordell undertook a number of successful drilling programs with approximately 25,000m of RC, diamond and air core drilling completed, primarily focused on the McNabs East Prospect (see Figure 4) as well as on the systematic follow-up of the +7km prospective felsic intrusion host rock along strike from McNabs East.

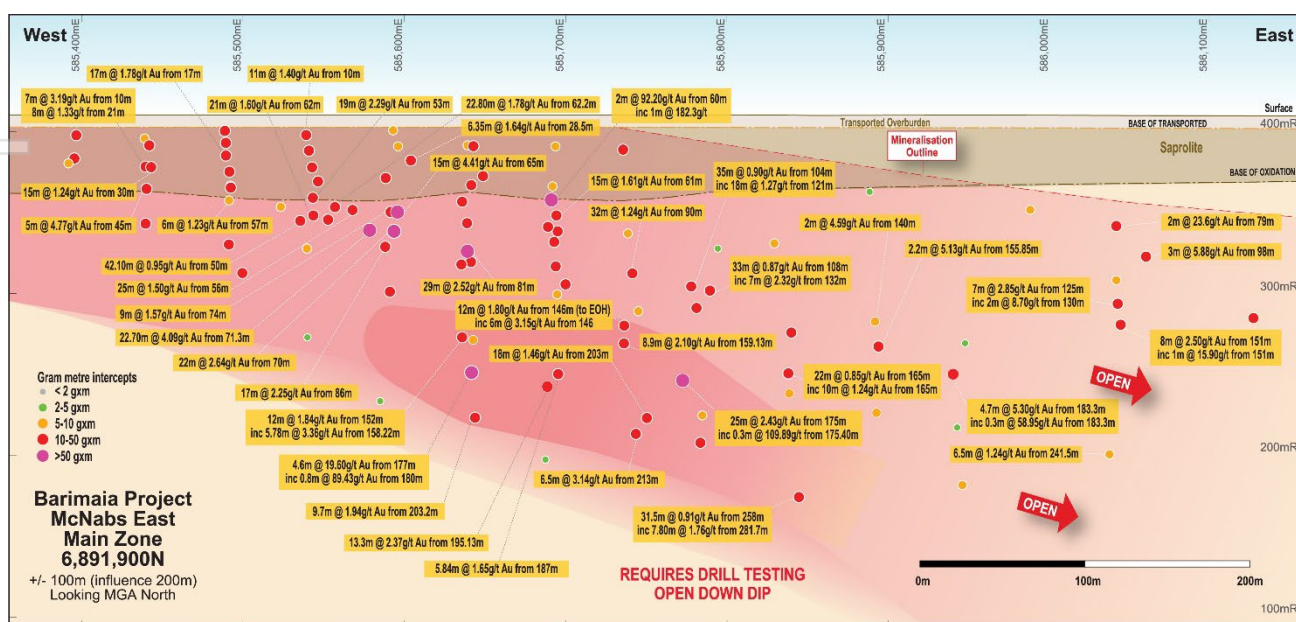


Figure 5: Section 6,891,900N (Main Zone +/-100M) showing drilling intercepts. Gold mineralisation is open and untested down dip and plunge within the granodiorite.

The results from the drilling programs are highlighted on Figures 4 and 5 and continue to confirm shallow, open pit potential, with coherent zones of gold mineralisation defined within an extensive gold system that remains open and untested at depth and open along strike.

Upcoming Exploration

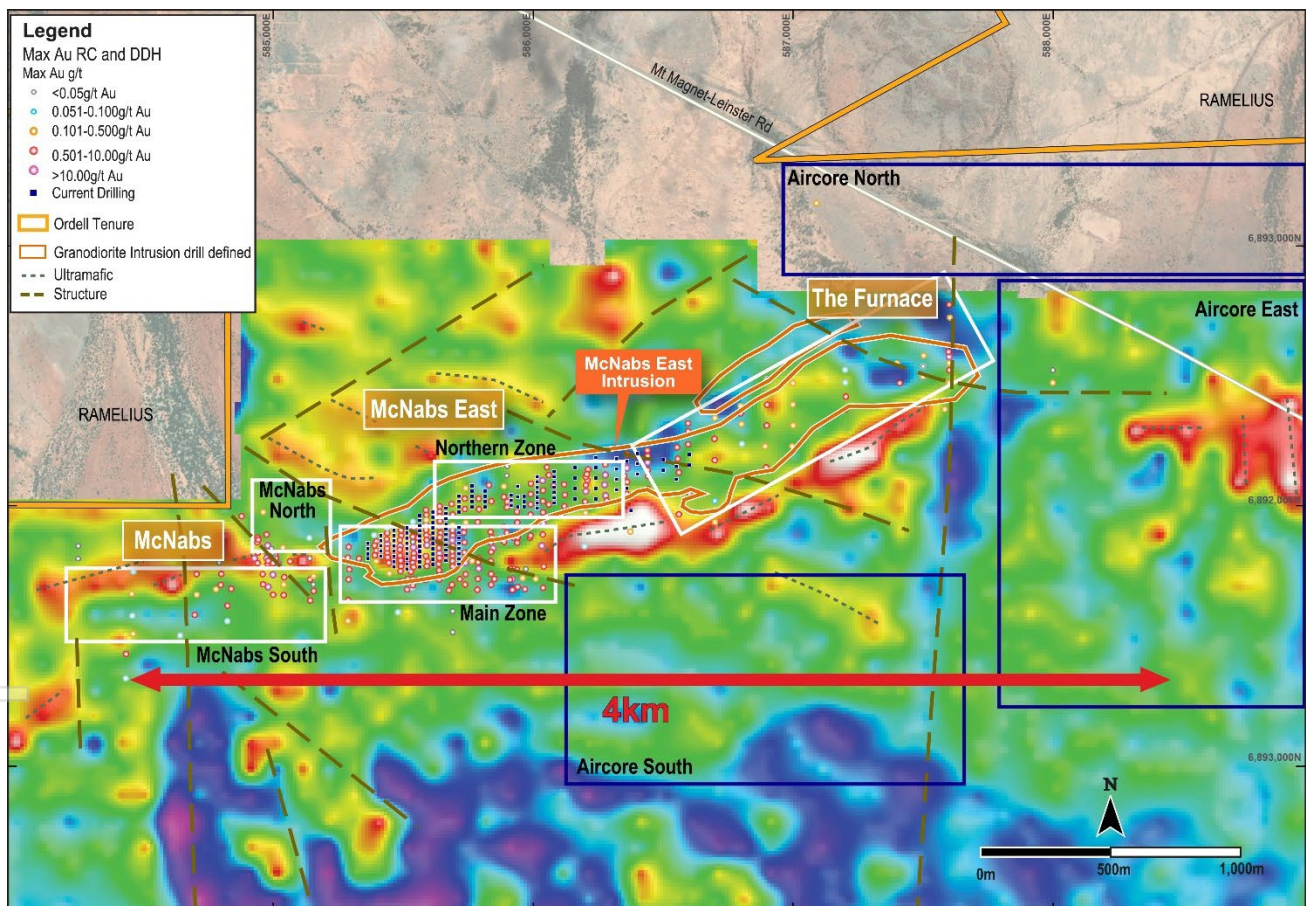


Figure 6. Proposed drilling August to September on 1VD Gravity BA267. Proposed RC drilling highlighted by grey squares with black outlines and aircore drilling within dark blue polygons.

Drilling for the remainder of 2026 will include ~10,000m (~ 140 holes) of RC drilling to confirm continuity of mineralisation targeting shallow mineralisation with the potential to be extracted via open pit mining methods prior to completing an initial Mineral Resource Estimate (MRE) and ~ 4,000m of aircore drilling. Areas to be drilled are highlighted on Figure 6 and include:

1. **McNabs East Main Zone:** RC drilling to take drill spacing to 25m section spacing x 20m hole spacing along section to ~90m vertical over 350m of strike between 585,365E and 585,715E. The objective of the drilling is to confirm continuity of mineralisation, particularly higher-grade zones identified to date, prior to the planned MRE due for completion in the December 2026 quarter;
2. **McNabs East Northern Zone:** RC drilling to take drill spacing to 40m section spacing x 40/20m hole spacing along section to ~60m vertical over 835m of strike between 585,765E and 586,600E to confirm continuity of gold mineralisation prior to the planned MRE due for completion in the December quarter;
3. **P58/2051:** First pass drill testing of quartz vein identified at surface; and
4. **Aircore North, Aircore South and Aircore East:** Completion of systematic aircore drilling program to follow up aircore-generated gold anomalism and multielement geochemistry with the objective of identifying new prospective intrusions.

Drilling in the December 2026 Quarter at Barimaia will include further extensional drilling at depth at McNabs East, testing down plunge and down dip (see Figure 5) of known mineralisation within the granodiorite. The drilling will also include the follow up of anticipated gold anomalies generated from air-core drilling.

Mineral Resource Estimate

A Mineral Resource Estimate is expected to be completed in the December 2026 Quarter following the receipt of all assays from the current drilling program.

Mining Studies and Approvals

Work on technical studies and approvals will be advanced on a number of fronts for the remainder of 2026 and into the first half of 2027 including:

- Metallurgical test work assessment;
- Geotechnical Assessment for both Open Pit and Underground and potentially geotechnical drilling;
- Preliminary open pit optimisations and conceptual mine designs;
- Mining infrastructure design work including Rock Landform (WRL);
- Surface Water (Flooding) Assessment;
- Groundwater and Water Balance Assessment (Section 26D licence recently applied for 10 bores);
- Waste Rock geochemistry and Soil Characterisation Assessments and commencement of test work as recommended;
- Flora, Vegetation and Fauna Survey reviews and further surveys if required;
- Heritage Surveys if required;
- Continued Stakeholder Consultation; and
- Commencing preparation of Mining Development and Closure Proposal (MDCP) and Clearing Permit application.

Goodia Project

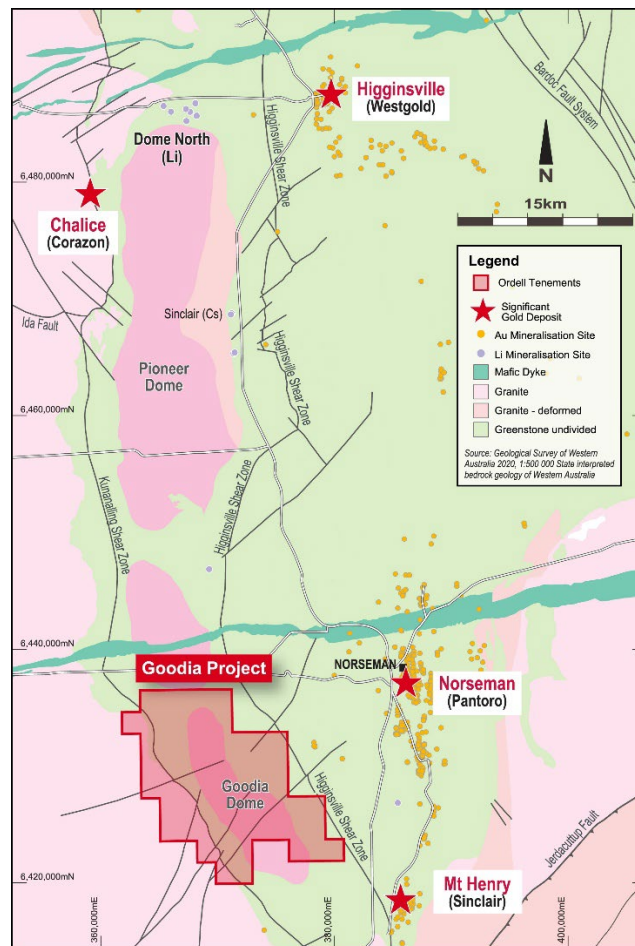


Figure 7. Location of Goodia Project.

The Goodia Project represents an early-stage exploration opportunity located approximately 15km west of Norseman (Figure 7) and is located close to several operating gold mines.

During the year, Ordell completed several soil geochemical sampling programs targeting the eastern side of the Goodia Dome. The results have defined extensive and robust surface gold anomalism along the eastern margin of the Goodia Dome.

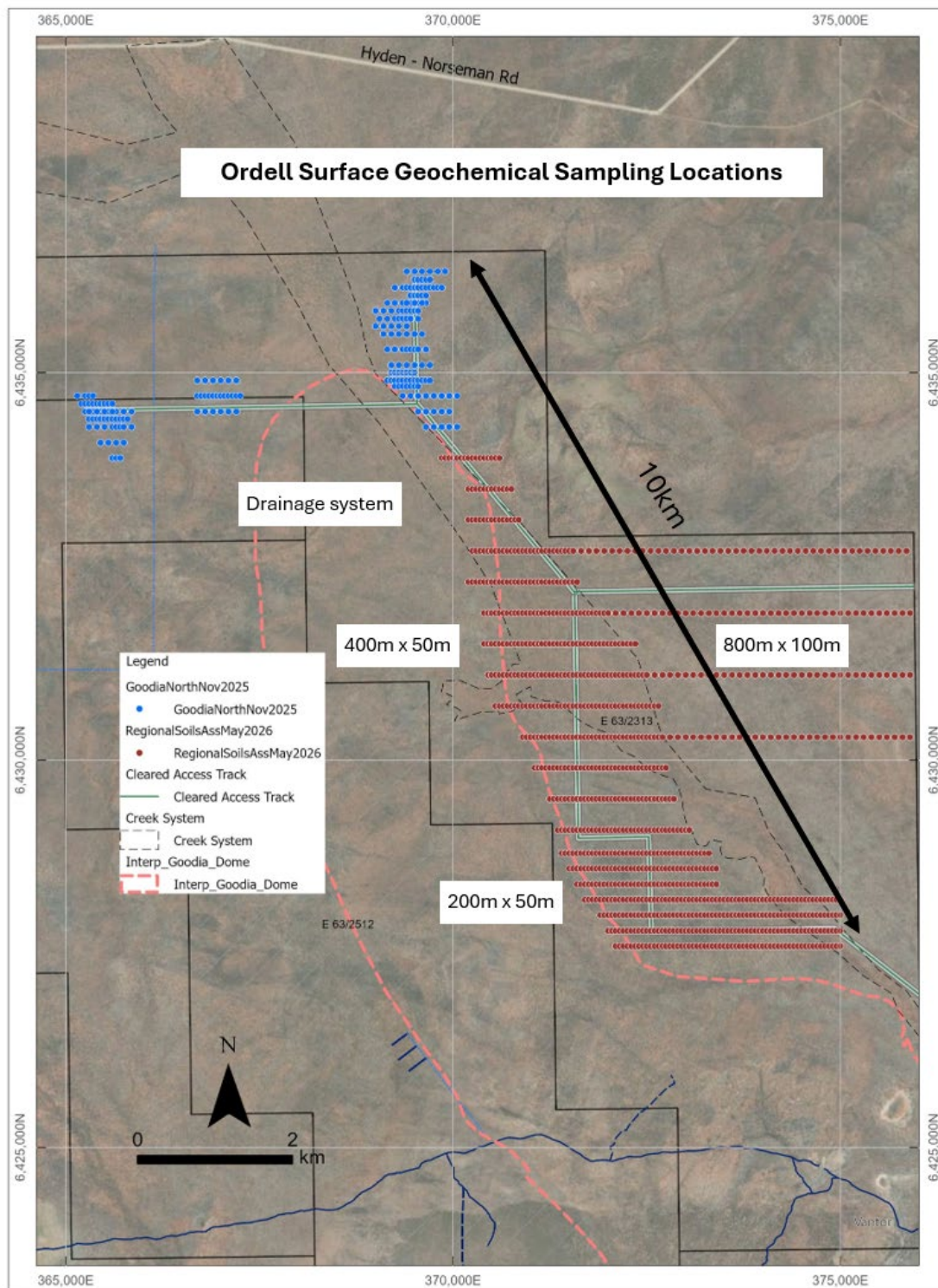


Figure 8. May 2026 sampling locations on the eastern side of Goodia Dome with sample spacings highlighted. May 2026 sampling shown as brown circles and November 2025 sampling in dark blue.

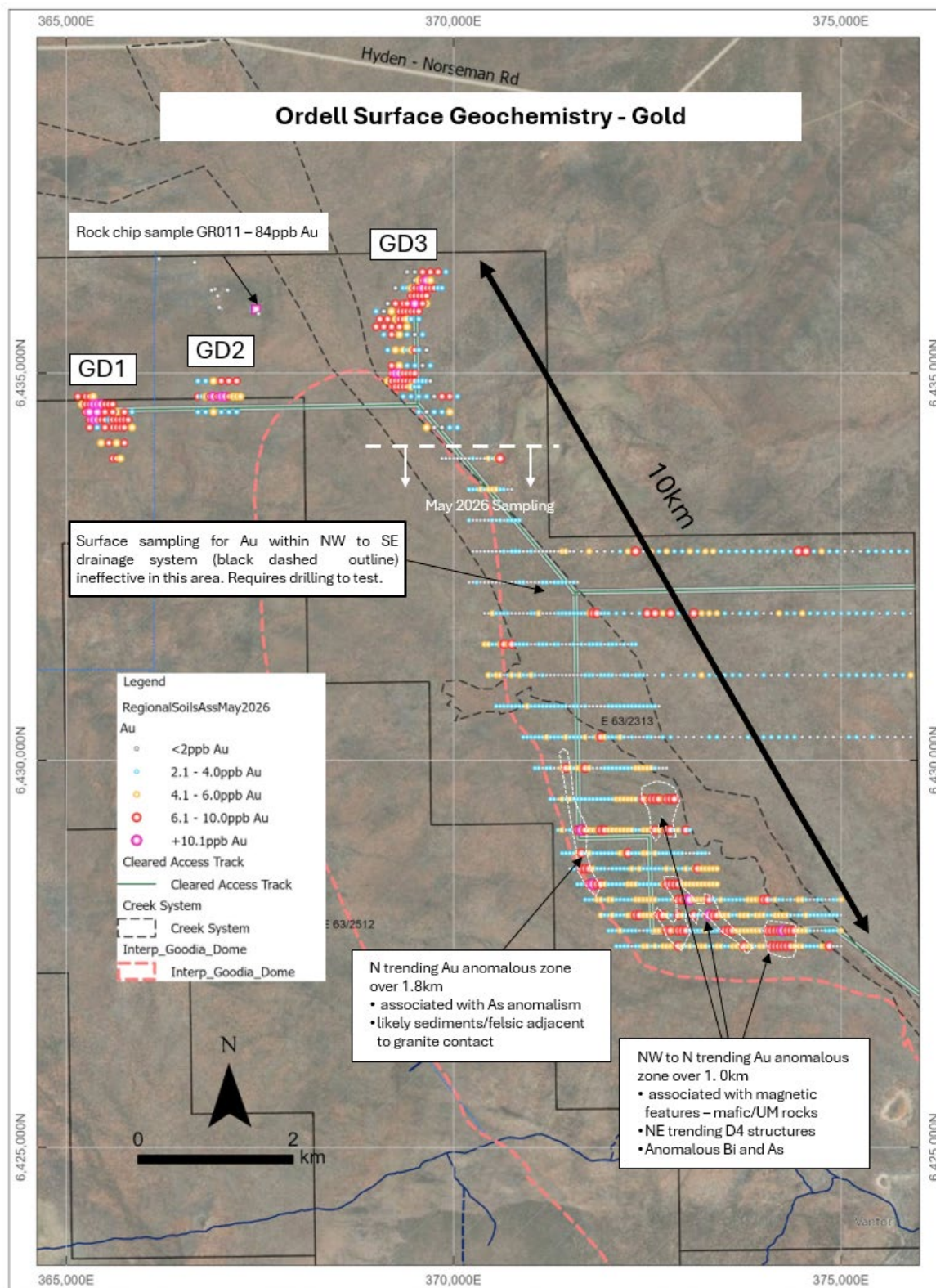


Figure 9. Ordell surface geochemical sample results. Sampling in the drainage channel is interpreted to be ineffective in testing for gold mineralisation within the underlying saprolite/bedrock.

The sample locations and results are shown on Figures 8 and 9.

Proposed work programs in FY27 to be completed at Goodia include:

- First-pass air-core drilling to test the geochemical anomalies generated from soil sampling;
- On going sampling to expand surface geochemical coverage particularly to the south;
- Integration of all historical data into Ordell's Goodia Project geological and GIS databases;
- Evaluation of previous gold, lithium, base metal and nickel exploration work undertaken on E63/2512 and E63/1953; and
- Heritage surveying as required.

Fisher South

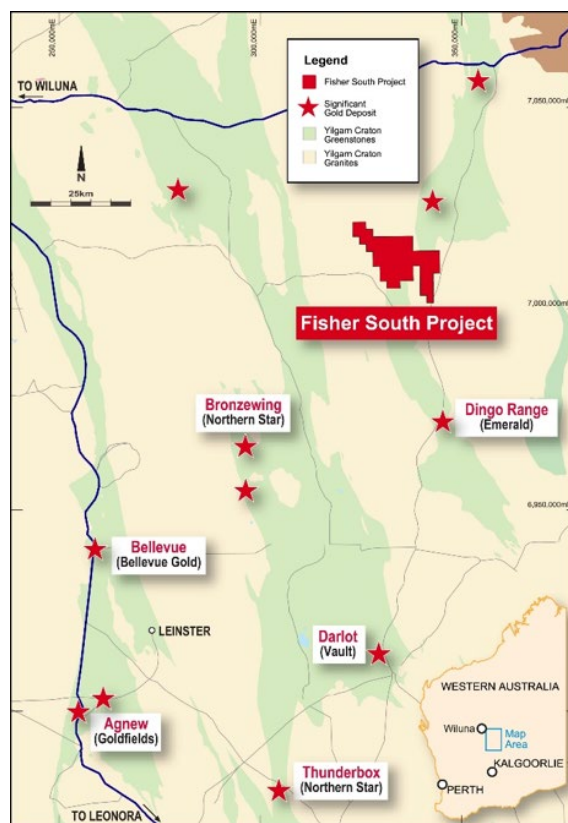


Figure 10. Location of Fisher South Project.

The Fisher South Project is located 400km north of Kalgoorlie in the Laverton district of the northeastern Goldfields (see Figure 10). Fisher South represents an early-stage exploration project, strategically located 40km along strike from Emerald Resources' North Laverton Gold Project.

The Project is highly prospective for gold, nickel and base metal deposits, but has seen only very limited exploration work.

Air-Core Drilling Program

During the year, Ordell completed a 59-hole air core drilling program for 2,717m with drilling completed on a 1,600m x 200m spaced grid.

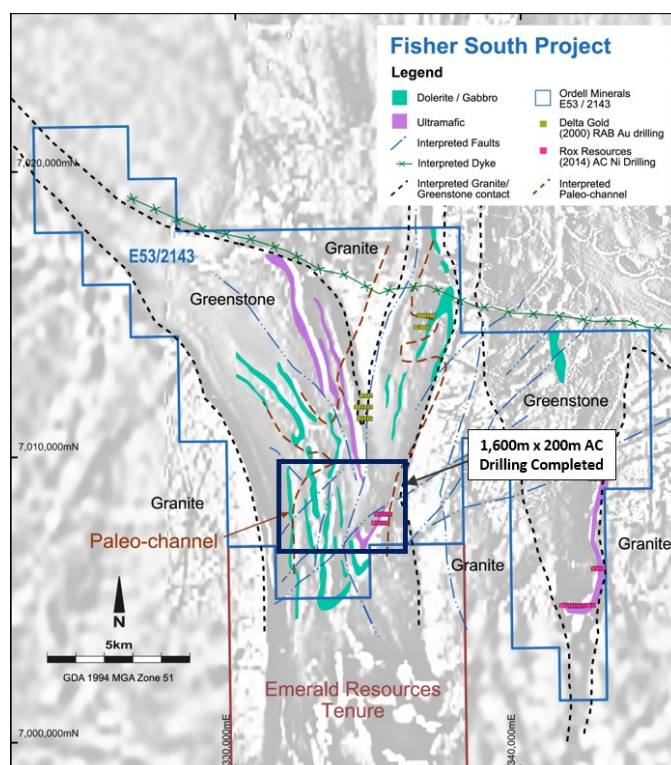


Figure 11. Fisher South Project aircore drilling location on RTP 1VD Magnetics.

The objective of the drilling was to gain knowledge of the stratigraphy and regolith in an area (See Figure 11) which is covered by transported overburden (including lake clays) and has had no systematic testing of the regolith/bedrock.

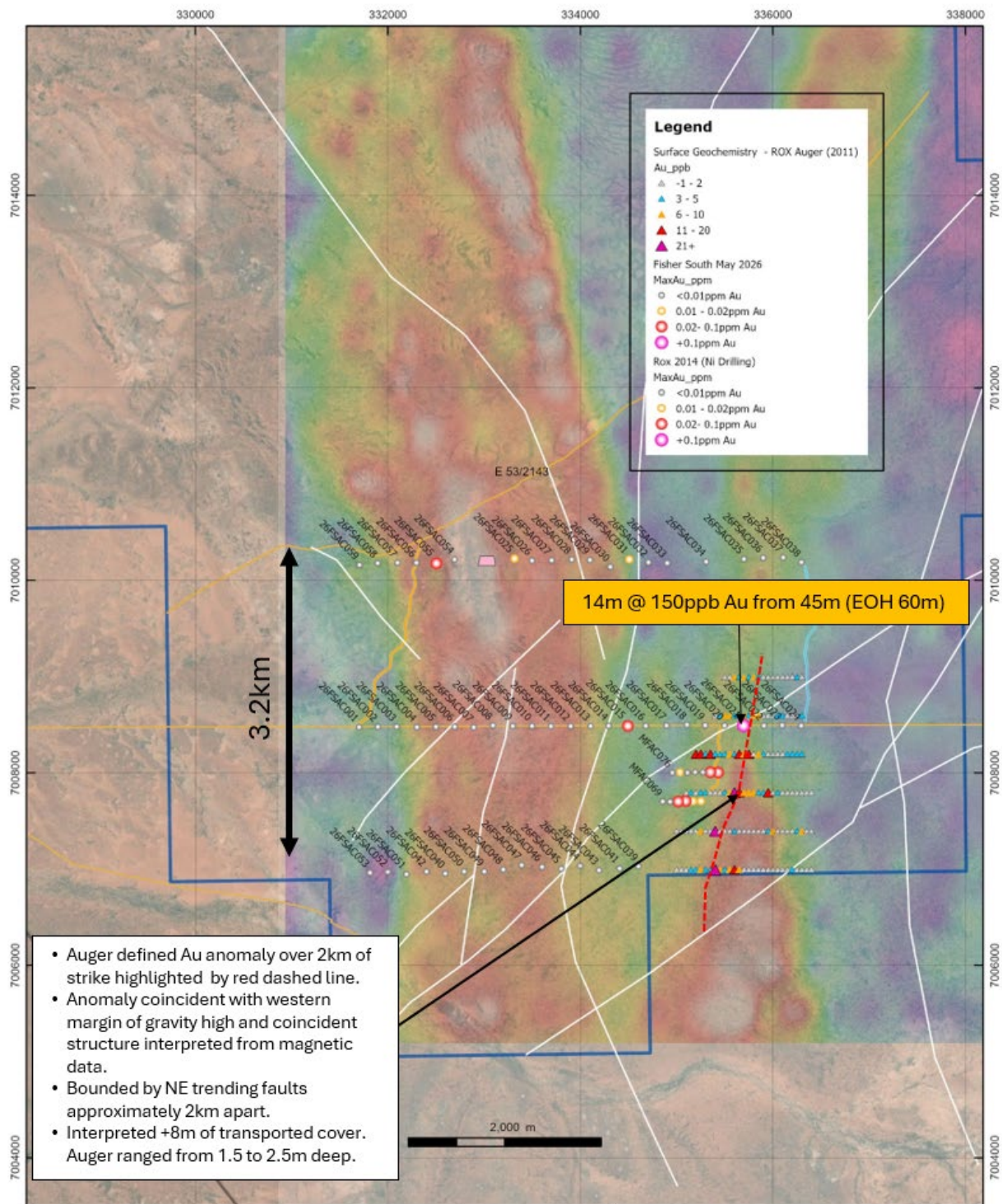


Figure 12. Fisher South aircore hole locations on BG267 1VD Gravity.

Drilling returned a best result of **14m @ 150ppb Au from 45m (EOH 60m) in 26FSAC021**. This result was returned at the northern end of an auger defined (from a previous explorer) gold anomaly which extends for over 1.6km to the south of 26FSAC021 (see Figure 12). This anomaly is interpreted to occur along the western margin of a gravity high and coincident structure interpreted from magnetic data and bounded by two NE trending faults.

Multielement assays returned from 1m bottom-of-hole samples on the western side of the drilled area returned anomalous tungsten in **26FSAC059 (1m @ 1,718ppm W from 36m)** and **26FSAC053 (1m @ 200ppm W from 39m)**.

DIRECTORS' REPORT

Environmental, Social and Governance (ESG)

Underpinning the business model of the Company is a commitment to sustainability through adherence to high standards of Environmental Social Governance (**ESG**). The Company intends to focus on:

- (a) Environment – the Company is committed to safeguarding the environment and managing potential impacts on water, land and air quality.
- (b) Climate Change – the Company recognises that climate change is a shared global challenge that requires collective action between business, government and society. The Company supports the move to a low emission economy to reduce future climate change impacts and avoid increasing their severity.
- (c) Social – strong community relationships are the foundation of our social licence to operate and we aim to make a meaningful contribution to the communities in the regions where our projects are located.
- (d) People - we aim to create an inclusive and supportive workplace, where people are empowered and aligned. Our future success and ability to execute our strategic plan depends on attracting and retaining the right people with the right skills.

Risk Management

The Board is responsible for ensuring that risks, and also opportunities, are identified on a timely basis and that activities are aligned with the risks and opportunities identified by the Board. The Board believes that it is crucial for all Board members to be a part of this process, and as such the Board has not established a separate risk management committee. The Board has a number of mechanisms in place to ensure that management's objectives and activities are aligned with the risks identified by the Board. These include the following:

- Board approval of a strategic plan, which encompasses strategy statements designed to meet stakeholders' needs and manage business risk.
- Implementation of Board approved operating plans and budgets and Board monitoring of progress against these budgets.

Summarised below is a brief outline of some of the key risks that have been identified by the Board.

Exploration and operations

The future exploration activities of the Company may be affected by a range of factors including geological conditions, limitations on activities due to permitting requirements, availability of appropriate exploration equipment, exploration costs, seasonal weather patterns, unanticipated operational and technical difficulties, industrial and environmental accidents and many other factors beyond the control of the Company.

The Company's projects are at early stages of exploration. There can be no assurance that future exploration of these exploration licences, or any other mineral licences that may be acquired in the future, will result in the discovery of an economic resource. Even if an apparently viable resource is identified, there is no guarantee that it can be economically exploited.

Exploration costs

The exploration costs of the Company are based on certain assumptions with respect to the method and timing of exploration. By their nature, these estimates and assumptions are subject to significant uncertainty, and accordingly, the actual costs may materially differ from the estimates and assumptions. Accordingly, no assurance can be given that the cost estimates and the underlying assumptions will be realised in practice, which may materially and adversely impact the Company's viability.

Expenditure requirements on tenements

Pursuant to the licences comprising the Company's projects, the Company is subject to payment and expenditure obligations. In particular, tenement holders are required to expend the funds necessary to meet the minimum work commitments attaching to the tenements. Failure to meet these work commitments may render the tenements subject to forfeiture or result in the tenement holders being liable for penalties or fees. Further, if any contractual obligations are not complied with when due, in addition to any other remedies that may be available to other parties, this could result in dilution or forfeiture of the Company's interest in the projects.

Climate

There are a number of climate-related factors that may affect the operations and proposed activities of the Company. The climate change risks particularly attributable to the Company include:

- (a) the emergence of new or expanded regulations associated with the transitioning to a lower-carbon economy and market changes related to climate change mitigation. The Company may be impacted by changes to local or international compliance regulations related to climate change mitigation efforts, or by specific taxation or penalties for carbon emissions or environmental damage. These examples sit amongst an array of possible restraints on industry that may further impact the Company and its business viability. While the Company will endeavour to manage these risks and limit any consequential impacts, there can be no guarantee that the Company will not be impacted by these occurrences; and
- (b) climate change may cause certain physical and environmental risks that cannot be predicted by the Company, including events such as increased severity of weather patterns and incidence of extreme weather events and longer-term physical risks such as shifting climate patterns. All these risks associated with climate change may significantly change the industry in which the Company operates.

Native title

The Company may be required to negotiate access arrangements and pay compensation to landowners, local authorities, traditional land users and others who may have an interest in the area covered by a mining tenement. Access is required for exploration and development to succeed. The Company's ability to resolve access and compensation issues will have an impact on the future success and financial performance of Ordell's operations.

No Resources or Reserves

The Company's Projects do not currently contain any JORC-compliant Resources or Reserves. Whilst the Company's focus will be to achieve exploration success, there can be no guarantee that its exploration activities will result in the delineation of new Resources or Reserves.

Access to Funding

The Group's ability to successfully develop projects is contingent on the ability to fund those projects from operating cash flows or through affordable debt and equity raisings.

Environmental Regulation and Performance

The Company is subject to significant environmental regulation in respect to its exploration activities. The Company aims to ensure the appropriate standard of environmental care is achieved, and in doing so, that it is aware of and is in compliance with all environmental legislation. The Directors of the Company are not aware of any breach of environmental legislation for the year under review.

The directors have considered the National Greenhouse and Energy Reporting Act 2007 (the NGER Act) which introduced a single national reporting framework for the reporting and dissemination of information about greenhouse gas emissions, greenhouse gas projects, and energy use. At the current stage of development, the directors have determined that the NGER Act will have no effect on the Group for the current, nor subsequent, financial year. The directors will reassess this position as and when the need arises.

Indemnifying Officers or Auditor

During the financial year the Group paid a premium in respect of a contract insuring the Directors and Secretary of the Group against a liability incurred as such to the extent permitted by the Corporations Act 2001. The contract of insurance prohibits disclosure of the nature of the liability and the amount of the premium. The Group has entered into a Deed of Indemnity, Insurance and Access with each Director and Secretary. In Summary the Deed provides for:

- Access to corporate records for each Director for a period after ceasing to hold office in the Group;
- The provision of Directors and Officers Liability Insurance; and
- Indemnity for legal costs incurred by Directors in carrying out the business affairs of the Group.

Except for the above the Group has not otherwise, during or since the financial year, except to the amount permitted by law, indemnified or agreed to indemnify an officer or auditor of the Group or of any related body corporate against a liability incurred as such an officer or auditor.

Proceedings on Behalf of the Company

No person has applied to the Court under section 237 of the *Corporations Act 2001* for leave to bring proceedings on behalf of the Company, or to intervene in any proceedings to which the Company is a party, for the purpose of taking responsibility on behalf of the Company for all or any part of those proceedings.

Non-Audit Services

The Group may decide to employ the auditor on assignments additional to their statutory audit duties where the auditor's expertise and experience with the Group are important.

The Board of Directors has considered the position and is satisfied that the provision of the non-audit services is compatible with the general standard of independence for auditors imposed by the Corporations Act 2001. All remuneration paid to Directors is valued at the cost to the Company and expensed. Options granted to Directors are valued using the Black-Scholes methodology.

Remuneration levels for Non-Executive Directors are set by reference to market rates for comparable companies for time, commitment, and responsibilities. The Board determines payments to the Non-Executive Directors and reviews their remuneration periodically based on market practice, duties and accountability. Independent external advice is sought when required. The maximum aggregate amount of fees that can be paid to Non-Executive Directors is subject to approval by shareholders at the Annual General Meeting (currently \$500,000). To align Directors' interests with shareholder interests, the Directors are encouraged to hold shares in the Company. Non-Executive Directors may be granted options or other equity incentives from time to time to provide a meaningful additional incentive for their ongoing commitment and dedication to the continued growth of the Company and to assist in attracting the highest calibre director, whilst maintaining the Company's cash reserves.

The remuneration policy has been tailored to increase the direct positive relationship between shareholders' investment objectives and KMP's performance. The Company believes this policy will be effective in increasing shareholder wealth. There is no direct link between remuneration paid to Non-Executive Directors and corporate performance.

Use of remuneration consultants

The Company did not employ the services of any remuneration consultants during the financial year ended 30 June 2026.

Voting and comment made at the Group's 2025 Annual General Meeting

NOTE 1: SUMMARY OF MATERIAL ACCOUNTING POLICIES

This note provides a list of the material accounting policies adopted in the preparation of these consolidated financial statements to the extent they have not already been disclosed in the other notes below. These policies have been consistently applied to all the years presented, unless otherwise stated. The consolidated financial statements are for the Group consisting of Ordell Minerals Limited and its subsidiaries.

(a) Reporting Entity

Ordell Minerals Limited ("Ordell" or the "Company") is a company limited by shares, incorporated and domiciled in Australia, whose shares are publicly traded on the Australian Securities Exchange.

A description of the nature of operations and principal activities of Ordell and its subsidiaries (collectively, the "Group") is included in the Directors' Report, which is not part of these financial statements.

(b) Basis of Preparation

Statement of compliance

The consolidated financial statements are general purpose financial statements which have been prepared in accordance with Australian Accounting Standards Board (AASB) and the Corporations Act 2001. The consolidated financial statements comply with International Financial Reporting Standards (IFRS) adopted by the International Accounting Standards Board (IASB).

The financial statements were authorised for issue in accordance with a resolution of the Directors on 7 September 2026.

Historical cost convention

These financial statements have been prepared under the historical cost convention, except for, where applicable, the revaluation of financial assets and liabilities at fair value through profit or loss, financial assets at fair value through other comprehensive income and derivative financial instruments.

Functional and presentation currency

The financial statements are presented in Australian dollars, which is Ordell's functional and presentation currency.

Rounding of Amounts

The Company is of a kind referred to in Corporations Instrument 2016/191, issued by the Australian Securities and Investments Commission, relating to 'rounding-off'. Amounts in this report have been rounded off in accordance with that Corporations Instrument to the nearest dollar.

New and amended accounting standards and policies adopted by the Group

The Group has adopted all the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current period.

Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

Accounting Standards issued but not yet effective

Certain new accounting standards, amendments to accounting standards and interpretations have been published that are not mandatory for 30 June 2026 reporting periods and have not been early adopted by the Group. These standards, amendments or interpretations are not expected to have a material impact on the entity in the current or future reporting periods and on foreseeable future transactions.

Critical accounting estimates

The preparation of these financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the consolidated entity's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements, are disclosed in notes.

(c) Goods and Services Tax ("GST") and other similar taxes

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the tax authority is included in other receivables or other payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the tax authority, are presented as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

(d) Principles of Consolidation

The consolidated financial statements comprise the financial statements of the Group. A list of controlled entities (subsidiaries) at year end is contained in Note 21(a).

The financial statements of subsidiaries are prepared for the same reporting period as the parent company, using consistent accounting policies. Adjustments are made to bring into line any dissimilar accounting policies that may exist.

In preparing the consolidated financial statements, all intercompany balances and transactions, income and expenses and profits and losses resulting from intra-group transactions have been eliminated. Subsidiaries are consolidated from the date on which control is obtained to the date on which control is disposed. The acquisition of subsidiaries is accounted for using the acquisition method of accounting.

Current Tax

Key Estimates and Assumptions

Recognition of benefit from deferred tax losses

The future recoverability of carried forward tax losses are dependent upon the Group's ability to generate taxable profits in the future in the same tax jurisdiction in which the losses arise. This is also subject to determinations and assessments made by taxation authorities. The recognition of a deferred tax asset on carried forward tax losses (in excess of taxable temporary differences) is dependent on management's assessment of these two factors. The ultimate recoupment and the benefit of these tax losses could differ materially from management's assessment.

Potential deferred tax assets attributable to tax losses and exploration expenditure carried forward have not been brought to account at 30 June 2026 because the Directors do not believe it is appropriate to regard realisation of the deferred tax assets as probable at this point in time. These benefits will only be obtained if:

- the Group derives future assessable income of a nature and of an amount sufficient to enable the benefit from the deductions for the loss and exploration expenditure to be realised;
- the Group continues to comply with conditions for deductibility imposed by law; and
- no changes in tax legislation adversely affect the Group in realising the benefit from the deductions for the loss and exploration expenditure.

This involved analysing the tenements in which the Company holds an interest and the exploration programs planned for those tenements; • For each area of interest, we assessed the Consolidated Entity's rights to tenure by corroborating on a sample basis to government registries and evaluating agreements in place with other parties as applicable; • We considered the activities in each area of interest to date and assessed the planned future activities for each area of interest by evaluating budgets for each area of interest; • We tested the exploration expenditure for the year by evaluating a sample of recorded expenditure for consistency to underlying records, the Consolidated Entity's accounting policy and the requirements of AASB 6; • We assessed each area of interest for one or more of the following circumstances that may indicate impairment of the exploration and evaluation asset: • the licenses for the right to explore expiring in the near future or are not expected to be renewed; • substantive expenditure for further exploration in the specific area is neither budgeted or planned; • decision or intent by the Consolidated Entity to discontinue activities in the specific area of interest due to lack of commercially viable quantities of resources; and • data indicating that, although a development in the specific area is likely to proceed, the carrying amount of the exploration asset is unlikely to be recovered in full from successful development or sale. • We assessed the disclosures included in note 12 to the financial statements.
