PROFITABLE FINANCIAL YEAR AND FINAL FY26 DIVIDEND DECLARED

FY26 has been a successful year for Red Hill Minerals Limited (Table 1), and the Board is pleased to declare a final FY26 dividend of 10.8 cents per ordinary share, fully franked.

Highlights for FY26:

- Total income of \$31.56 million, including \$28.8 million in royalty income.
- Profit after tax of \$20.1 million.
- Net cash position \$62.77 million as at 30 June 2026.
- Earnings per share 31.27 cents per share.
- Payment of two fully franked dividends totalling \$11.6 million or 18.1 cents per share during FY2026 as below:
 - FY25 final dividend of 6.5 cents per share fully franked on 10 October 2025.
 - FY26 interim dividend of 11.6 cents per share fully franked on 24 March 2026.

Final FY26 Fully Franked Dividend Declared:

The Board is pleased to declare a final fully franked dividend for FY26 of 10.8 cents per share.

Executive Chairman, Joshua Pitt, said:

"The achievement of nameplate capacity at the Onslow Iron Project generated \$28.8 million in royalty income for FY26. The 22.4 cents per share of dividends for FY26 reflects our policy of paying 50% the \$28.8 million of royalty income during the reporting period. With \$62.77 million in cash at year end and ongoing royalty income, Red Hill is well positioned to continue to pay dividends, to fund its exploration programs and to pursue further royalty acquisitions. During the year we carried out our first drill programs on the exciting Curnamona Project which straddles the SA-NSW border and continued our efforts on our West Pilbara Project. I thank our team for its efforts and our shareholders for their continued support."
