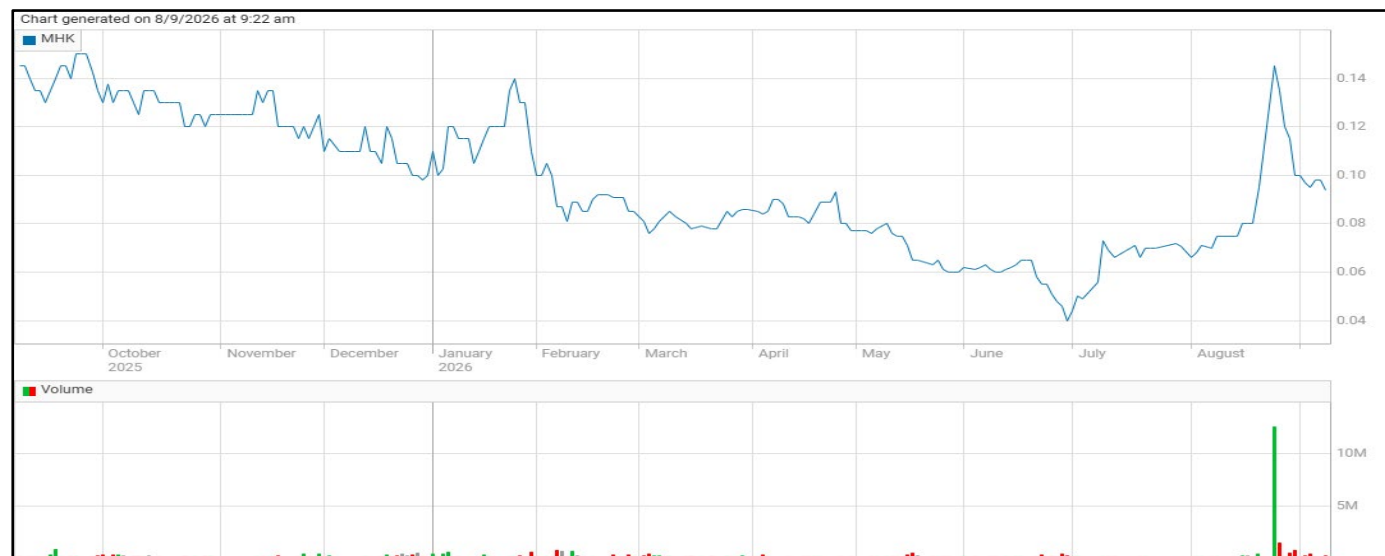

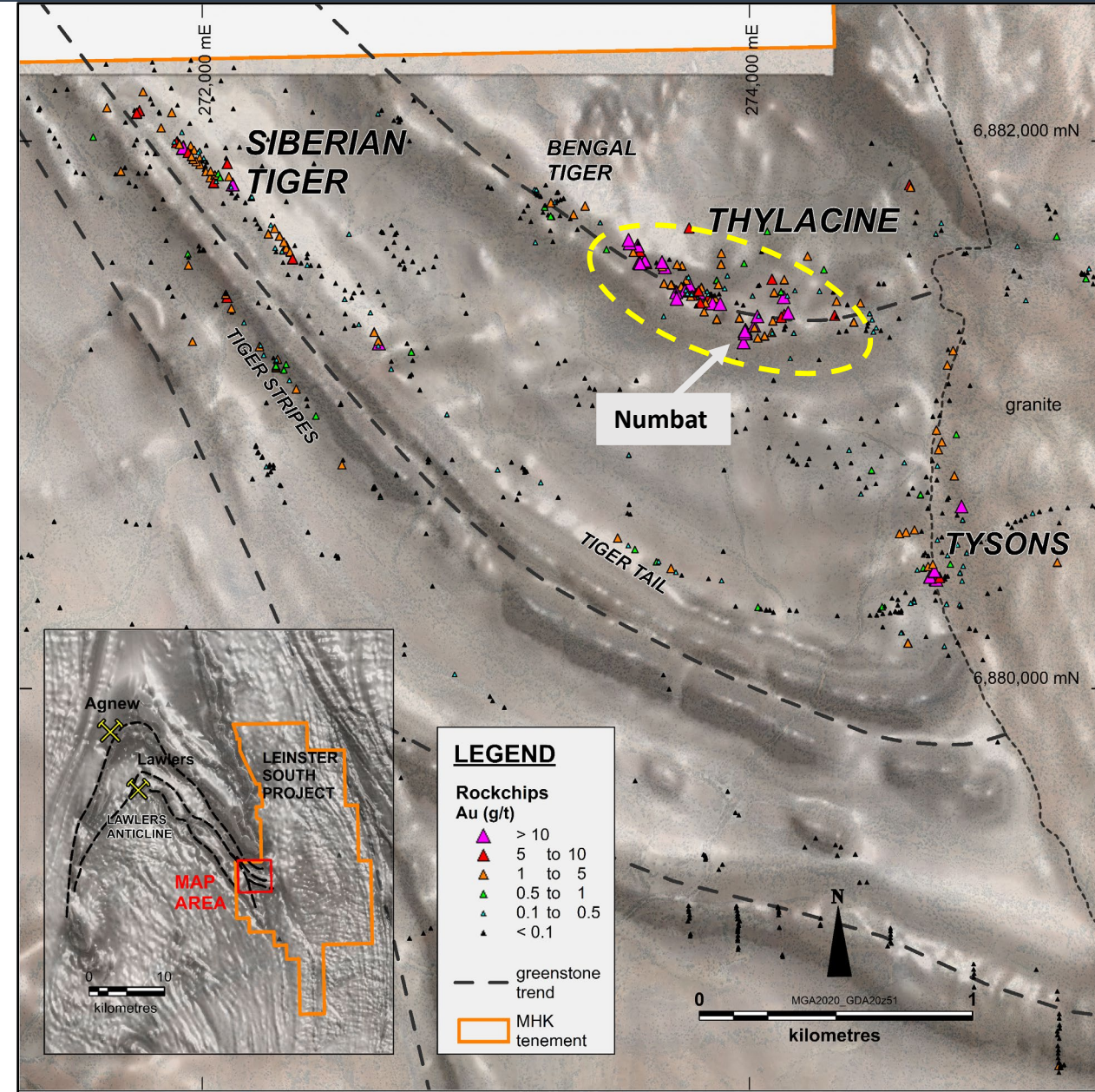

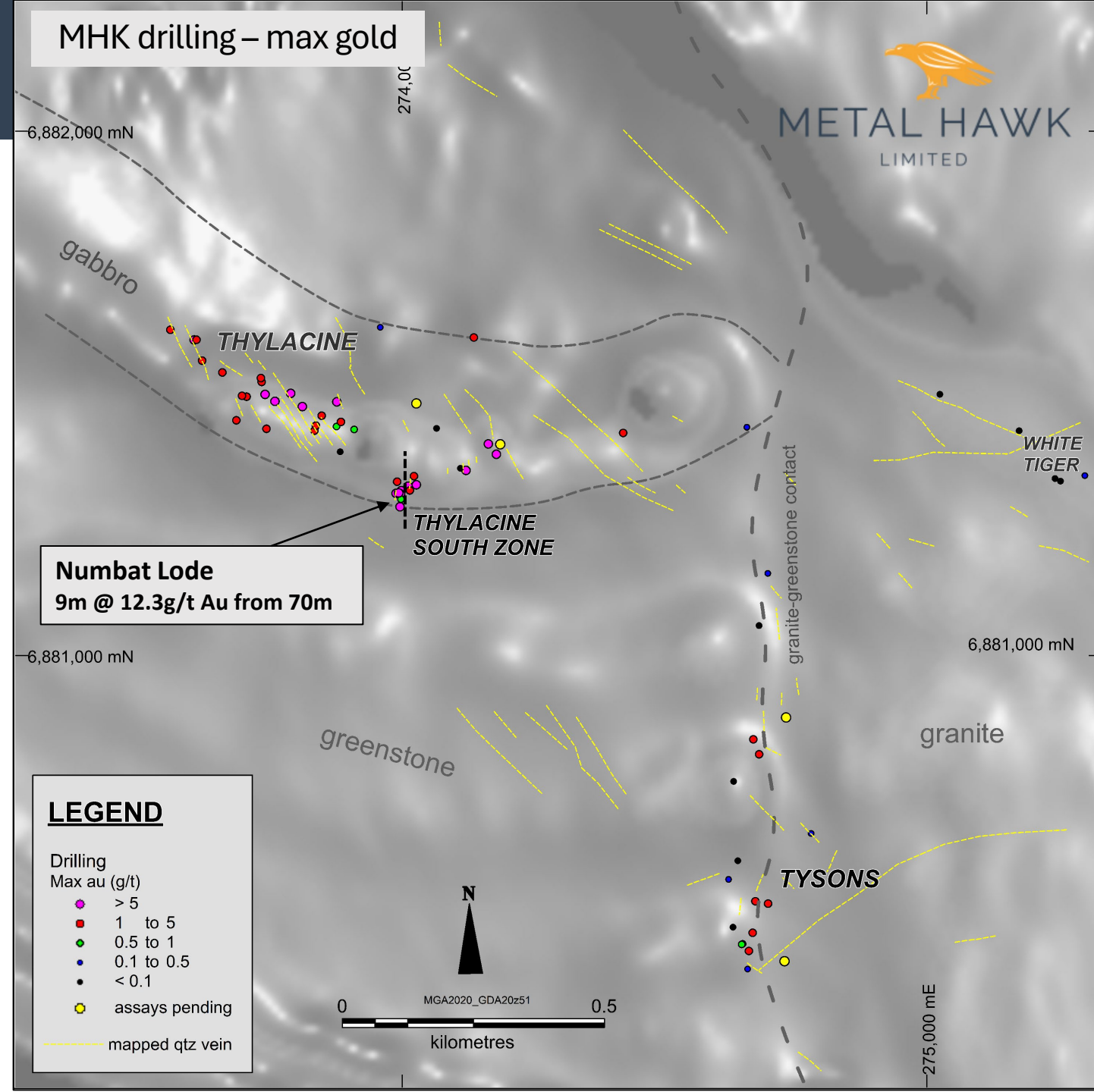
- High-grade gold discovered in 2024 at several prospects with no previous drilling
- Multiple stacked quartz veins within differentiated mafic host rocks at the Thylacine prospect
- Large proportion of rockchips **> 10g/t Au**



THYLACINE PROSPECT

Compelling targets for drilling

- multiple stacked mineralised quartz veins
- mostly NW sub-parallel veins
- **N-S orientation at Numbat**
- differentiated mafic host rocks >300m thick
- high-grade shoots within a broad mineralised envelope
- significant drillhole intersections

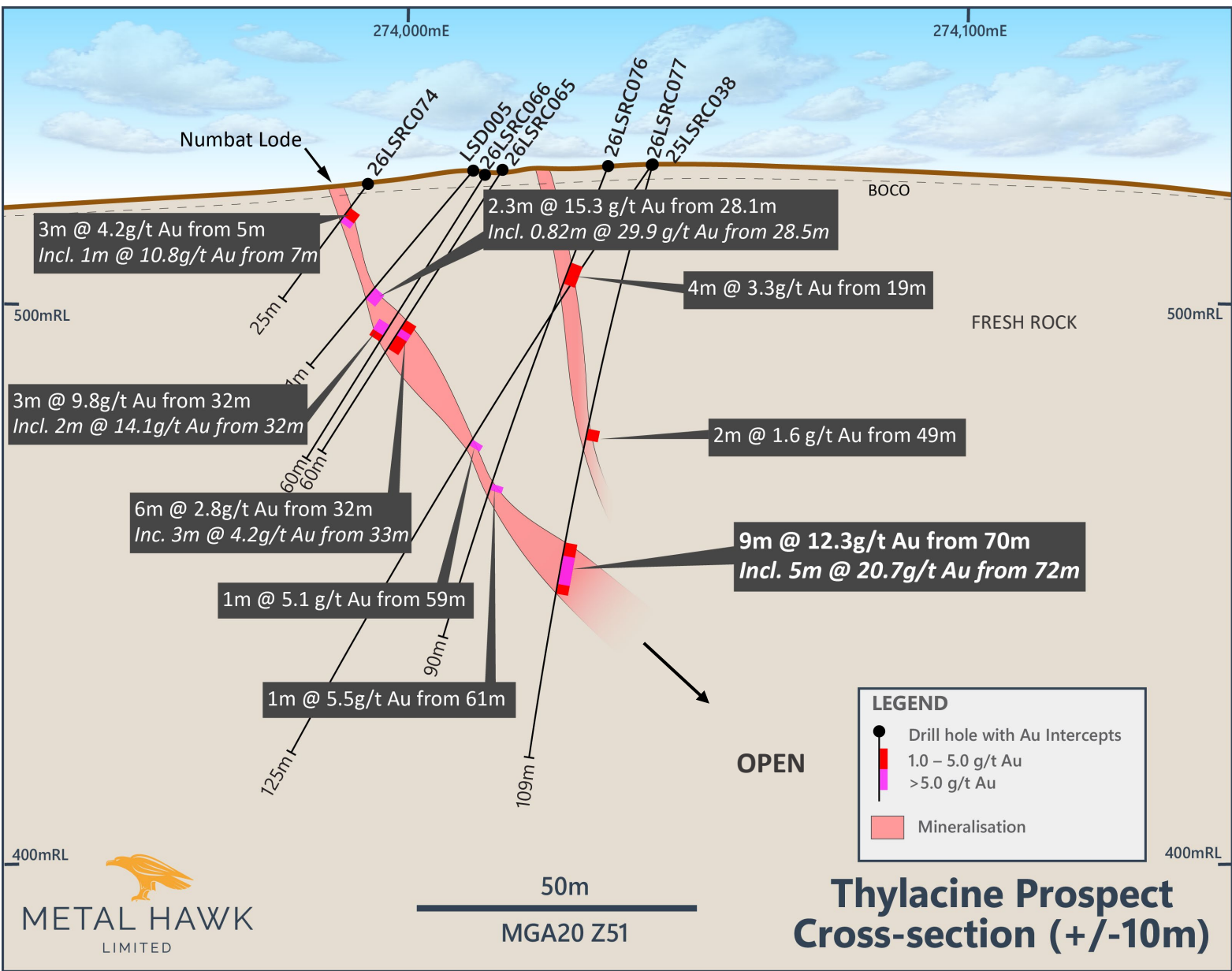


THYLACINE PROSPECT – THE NUMBAT LODGE

New drilling results show grade and thickness

- RC drilling (July 2026) intersects shallow and thick high-grade gold at the Numbat lode

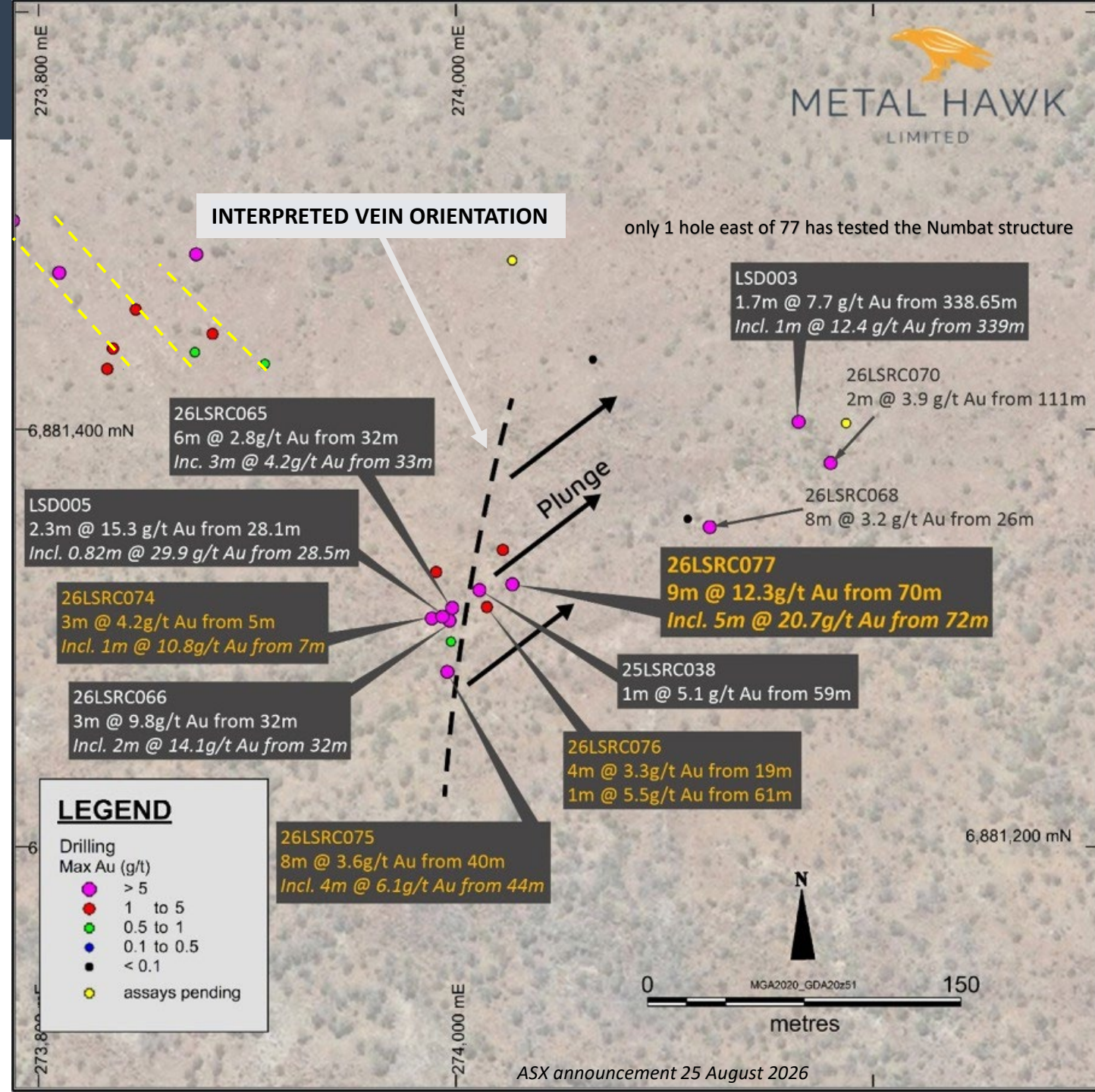

NUMBAT LODGE

Structural interpretation indicates steep NE plunge

- Recent RC drilling confirms new geological model
- Numbat vein N-S, not NW-SE
- High-grade intercept shows quartz lode thickening at depth
- Open at depth and along strike



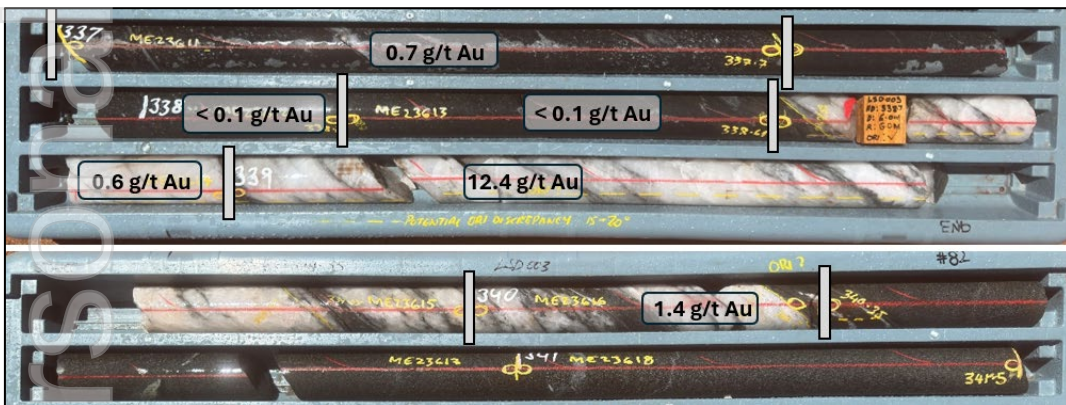
NUMBAT LODGE

Follow-up drilling to confirm scale and continuity

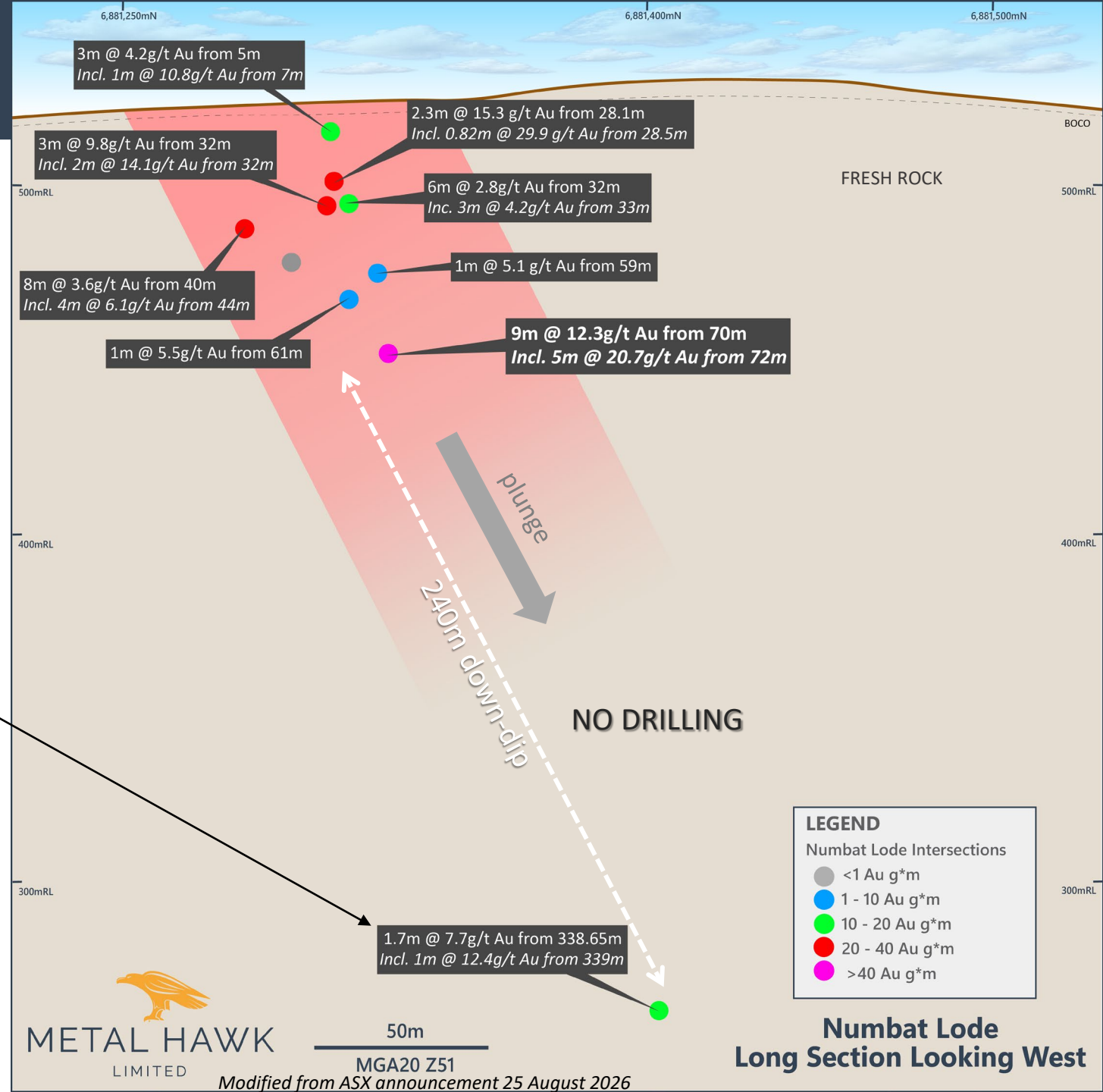
- Evidence for continuation of mineralised structure at depth:
