

COMMENCEMENT OF GOLD DISCOVERY AIRCORE PROGRAM AT NUCKULLA HILL

ASX RELEASE | 11 September 2026

HIGHLIGHTS

- **Gold focussed discovery aircore drilling has commenced at Nuckulla Hill in South Australia**
- **The program is testing a number of new targets along the highly prospective Yarlbrinda Shear Zone, which hosts Barton Gold Holdings Limited's (ASX: BGD) neighbouring 1.6Moz Tunkillia Gold Project¹**
- **The c.3,500m aircore program is expected to take 7 to 10 days, with assays expected mid to late October**
- **RC drilling is scheduled to commence shortly thereafter, undertaking an infill and extensional focussed program at Sheoak, Sheoak East and Bimba**

Auravelle Metals Limited (ASX: AUV) ("Auravelle" or "the Company") is pleased to advise that aircore drilling has commenced at the Nuckulla Hill Gold Project in South Australia.

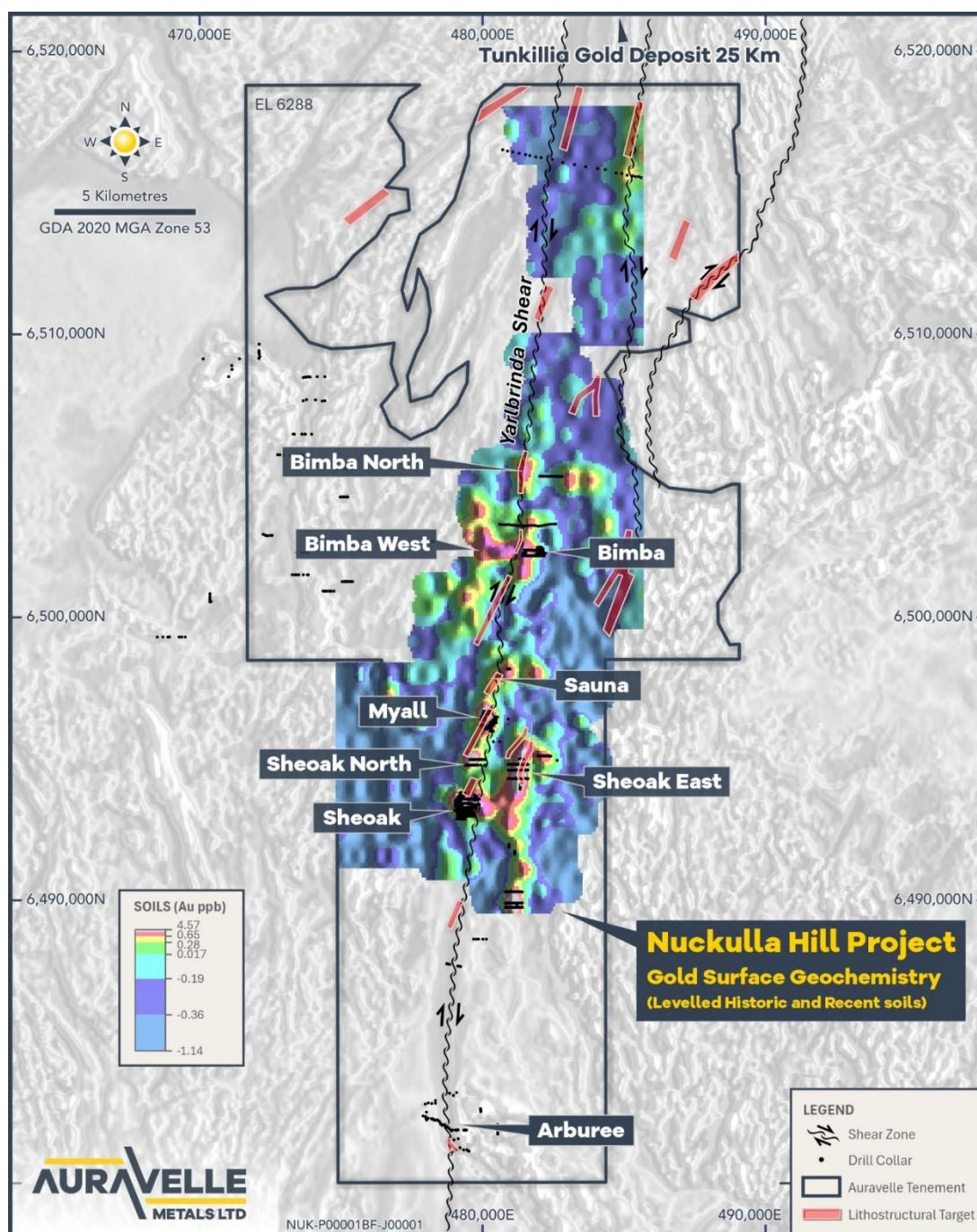


Figure 1: Nuckulla Hill Project showing Gold in Soils with Structural Targets²

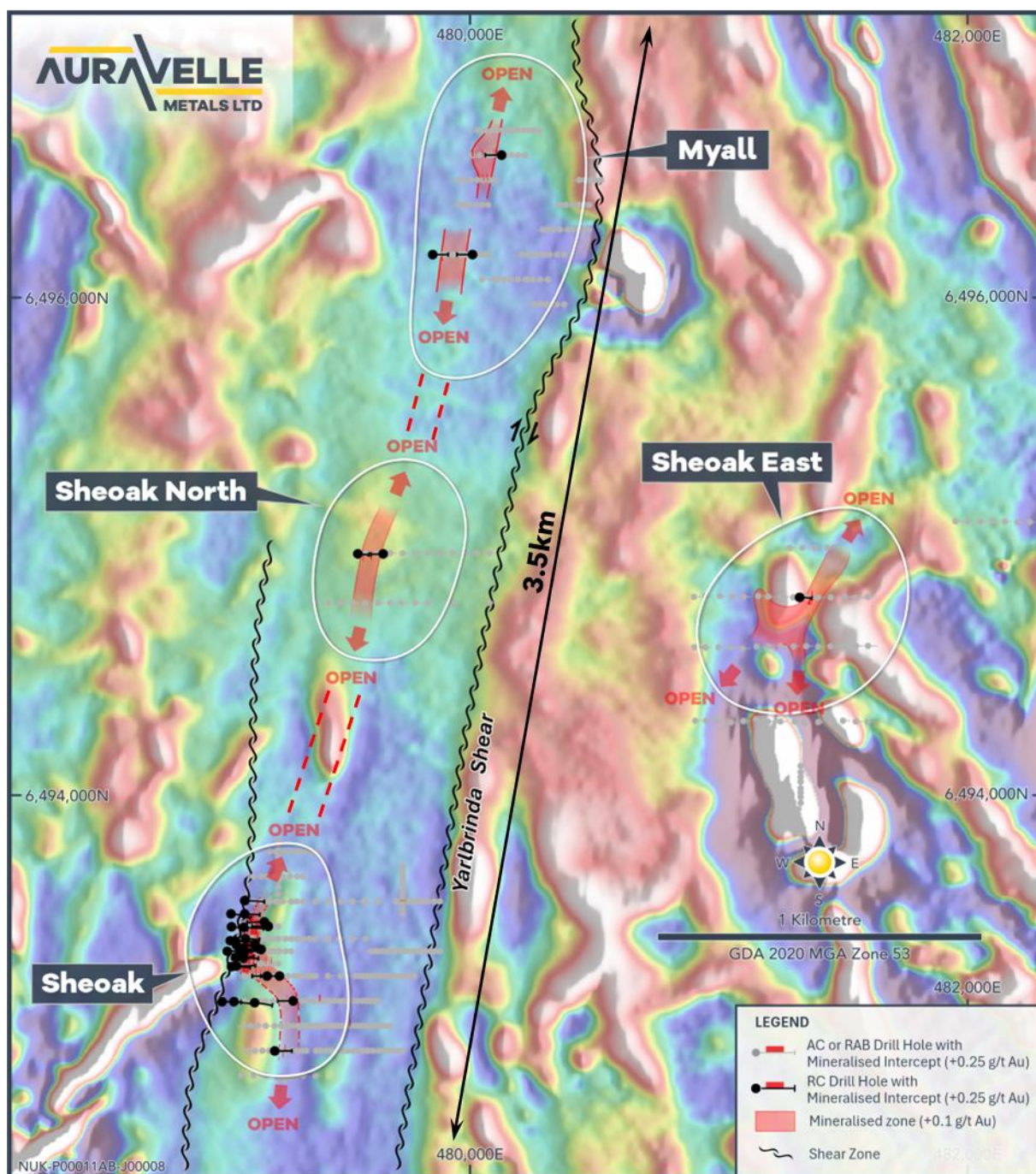


Figure 2: Myall to Sheoak Prospects – Sheoak Anomalous Gold Trend from Drilling over Magnetics³

The discovery-focused aircore drilling program will test five targets along the Yarlbrinda Shear zone within Nuckulla Hill. Targets to be drilled are Sheoak North, Myall, Sauna, Bimba West and Bimba North. All five prospects have coincident gold and silver geochemical anomalism, and are proximal to interpreted lithostructural targets (Figure 1). Furthermore, Sheoak North and Myall are along strike of Sheoak, and within a 3.5km long zone of gold anomalism (Figure 2).

Following the completion of the aircore drilling, Auravelle will undertake RC drilling at Nuckulla Hill to infill and extend Sheoak, as well as test a number of other advanced targets.

Auravelle Managing Director Andrew Muir said:

"We are pleased to commence our next round of drilling at Nuckulla Hill, testing these early-stage targets. Large areas of the Yarlbrinda remain untested or have had little to no follow-up drilling. This program will test some of those areas, which is an exciting opportunity given the prospectivity of the Yarlbrinda and its potential to host large gold deposits."

- Nuckulla Hill: Regional aircore drilling (underway)
- Crown: Results from recent soil sampling (coming weeks)
- Skye: Results from first-pass soil sampling to define drill targets (late September 2026)
- Nuckulla Hill: RC drilling of Sheoak for infill and extension (early October 2026)

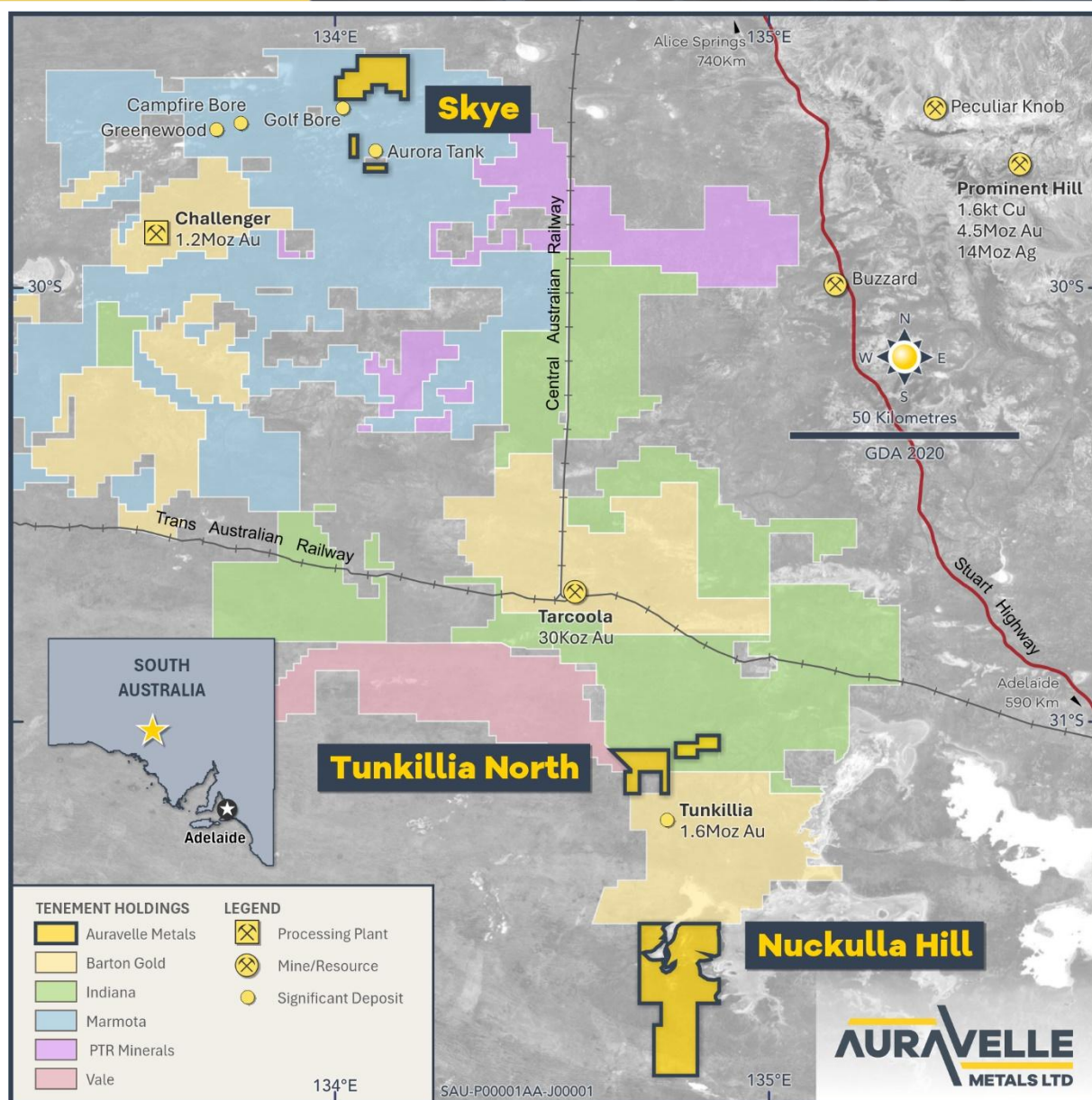


Figure 3: Auravelle's South Australian Projects⁴
