To receive and consider the financial report of the Company for the year ended 30 June 2026, together with the Directors' Report and Auditor's Report as set out in the Annual Report.

2. Resolution 1 – Re-election of Ms Tracey Arlaud

To consider and, if thought fit, to pass with or without amendment, the following Resolution as an **ordinary resolution**:

"That, for the purposes of ASX Listing Rules 14.4 and 14.5, Rule 6.1(f) of the Constitution, and for all other purposes, Ms Tracey Arlaud, who retires from the office of Director at the end of the Meeting, and being eligible, offers herself for re-election, is re-elected as a Director."

3. Resolution 2 – Remuneration Report

To consider and, if thought fit, to pass with or without amendment, the following Resolution as a **non-binding resolution**:

EXPLANATORY STATEMENT

Purpose of this Document

This Explanatory Statement has been prepared to assist Shareholders with their consideration of the Resolutions in the accompanying Notice of Annual General Meeting.

Certain abbreviations and other defined terms are used throughout this Explanatory Statement. Defined terms are generally identifiable by the use of an upper case first letter. Details of the definitions and abbreviations are set out in the Glossary to this Explanatory Statement.

1. Financial Statements

The first item of the Notice deals with the presentation of the consolidated annual financial report of the Company for the financial year ended 30 June 2026, together with the Directors' declaration and report in relation to that financial year and the Auditor's Report on the financial report. Shareholders should consider these documents and raise any matters of interest with the Directors when this item is being considered.

No resolution is required to be moved in respect of this item.

Shareholders will be given a reasonable opportunity at the Meeting to ask questions and make comments on the accounts and on the management of the Company.

The Chair will also give Shareholders a reasonable opportunity to ask the Auditor or the Auditor's representative questions relevant to:

- (a) the conduct of the audit;
- (b) the preparation and content of the independent audit report;
- (c) the accounting policies adopted by the Company in relation to the preparation of the financial statements; and
- (d) the independence of the Auditor in relation to the conduct of the audit.

The Chair will also allow a reasonable opportunity for the Auditor or their representative to answer any written questions submitted to the Auditor under section 250PA of the Corporations Act.

2. Resolution 1 – Re-election of Ms Tracey Arlaud as a Director

2.1 Background

Resolution 1 seeks approval for the re-election of Ms Tracey Arlaud as a Director with effect from the end of the Meeting.

Rule 6.1(f) of the Constitution and Listing Rule 14.4 provide that a Director must not hold office (without re-election) past the third annual general meeting following the Director's appointment or 3 years, whichever is longer.

Further, Rule 6.1(f) of the Constitution provides that at every annual general meeting one third of the Directors for the time being must retire from office and are eligible for re-election. The Directors to retire are to be those who have been longest in office since their appointment or last re-appointment.

Ms Arlaud, being a Director of the Board, retires by way of rotation in accordance with the requirements of Rule 6.1(f) of the Constitution and Listing Rule 14.4 and, being eligible, submits herself for re-election as a Director in accordance with Rule 6.1(f) of the Constitution.

If Resolution 1 is passed, Ms Arlaud will be re-elected and will continue to act as a Director. If Resolution 1 is not passed, Ms Arlaud will not be re-elected and will cease to act as a Director following the Meeting.

2.2 Qualifications and other material directorships

Details concerning Ms Arlaud's qualifications and experience are set out in the Annual Report. Currently, Ms Arlaud is also a director of Global Atomic Corporation (TSX: GLO), Seabridge Gold (TSX: SEA, NYSE:SA) and IGO Limited (ASX: IGO).

Ms Arlaud has confirmed that she considers she will have sufficient time to fulfil her responsibilities as a Director of the Company and does not consider that any other commitment will interfere with her availability to perform her duties as a Director of the Company.

2.3 Independence

The Board considers that Ms Arlaud, if re-elected, will continue to be classified as an independent Director.

2.4 Directors' Recommendation

The Directors (in the absence of Ms Arlaud) recommend that Shareholders vote in favour of Resolution 1 to re-

elect Ms Arlaud as a Director.

3. Resolution 2 – Remuneration Report

3.1 Background

Included within the Annual Report is a Remuneration Report that sets out the details of the remuneration of all Directors and senior executives. In addition, it explains the Board policies in relation to the nature and level of remuneration paid to Directors, sets out remuneration details for each Director and any service agreements and sets out the details of any equity based compensation.

In accordance with section 250R(2) of the Corporations Act, the Board submits the Remuneration Report to Shareholders for their consideration and adoption by way of a non-binding resolution.

The vote on this Resolution 2 is advisory only and does not bind the Directors or the Company. Therefore, if Resolution 2 is not passed, the Directors will not be required to alter any of the arrangements in the Remuneration Report.

Under the Corporations Act, if 25% or more of votes that are cast are voted against the adoption of the Remuneration Report at two consecutive annual general meetings, the Company will be required to put a resolution to the second annual general meeting (a "spill resolution") to approve calling a general meeting (a "spill meeting"). If more than 50% of Shareholders vote in favour of the spill resolution, the Company must then convene a spill meeting within 90 days of the second annual general meeting. All of the Directors who were in office when the applicable Directors' Report was approved, other than the Managing Director, will need to stand for re-election at the spill meeting if they wish to continue as Directors.

The Company notes that its remuneration report for the financial year ended 30 June 2025 did not receive a vote of more than 25% against its adoption at the Company's last annual general meeting held on 16 October 2025. Accordingly, even if at least 25% of the votes cast on this Resolution are against adoption of the Remuneration Report, it will not result in the Company putting a spill resolution to Shareholders.

The Chair will give Shareholders a reasonable opportunity to ask questions about, or make comments on, the Remuneration Report.

3.2 Voting

As set out in the Notice, a voting restriction applies to this Resolution 2.

Shareholders are urged to carefully read the Proxy Form and provide a direction to the proxy on how to vote on this Resolution.

4. Resolution 3 – Issue of LTI Performance Rights to Mr Paul House

4.1 Background

Pursuant to Resolution 3, the Company is seeking Shareholder approval for the grant of up to 438,984 LTI Performance Rights under the ERP to Mr Paul House, the Managing Director and CEO of the Company, for no cash consideration.

The purpose of the grant of LTI Performance Rights is to provide Mr House, as the Managing Director and CEO, with a long term incentive to participate in Imdex's growth that is directly aligned with the creation of shareholder value. The Directors consider (in the absence of Mr House) that the incentives intended for Mr House represented by the grant of these LTI Performance Rights are a cost effective and efficient means for the Company to provide a reward and an incentive, as opposed to alternative forms of payment, such as the payment of additional cash consideration.

An LTI Performance Right entitles the holder to receive one Share in the Company for no cash consideration provided that specified performance criteria (as summarised in Annexure B to this Explanatory Statement) are met.

The number of LTI Performance Rights to be granted to Mr House has been determined based upon a consideration of:

- (a) Mr House's remuneration, and the Directors' (excluding Mr House) wish to ensure that the remuneration offered is competitive with market standards and practice;
- (b) the extensive experience and reputation of Mr House within the resources industry;
- (c) the current price of Shares; and
- (d) the Directors' (excluding Mr House) assessment that the issue of LTI Performance Rights upon the terms proposed will assist to incentivise and ensure continuity of service of Mr House, while maintaining the

Company's cash reserves, and will not impose any significant opportunity costs on the Company or cause the Company to forego any significant benefits.

4.2 Related party transactions generally

Chapter 2E of the Corporations Act prohibits a public company from giving a financial benefit to a related party of the public company unless the giving of the financial benefit has been approved by shareholders and the benefit is given within 15 months after obtaining such approval, or the giving of the financial benefit falls within an exception set out in Chapter 2E. For the purposes of Chapter 2E of the Corporations Act, Mr House is a related party of the Company.

In relation to this Resolution, the Board (in the absence of Mr House) has formed the view that Shareholder approval pursuant to Chapter 2E of the Corporations Act is not required in relation to the proposed issue of LTI Performance Rights to Mr House as the issue, which forms part of the remuneration package for Mr House, is considered reasonable remuneration for the purposes of section 211 of the Corporations Act.

4.3 Total FY27 remuneration package

Mr House's annual salary (excluding superannuation) and the total financial benefit to be received by him in FY27, including as a result of the grant of the LTI Performance Rights the subject of Resolution 3, are as follows:

Note:

- Mr House currently receives a base annual salary of \$1,050,000 (excluding superannuation) for his role as CEO. Mr House was appointed as Managing Director with effect from 1 March 2024 but does not currently receive any fees for his role as a Director.*
- This is an approximate maximum value at \$4.126 per LTI Performance Right, which represents the volume-weighted average price of the Company's Shares traded on ASX during the five trading days immediately preceding 1 July 2026 (being the commencement of the performance period for the LTI Performance Rights).*
- Inclusive of superannuation.*

4.4 Directors' recommendation

The Directors (in the absence of Mr House) recommend that Shareholders vote in favour of Resolution 3. Mr House declines to make a recommendation about the Resolution as he may have a material personal interest in the outcome of this particular Resolution as it relates to the proposed grant of LTI Performance Rights to him. The Board (in the absence of Mr House) is not aware of any other information that would reasonably be required by Shareholders to allow them to make a decision whether it is in the best interests of the Company to pass the Resolution.

4.5 Information requirements – ASX Listing Rules 10.14 and 10.15

ASX Listing Rule 10.14 provides that the Company must not permit any of the following persons to acquire Equity Securities under an employee incentive scheme:

- a Director of the Company (Listing Rule 10.14.1);
- an Associate of a Director of the Company (Listing Rule 10.14.2); or
- a person whose relationship with the Company or a person referred to in Listing Rule 10.14.1 or 10.14.2 is such that, in ASX's opinion, the acquisition should be approved by its Shareholders (Listing Rule 10.14.3), unless it obtains the approval of its Shareholders.

The proposed grant of LTI Performance Rights to Mr House pursuant to Resolution 3 falls within Listing Rule 10.14.1 and therefore requires the approval of Shareholders under ASX Listing Rule 10.14.

If this Resolution is passed, the Company will grant up to a total of 438,984 LTI Performance Rights to Mr House, as noted above.

If this Resolution is not passed, the Company will not grant up to a total of 438,984 LTI Performance Rights to Mr House and the Company may need to consider alternative ways to remunerate Mr House, including by the payment of cash.

The following further information is provided to Shareholders for the purposes of ASX Listing Rule 10.15:

- the LTI Performance Rights will be granted to Mr House, as noted above;

- (b) Mr House is a Listing Rule 10.14.1 party by reason of being a Director of the Company;
- (c) up to 438,984 LTI Performance Rights will be granted to Mr House;
- (d) Mr House is a Director of the Company, and the issue of LTI Performance Rights the subject of this Resolution is intended to remunerate Mr House, whose current total remuneration package is set out above;
- (e) a total of 932,373 Equity Securities (all such Equity Securities being LTI Performance Rights) have been issued to Mr House for nil cash consideration pursuant to the ERP, as approved by Shareholders at Imdex's 2024 annual general meeting;
- (f) a summary of the terms and conditions of the LTI Performance Rights are set out in Annexure B to this Explanatory Statement;
- (g) the Company has selected to issue LTI Performance Rights to Mr House because it considers that doing so is a cost effective and efficient means for the Company to provide a reward and an incentive to Mr House to deliver on specified performance outcomes;
- (h) as noted above, the Company has valued the LTI Performance Rights at \$4.126 each, which represents the volume-weighted average price of the Company's Shares traded on ASX during the five trading days immediately preceding 1 July 2026 (being the commencement of the performance period for the LTI Performance Rights);
- (i) the LTI Performance Rights will be granted on a date which will be no later than 3 years after the date of this Meeting, unless otherwise extended by way of ASX granting a waiver to the Listing Rules;
- (j) the LTI Performance Rights will be granted for no cash consideration;
- (k) a summary of the material terms of the ERP under which the LTI Performance Rights have been offered is set out in Annexure A to this Explanatory Statement;
- (l) details of any LTI Performance Rights issued under the ERP will be published in each annual report of the Company relating to the period in which the LTI Performance Rights were issued and, where applicable, it will be noted that approval for the issue of the LTI Performance Rights was obtained under ASX Listing Rule 10.14;
- (m) any additional persons covered by ASX Listing Rule 10.14 who become entitled to participate in the issue of Awards under the ERP after this Resolution is approved and who are not named in this Notice will not participate until approval is obtained under ASX Listing Rule 10.14; and
- (n) no loan will be provided to Mr House by the Company in connection with the issue of the LTI Performance Rights.

4.6 Voting

As set out in the Notice, a voting exclusion and a voting restriction apply to this Resolution.

Shareholders are urged to carefully read the Proxy Form and provide a direction to the proxy on how to vote on the Resolution.

5. Resolution 4 - Potential termination benefits to Mr Paul House in relation to LTI Performance Rights

5.1 Background

Subject to the passing of Resolution 3, up to 438,984 LTI Performance Rights are proposed to be granted to Mr Paul House. A summary of the material terms of LTI Performance Rights is set out in Annexure B to this Explanatory Statement, and a summary of the material terms of the ERP pursuant to which those LTI Performance Rights are offered is set out in Annexure A to this Explanatory Statement.

The terms of the LTI Performance Rights and the ERP pursuant to which they are offered include potential termination benefits which may become payable to Mr House in connection with Mr House ceasing employment with the Company, or his appointment as a Director of the Company. This Resolution 4 seeks Shareholder approval for the giving of those potential termination benefits for all purposes of Part 2D.2 of the Corporations Act as set out in this Explanatory Statement.

If Resolution 3 is not passed, then this Resolution will have no effect.

5.2 Potential termination benefits payable

The terms of the LTI Performance Rights (and the ERP pursuant to which they are offered) allow for the Board to exercise discretion in the following circumstances:

- (a) where Mr House ceases employment and is classified as a 'Good Leaver', discretion to determine that a

number of unvested LTI Performance Rights may remain on foot in accordance with the Company's Good Leaver policy (being a pro-rata basis (based on time elapsed) under the terms of the ERP); and

- (b) where Mr House ceases employment in other circumstances, general discretion to deal with the unvested LTI Performance Rights.

The benefits noted above are in addition to statutory entitlements, any payment in lieu of notice and accrued contractual entitlements, comprised of any outstanding remuneration and any accrued leave entitlements as at the date of termination.

5.3 Sections 200B and 200E of the Corporations Act

Part 2D.2 of the Corporations Act restricts the benefits that can be given to persons who hold a "managerial or executive office" (as defined in the Corporations Act), or persons who have in the 3 years before their termination held a managerial or executive office, on leaving their employment with the Company or ceasing to be appointed as a director of the Company or any of its related bodies corporate, unless an exception applies.

Section 200B of the Corporations Act applies to managerial or executive officers of the Company or any of its subsidiaries, which will include Mr House.

Under section 200B of the Corporations Act, a company may only give a person a benefit in connection with their ceasing to hold a managerial or executive office in the company or a related body corporate if it is approved by shareholders under section 200E of the Corporations Act or another exemption applies.

The term "benefit" has a wide operation and would include the exercise of Board discretion in the circumstances noted above upon termination or cessation of employment in accordance with their terms (including the terms of the employee incentive scheme under which they are offered).

Accordingly, Shareholder approval is sought for the purposes of section 200E of the Corporations Act to allow the Company to deal with the LTI Performance Rights upon termination or cessation of Mr House's employment or appointment as a Director in accordance with the terms and conditions of the LTI Performance Rights (and the ERP pursuant to which they are offered), where to do so would involve giving a "benefit" to Mr House in connection with Mr House ceasing to hold a managerial or executive office.

The approval is sought in relation to the LTI Performance Rights proposed to be granted to Mr House under Resolution 3.

The value of any benefit relating to the LTI Performance Rights given in connection with Mr House ceasing to hold managerial or executive office cannot presently be ascertained. However, matters, events and circumstances that will, or are likely to, affect the calculation of that value are:

- (a) the number of LTI Performance Rights held by Mr House prior to termination or cessation of his employment;
- (b) Mr House's length of service and the status of the vesting conditions attaching to the LTI Performance Rights at the time his employment or office ceases;
- (c) whether the vesting conditions are waived or (if not waived) met, and the number of LTI Performance Rights (which could be a portion of or all of the LTI Performance Rights held by Mr House); and
- (d) the market price of the Company's Shares on ASX on the date Shares are issued to Mr House upon exercise of the LTI Performance Rights.

5.4 Consequences of passing the Resolution

If Resolution 4 is passed, the Company will be able to give termination benefits to Mr House in connection with Mr House ceasing to hold his managerial or executive office in accordance with the rules of the LTI Performance Rights (and the ERP pursuant to which they are offered).

If Resolution 4 is not passed, the Company will not be able to give termination benefits to Mr House unless the Company obtains future Shareholder approval under section 200E of the Corporations Act for the giving of the particular termination benefit or another exemption to the restriction in section 200B of the Corporations Act applies.

The Chair intends to vote all available proxies in favour of this Resolution.

5.5 Directors' Recommendation

The Board (in the absence of Mr House) recommends that Shareholders vote in favour of Resolution 4.

5.6 Voting

As set out in the Notice, a voting exclusion and a voting restriction apply to this Resolution.

Shareholders are urged to carefully read the Proxy Form and provide a direction to the proxy on how to vote on

the Resolution.

6. Resolution 5 – Issue of Deferred STI Performance Rights to Mr Paul House

6.1 Background

The Company operates an annual short-term incentive (STI) program that is available to the Company's Executives subject to the attainment of clearly defined Company and individual financial and non-financial measures.

Actual STI payments awarded to each Executive depend on the extent to which performance criteria set at the beginning of the financial year are met. Half of any STI award is paid in cash and half is delivered as deferred Performance Rights which may vest on 1 July the following year subject to the Executive's continued employment.

The Company's Executive group includes Managing Director and Chief Executive Officer, Mr Paul House.

As set out in the Company's Annual Report, Mr House is eligible to receive 116% of the maximum STI offered for the financial year ended 30 June 2026. Half of this will be paid in cash, and half will be awarded in deferred Performance Rights. The award of up to 103,320 Deferred STI Performance Rights to Mr House in satisfaction of the deferred component of his FY26 STI award is subject to Shareholder approval.

6.2 ASX Listing Rules 10.11

Listing Rule 10.11 provides that unless one of the exceptions in Listing Rule 10.12 applies, the Company must not issue or agree to issue equity securities to:

- (a) a related party (Listing Rule 10.11.1);
- (b) a person who is, or was at any time in the 6 months before the issue or agreement, a substantial (30%+) holder in the Company (Listing Rule 10.11.2);
- (c) a person who is, or was at any time in the 6 months before the issue or agreement, a substantial (10%+) holder in the Company and who has nominated a Director to the Board pursuant to a relevant agreement which gives them a right or expectation to do so (Listing Rule 10.11.3);
- (d) an associate of a person referred to in Listing Rules 10.11.1 to 10.11.3 (Listing Rule 10.11.4); or
- (e) a person whose relationship with the Company or a person referred to in Listing Rules 10.11.1 to 10.11.4 is such that, in ASX's opinion, the issue or agreement should be approved by Shareholders (Listing Rule 10.11.5),

unless it obtains the approval of its Shareholders.

The proposed issue of Deferred STI Performance Rights to Mr House falls within Listing Rule 10.11.1 and does not fall within any of the exceptions in Listing Rule 10.12. It therefore requires the approval of Shareholders under Listing Rule 10.11.

6.3 Related Party Transactions Generally

Chapter 2E of the Corporations Act prohibits a public company from giving a financial benefit to a related party of the public company unless either:

- (a) the giving of the financial benefits falls within one of the nominated exceptions to the provision; or
- (b) Shareholder approval is obtained prior to the giving of the financial benefit and the benefit is given within 15 months after obtaining such approval.

For the purposes of Chapter 2E of the Corporations Act, Mr House is a related party of the Company. This Resolution relates to the proposed issue of Deferred STI Performance Rights to Mr House, which is a financial benefit that requires Shareholder approval for the purposes of section 208 of the Corporations Act.

Under section 208 of the Corporations Act, for a public company, or an entity that the public company controls, to give a financial benefit to a related party of the public company, the public company or entity must:

- (a) obtain the approval of the public company's members; and
- (b) give the benefit within 15 months following such approval,

unless the giving of the financial benefit falls within an exception set out in sections 210 to 216 of the Corporations Act.

Shareholder approval is not being sought for the purposes of section 208 of the Corporations Act on the basis that the benefit is considered by the Board (in the absence of Mr House) to constitute reasonable remuneration and, therefore, the exception in section 211 of the Corporations Act applies. Section 211 provides that Shareholder approval is not required for the purposes of section 208 in circumstances where the benefit constitutes remuneration which would be reasonable given the Company's and the related party's circumstances.

Having considered the Company's circumstances, Mr House's position with the Company and the Company's STI program which applies to all of its Executives, the Board considers that the financial benefit conferred by the issue of Deferred STI Performance Rights to Mr House is reasonable in the circumstances and therefore the exception in section 211 applies.

6.4 Directors' recommendation

The Directors (in the absence of Mr House) recommend that Shareholders vote in favour of this Resolution.

Mr House declines to make a recommendation about this Resolution as he may have a material personal interest in the outcome of the Resolution.

The Directors (in the absence of Mr House) are not aware of any other information that would reasonably be required by the Shareholders to allow them to make a decision whether it is in the best interests of the Company to pass this Resolution.

6.5 Information Requirements - Listing Rules 10.11 and 10.13

This Resolution seeks Shareholder approval for the purposes of Listing Rule 10.11 and for all other purposes to allow the Company to issue up to 103,320 Deferred STI Performance Rights to Mr House.

If this Resolution is passed, the Company will be able to proceed with the issue of Deferred STI Performance Rights to Mr House in satisfaction of the deferred component of Mr House's FY26 STI award.

If this Resolution is not passed, the Company will not be able to proceed with the issue of Deferred STI Performance Rights to Mr House and will instead make a cash payment of \$426,298.32 to Mr House in satisfaction of the 50% deferred component of his FY26 STI award. This cash payment will not carry the same condition of continued employment by Mr House that the Deferred STI Performance Rights will.

The following further information is provided to Shareholders for the purposes of Listing Rule 10.13:

- (a) the Deferred STI Performance Rights will be issued to Mr House as noted above;
- (b) Mr House is a Director, and therefore a Listing Rule 10.11.1 party;
- (c) up to 103,320 Deferred STI Performance Rights will be issued to Mr House;
- (d) the terms and conditions of the Deferred STI Performance Rights are set out in Annexure C to this Explanatory Statement;
- (e) the Deferred STI Performance Rights will be issued on a date which will be no later than 1 month after the date of this Meeting, unless otherwise extended by way of ASX granting a waiver to the Listing Rules;
- (f) the Deferred STI Performance Rights will be issued for no cash consideration, in satisfaction of the 50% deferred component of Mr House's FY26 STI award; and
- (g) Mr House is a Director of the Company and, as such, is a related party of the Company, and the issue the subject of this Resolution is intended to remunerate or incentivise Mr House, whose current total remuneration package is set out in section 4.3 above.

If approval is given for the grant of the Deferred STI Performance Rights under Listing Rule 10.11, approval is not required under Listing Rule 7.1.

6.6 Voting

As set out in the Notice, a voting exclusion and a voting restriction apply to this Resolution.

Shareholders are urged to carefully read the Proxy Form and provide a direction to the proxy on how to vote on the Resolution.

7. Resolution 6 – Appointment of Auditor

Deloitte Touche Tohmatsu has given the Company notice of its resignation as the Company's auditor. This resignation is conditional on ASIC granting its consent in accordance with section 329(5)(b) of the Corporations Act which, as at the date of this Notice, has not yet been received.

If the ASIC process is not yet finalised with the ASIC consent received prior to the Meeting, Deloitte Touche Tohmatsu's resignation as the Company's auditor will not yet have become effective as at the date of the Meeting and Resolution 6 will be withdrawn.

If Deloitte Touche Tohmatsu's resignation as the Company's auditor becomes effective prior to the date of the Meeting, the Company intends to appoint PricewaterhouseCoopers (PwC) to fill the resulting casual vacancy in accordance with section 327C(1) of the Corporations Act. PwC would then hold office until the Meeting, at which it must be re-appointed.

In accordance with section 328B(1) of the Corporations Act, the Company has received written notice from a

Shareholder nominating PwC for appointment as the Company's auditor. A copy of the notice is attached as Annexure D.

PwC has provided its written consent to act as the Company's auditor. Resolution 6 seeks Shareholder approval under section 327B(1) of the Corporations Act to appoint PwC as the Company's auditor at the Annual General Meeting.

8. Resolution 7 – Increase to Non-Executive Directors' Fee Pool

8.1 Background

Resolution 7 seeks Shareholder approval for the Company to be authorised to increase the maximum total aggregate amount of Directors' fees payable to Non-Executive Directors from \$1,100,000 per annum to an aggregate amount of \$1,600,000 per annum.

ASX Listing Rule 10.17 and Rule 6.3(a) of the Constitution require that Shareholder approval is obtained to establish the maximum amount of remuneration payable to Non-Executive Directors.

For the purposes of the ASX Listing Rules, "directors' fees" includes committee fees, superannuation contributions and fees which a director sacrifices for other benefits, but does not include reimbursement of genuine out-of-pocket expenses, genuine "special exertion" fees or securities issued to Non-Executive Directors with approval of Shareholders in accordance with the ASX Listing Rules.

In accordance with the Constitution the Board may determine the proportions in which the total aggregate amount for Non-Executive Director remuneration is to be divided between the Non-Executive Directors for remuneration for their services as directors.

The maximum aggregate fees payable to Non-Executive Directors have not been increased since 17 October 2024.

The Board considers that it is reasonable and appropriate at this time to seek an increase in the remuneration pool for Non-Executive Directors to account for inflationary increases as well as any additional Board members who may be appointed as part of the Company's ongoing expansion. The Board does not presently intend to fully utilise the proposed increased maximum amount in the immediate future. However, the Company wishes to retain sufficient flexibility to enable the Board to appoint and remunerate appropriately qualified persons to the Board as and when required without the need to hold a further general meeting.

If this Resolution is passed, the maximum aggregate amount of fees that may be paid to all of the Company's Non-Executive Directors will be \$1,600,000 per annum. This does not mean that the Company must utilise the entire maximum amount approved for Non-Executive Directors' fees in each year.

If this Resolution is not passed, the Company will not be permitted to pay fees to its Non-Executive Directors which exceed the aggregate amount of directors' fees already approved by Shareholders at the Company's 2024 annual general meeting (that is, \$1,100,000 per annum).

The remuneration of each Non-Executive Director for the year ended 30 June 2026 is detailed in the Remuneration Report in the Company's Annual Report.

8.2 Information required under Listing Rule 10.17

The Company provides the following information as required under Listing Rule 10.17:

- (a) the amount of the proposed increase is \$500,000 per annum;
- (b) the maximum aggregate amount of Non-Executive Directors' fees if this Resolution is passed will be \$1,600,000 per annum; and
- (c) No Equity Securities have been issued to persons who have held the role of Non-Executive Director at any time during the past 3 years under Listing Rule 10.11 or Listing Rule 10.14.

Note that a voting exclusion applies to this Resolution in the terms set out in the Notice.

Shareholders are urged to carefully read the Proxy Form and provide a direction to the proxy on how to vote on this Resolution.

9. Resolution 8 to 12 (inclusive) – Issue of Share Rights in lieu of fees to the Non-Executive Directors or their respective nominees

9.1 Background

The Company has implemented a salary sacrifice program for its Non-Executive Directors pursuant to which each Non-Executive Director will sacrifice at least 10% of their fees for each of the financial years ending 30 June 2027, 30 June 2028 and 30 June 2029 in return for Share Rights under the Company's NED Share Rights Plan.

The purpose of the NED Share Rights Plan is to:

- (a) link the remuneration of Non-Executive Directors to performance and the creation of Shareholder value;
- (b) align the interests of Non-Executive Directors more closely with the interests of Shareholders by providing an opportunity for Non-Executive Directors to receive an equity interest in the form of Share Rights and underlying Shares;
- (c) provide Non-Executive Directors with the opportunity to share in any future growth in value of the Company; and
- (d) provide greater incentive for Non-Executive Directors to focus on the Company's longer-term goals.

The Board considers it to be good governance practice for Non-Executive Directors not to participate in the same equity incentive scheme as Company executives and therefore proposes to utilise its separate NED Share Rights Plan for this purpose across the next three financial years.

9.2 Operation of the NED Share Rights Plan

The Company proposes to invite Non-Executive Directors to apply for Share Rights annually under its NED Share Rights Plan.

The NED Share Rights Plan provides that:

- (a) Non-Executive Directors are obliged to sacrifice 10% of their Remuneration in a financial year as Share Rights; and
- (b) Non-Executive Directors are permitted to elect to sacrifice up to a further 40% of their Remuneration in a financial year as Share Rights.

The number of Share Rights to be offered to each Non-Executive Director or their respective nominees for each financial year will be calculated by dividing the aggregate dollar value of the Non-Executive Director's salary sacrifice elections (ranging from 10% to 50% of their Remuneration for that financial year) by the 30-day volume-weighted average price of Shares on ASX calculated for the period commencing on the date the Company releases its annual report for the year during which the relevant offer of Share Rights was made, subject to a maximum of 550,000 Share Rights in aggregate across the financial years ending 30 June 2027, 30 June 2028 and 30 June 2029.

Subject to obtaining Shareholder approval for the issue of the Share Rights, those Share Rights will be issued in yearly instalments in or around December each year in respect of the period running from 1 December until 30 November in the following calendar year (Relevant Period).

The approvals sought pursuant to Resolutions 8 to 12 (inclusive) will enable the Non-Executive Directors to participate in, and (subject to their elections) be issued Share Rights for the financial years ending 30 June 2027, 30 June 2028 and 30 June 2029. The Company intends to seek further Shareholder approval for the issue of Share Rights to Non-Executive Directors in future financial years, as well as for the issue of Share Rights to any new Non-Executive Directors who may be appointed to the Board from time to time.

9.3 Number and value of the Share Rights proposed to be issued

The total number of Share Rights to be issued to each Non-Executive Director or their respective nominees will depend on:

- (a) the Non-Executive Director's Remuneration for the Relevant Period;
- (b) the Non-Executive Director's election for the Relevant Period (which must be a minimum of 10%, and must not exceed 50%, of his or her Remuneration for that period); and
- (c) the calculation of the number of Share Rights for the Relevant Period, which is in turn based on the 30-day VWAP of Shares on ASX calculated for the period commencing on the date the Company releases its annual report for the financial year ending immediately prior to the start of the Relevant Period.

Accordingly, the exact number of Share Rights to be issued to each Non-Executive Director or their respective nominees for each Relevant Period is unknown as at the date of this Notice.

Subject to Shareholder approval, the maximum number of Share Rights proposed to be issued to each Non-Executive Director or their respective nominees for each of the financial years ending 30 June 2027, 30 June 2028 and 30 June 2029 will be calculated using the following formula:

$$SR = \frac{\text{Base FAR} \times \text{Election}}{\text{Price}}$$

where:

SR = aggregate number of Share Rights that will be issued to the relevant Non-Executive Director or their nominees for the Relevant Period, which is subject to a maximum of 550,000 Share Rights in aggregate across the financial years ending 30 June 2027, 30 June 2028 and 30 June 2029;

Base FAR = the relevant Non-Executive Director's total fixed annual base remuneration for the Relevant Period;

Election = the percentage of the relevant Non-Executive Director's total fixed annual base remuneration for the Relevant Period that the Non-Executive Director elects to Salary Sacrifice (which must be a minimum of 10% and must not exceed 50%); and

Price = the 30-day VWAP of Shares on ASX calculated for the period commencing on the date the Company releases its annual report for the financial year ending immediately prior to the start of the Relevant Period.

Any fractional entitlements will be rounded down to the nearest whole number.

Set out below are worked examples of the minimum and maximum number of Share Rights that would be issued pursuant to Resolutions 8 to 12 (inclusive) for each of the financial years ending 30 June 2027, 30 June 2028 and 30 June 2029, based on the current remuneration package of the Non-Executive Directors for the financial year ending 30 June 2027 as set out in Section 0 below (which may be subject to change in future years). In preparing this example, the value applied for the 30-day VWAP has been assumed to be \$3.69 per Share, being the closing Share price on 17 August 2026 (being the date on which the Company's 2026 annual report was released).

9.4 Related Party Transactions Generally

- Shareholder approval is obtained prior to the giving of the financial benefit and the benefit is given within 15 months after obtaining such approval.

For the purposes of Chapter 2E of the Corporations Act, each Non-Executive Director is a related party of the Company.

In relation to Resolutions 8 to 12 (inclusive), the Board (excluding each Non-Executive Director in respect of the proposed issue of Share Rights to that Non-Executive Director or their nominee(s)) has formed the view that Shareholder approval under section 208 of the Corporations Act is not required for each proposed issue of Share Rights as each issue, which will form part of the remuneration package for the relevant Non-Executive Director, is considered reasonable remuneration for the purposes of section 211 of the Corporations Act.

9.6 Directors' recommendation

Mr Anthony Wooles, Ms Sally-Anne Layman, Ms Tracey Arlaud, Mr Uwa Airhiavbere and Ms Tracey Horton AO each have an interest in the outcome of Resolutions 8, 9, 10, 11 and 12 respectively, and therefore believe it inappropriate to make a recommendation in relation to Resolutions 8, 9, 10, 11 and 12 respectively.

Other than as outlined above, the Directors recommend that Shareholders vote in favour of each of Resolutions 8 to 12 (inclusive).

The Board is not aware of any other information that would reasonably be required by the Shareholders to allow them to make a decision whether it is in the best interests of the Company to pass Resolutions 8 to 12 (inclusive).

9.7 Consequences of passing the Resolutions

If Resolution 8 is passed, the Company will be entitled to issue Share Rights in lieu of salary for each Relevant Period to Mr Anthony Wooles or his nominee(s) under the NED Share Rights Plan, subject to receiving a valid election from Mr Anthony Wooles or his nominee(s). If Resolution 8 is not passed, the Company will not be entitled to issue Share Rights to Mr Anthony Wooles or his nominee(s) and will be required to pay Mr Anthony Wooles' full Remuneration in cash without any sacrifice of his fees for Share Rights.

If Resolution 9 is passed, the Company will be entitled to issue Share Rights in lieu of salary for each Relevant Period to Ms Sally-Anne Layman or her nominee(s) under the NED Share Rights Plan, subject to receiving a valid election from Ms Sally-Anne Layman or her nominee(s). If Resolution 9 is not passed, the Company will not be entitled to issue Share Rights to Ms Sally-Anne Layman or her nominee(s) and will be required to pay Ms Sally-Anne Layman's full Remuneration in cash without any sacrifice of her fees for Share Rights.

If Resolution 10 is passed, the Company will be entitled to issue Share Rights in lieu of salary for each Relevant Period to Ms Tracey Arlaud or her nominee(s) under the NED Share Rights Plan, subject to receiving a valid election from Ms Tracey Arlaud or her nominee(s). If Resolution 10 is not passed, the Company will not be entitled to issue Share Rights to Ms Tracey Arlaud or her nominee(s) and will be required to pay Ms Tracey Arlaud's full Remuneration in cash without any sacrifice of her fees for Share Rights.

If Resolution 11 is passed, the Company will be entitled to issue Share Rights in lieu of salary for each Relevant Period to Mr Uwa Airhiavbere or his nominee(s) under the NED Share Rights Plan, subject to receiving a valid election from Mr Uwa Airhiavbere or his nominee(s). If Resolution 11 is not passed, the Company will not be entitled to issue Share Rights to Mr Uwa Airhiavbere or his nominee(s) and will be required to pay Mr Uwa Airhiavbere's full Remuneration in cash without any sacrifice of his fees for Share Rights.

If Resolution 12 is passed, the Company will be entitled to issue Share Rights in lieu of salary for each Relevant Period to Ms Tracey Horton AO or her nominee(s) under the NED Share Rights Plan, subject to receiving a valid election from Ms Tracey Horton AO or her nominee(s). If Resolution 12 is not passed, the Company will not be entitled to issue Share Rights to Ms Tracey Horton AO or her nominee(s) and will be required to pay Ms Tracey Horton's full Remuneration in cash without any sacrifice of her fees for Share Rights.

9.8 Information Requirements – Listing Rules 10.14 and 10.15

Listing Rule 10.14 provides that the Company must not permit any of the following persons to acquire Equity Securities under an employee incentive scheme:

- a director of the Company (Listing Rule 10.14.1);

The proposed issue of Share Rights to the Non-Executive Directors or their respective nominees pursuant to Resolutions 8 to 12 (inclusive) falls within Listing Rule 10.14.1 and therefore requires the approval of Shareholders under Listing Rule 10.14.

The following further information is provided to Shareholders for the purposes of Listing Rule 10.15:

- the Share Rights will be issued to Mr Anthony Wooles, Ms Sally-Anne Layman, Ms Tracey Arlaud, Mr Uwa Airhiavbere and Ms Tracey Horton AO or their respective nominees as noted above;
- each of Mr Anthony Wooles, Ms Sally-Anne Layman, Ms Tracey Arlaud, Mr Uwa Airhiavbere and Ms Tracey Horton AO are Listing Rule 10.14.1 parties because they are Directors;
- the maximum number of Share Rights which may be issued to each of the Non-Executive Directors will be dependent on the variables outlined in Section 0 above. Based on the formula and the assumptions set out in Section 0 above, the maximum number of Share Rights to be issued to each of the Non-Executive Directors or their respective nominees for the current financial year, are as follows:
 - Mr Anthony Wooles: 44,715 Share Rights;
 - Ms Sally-Anne Layman: 21,002 Share Rights;
 - Ms Tracey Arlaud: 25,745 Share Rights;
 - Mr Uwa Airhiavbere: 25,745 Share Rights; and
 - Ms Tracey Horton AO: 21,002 Share Rights.

The number of Share Rights issued to each Non-Executive Director will be disclosed in the Company's annual report for the relevant financial year;

- the issue of Share Rights the subject of Resolutions 8 to 12 (inclusive) is intended to remunerate the Non-Executive Directors in a way which aligns the interests of Non-Executive Directors more closely with the interests of Shareholders;
- each Non-Executive Director's current total remuneration package is set out in Section 0 above;
- no Equity Securities have previously been issued to the Non-Executive Directors or their respective nominees under the NED Share Rights Plan;
- a summary of the terms and conditions of the Share Rights are set out in Annexure E to this Explanatory Statement;
- as noted above, the Share Rights will represent the value of the proportion of Remuneration that the relevant Non-Executive Director elects to receive in Share Rights for each Relevant Period, and the number of Share Rights to be issued will be calculated in accordance with the formula set out in Section 0 above;
- the Share Rights will be issued on a date which will be no later than three years after the date of this Meeting, unless otherwise extended by way of ASX granting a waiver to the Listing Rules;
- the Share Rights will be issued for no cash consideration (but will be issued in lieu of a proportion of the relevant Non-Executive Director's Remuneration);
- a summary of the material terms of the NED Share Rights Plan under which the Share Rights have been offered is set out in Annexure F to this Explanatory Statement;
- details of any Equity Securities issued under the NED Share Rights Plan will be published in the annual report of the Company relating to a period in which they were issued, along with a statement that approval for the issue was obtained under Listing Rule 10.14; and
- any additional persons covered by Listing Rule 10.14 who become entitled to participate in the NED Share Rights Plan after any of Resolutions 8 to 12 (inclusive) are approved and who were not named in this Notice will not participate until approval is obtained under that Listing Rule 10.14.

9.9 Voting

A voting exclusion statement applies to Resolutions 8 to 12 (inclusive) as set out in this Notice.

Shareholders are urged to carefully read the Proxy Form and provide a direction to the proxy on how to vote on Resolutions 8 to 12 (inclusive).

Glossary

In this Explanatory Statement, the following terms have the following meanings unless the context otherwise requires. \$ means Australian dollars.

Accounting Standards has the meaning given to that term in the Corporations Act.

Annual Report means the annual report of the Company for the year ended 30 June 2026.

Associate has the meaning given to that term in the Listing Rules.

ASX means ASX Limited ABN 98 008 624 691 or the Australian Securities Exchange operated by ASX Limited, as the context requires.

and, where the Awards involve any Monetary Consideration, the following details:

- (o) the terms and conditions of any applicable salary sacrifice arrangements;
- (p) whether a Participant is not entitled to elect to receive Shares upon surrender of an applicable number of exercisable Options without payment of cash or other consideration (i.e. a cashless exercise facility);
- (q) whether a Participant is entitled to elect to receive cash payment on the exercise of Awards in lieu being issued or transferred Shares (i.e. a cash payment facility);
- (r) general information about the risks of acquiring and holding the Awards (and underlying Shares) the subject of the Invitation;
- (s) an explanation of how a prospective Participant could, from time to time, ascertain the market price of Shares;

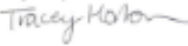

 - (xii) any other specific terms and conditions applicable to the Offer;
 - (xiii) to the extent required by applicable law:
 - (A) an explanation of how a Non-Executive Director could, from time to time, ascertain the market price of the Shares underlying the Share Rights;
 - (B) the terms of any loan or contribution plan under which a Non-Executive Director may obtain Share Rights, or a summary of the terms of the loan together with a statement that the Participant can request a copy of the terms;
 - (C) the trust deed of any trust that will hold Share Rights on trust for a Non-Executive Director, or a summary of the terms of the trust deed together with a statement that the Participant can request a copy of the trust deed;
 - (D) a copy of any disclosure document prepared by the Company under Part 6D.2 of the Corporations Act in the 12 months before the date of the Offer, or a statement of how the Participant can access a copy of those disclosure documents; and
 - (E) any other information required by applicable laws; and
 - (xiv) a prominent statement to the effect that:
 - (A) any advice given by the Company in relation to Share Rights issued under the NED Share Rights Plan, and Shares issued upon exercise of the Share Rights, does not take into account a Non-Executive Director's objectives, financial situation and needs; and
 - (B) the Non-Executive Director should obtain their own financial product advice in relation to the Offer from a person who is licensed by ASIC to give such advice.
- (d) **Terms of Offer:** The terms and conditions applicable to an Offer, and any accompanying document, must not include any misleading or deceptive statements, or omit any information that would result in those materials becoming misleading or deceptive. If the Company becomes aware, during the application period for Share Rights, that any statement in the Offer has become out of date, or is otherwise not correct, in a material respect, then it must provide an updated Offer.
- (e) **Nominees:** A Non-Executive Director may, by notice in writing to the Board and subject to applicable laws, nominate a nominee in whose favour the Non-Executive Director wishes the Share Rights to be issued. The nominee may be an immediate family member of the Non-Executive Director, a corporate trustee of a self-managed superannuation fund where the Non-Executive Director is a director of the trustee or a company

whose members comprise no persons other than the Non-Executive Director or immediate family members of the Non-Executive Director. The Board may, in its sole and absolute discretion, decide not to permit the Share Rights to be issued to a nominee.

(f) **Terms and conditions of Salary Sacrifice arrangement:**

- (i) The Board may, in its absolute discretion, determine the terms and conditions of any Salary Sacrifice arrangement by which Share Rights may be offered in lieu of Remuneration.

 - (A) the Board may determine the minimum and/or maximum amount of Remuneration in respect of each Non-Executive Director which may be the subject of the Salary Sacrifice arrangement;
 - (B) the number of Share Rights to be issued to the Non-Executive Director (or their Nominated Party, if applicable) will be determined in the manner set out in the Offer Document; and
 - (C) in the case of fractional entitlements, and unless the Offer Document states otherwise, the number of Share Rights to be issued to the Non-Executive Director (or their Nominated Party, if applicable) will be rounded down to the nearest whole number of Share Rights.

(g) **Variation and termination of Salary Sacrifice arrangement:**

- (i) A Non-Executive Director may, in writing to the Board, request to vary their Salary Sacrifice contribution amount only on the basis of exceptional circumstances (which may include severe financial hardship). The Board may accept or decline the request in its sole and absolute discretion.
- (ii) A Non-Executive Director may at any time, in writing to the Board, elect to discontinue any Salary Sacrifice arrangement relating to them (Termination Notice).
- (iii) If a Non-Executive Director provides a Termination Notice:
 - (A) the Salary Sacrifice arrangement will be terminated and no further Salary Sacrifice contributions will be made in respect of the Non-Executive Director with effect from the commencement of the next payroll period following the payroll period in which the Board receives the Termination Notice;
 - (B) any Salary Sacrifice deductions from the Non-Executive Directors' Remuneration will cease, and any deductions made after the date of the Termination Notice will be repaid to the Non-Executive Director within 45 days; and
 - (C) the amount of any Salary Sacrifice contributions standing at the date of the Termination Notice to the credit of the account of the Non-Executive Director, and any interest on that amount, will be repaid to the Non-Executive Director within 45 days of the date of the Termination Notice.

(h) **Dealing:** Share Rights may not be sold, assigned, transferred or otherwise dealt with except on the death of the Participant in limited circumstances or with the prior consent of the Board.

(i) **Vesting:** Subject to paragraphs (l) and (m) below, Share Rights will vest when the Participant receives a vesting notice from the Company confirming that the vesting conditions attaching to the Share Rights are met or waived.

(j) **Exercise of Share Rights:** Upon receiving a vesting notice with respect to their Share Rights, a Participant may exercise those Share Rights by delivery to the Company Secretary of the certificate for the Share Rights (if any) and a signed notice of exercise.

(k) **Lapse of Share Rights:** Unless otherwise determined by the Board, a Share Right will not vest and will lapse on the earlier of:

- (i) the Board determining that the vesting conditions attaching to the Share Right have not been satisfied, reached or met in accordance with its terms or is not capable of being satisfied, reached or met;
- (ii) the day immediately following the last exercise date; or
- (iii) with respect of unvested Share Rights, the date the Participant ceases to be a Non-Executive Director in the relevant circumstances summarised at paragraph (l) below.

(l) **Ceasing office:** If the Non-Executive Director ceases to be a Non-Executive Director for any reason, then (subject to compliance with the Corporations Act and Listing Rules):

- (i) a portion of any unvested Share Rights held by the relevant Participant will automatically vest pro rata to the proportion of the vesting period that has elapsed at the relevant time and become exercisable;
- (ii) any unvested Share Rights held by the relevant Participant that do not automatically vest in accordance with sub-paragraph (i) will immediately lapse;
- (iii) any vested Share Rights held by the relevant Participant that have not been exercised will remain on foot and will continue to be exercisable; and
- (iv) any Salary Sacrifice arrangements in respect of the Non-Executive Director will be terminated,
- (v) although the Board may (subject to compliance with the Corporations Act and Listing Rules) determine to treat any unvested Share Rights in any other way other than in the manner set out above if the Board determines that the relevant circumstances warrant such treatment. If the Board makes such a determination for alternative treatment, then it must give the relevant Participant notice within 14 days of that determination.

(m) **Change of control:** If a Change of Control Event (see below) occurs, then (subject to compliance with the Corporations Act and Listing Rules):

- (i) a portion of any unvested Share Rights held by the relevant Participant will automatically vest pro rata to the proportion of the vesting period that has elapsed at the relevant time and become exercisable;
- (ii) any unvested Share Rights held by the relevant Participant that do not automatically vest in accordance with sub-paragraph (i) will immediately lapse;
- (iii) any vested Share Rights held by the relevant Participant that have not been exercised will remain on foot and will continue to be exercisable; and
- (iv) any Salary Sacrifice arrangements in respect of the Non-Executive Director will be terminated,

although the Board may (subject to compliance with the Corporations Act and Listing Rules) determine to treat any unvested Share Rights in any other way other than in the manner set out above if the Board determines that the relevant circumstances warrant such treatment.

In this context, a “**Change of Control Event**” means:

- (i) a takeover bid (as defined in the Corporations Act) is made for all Shares and which is, or is declared, unconditional and the bidder under the bid acquires a voting power in the Company of at least 50.1%;
- (ii) the Court sanctioning a compromise or arrangement relating to the Company under Part 5.1 of the Corporations Act;
- (iii) any other merger, consolidation or amalgamation involving the Company occurring which results in the holders of Shares immediately prior to the merger, consolidation or amalgamation being entitled to 50% or less of the voting shares in the body corporate resulting from the merger, consolidation or amalgamation;
- (iv) any Group Company entering into agreements to sell in aggregate a majority in value of the businesses or assets of the Group to a person, or a number of persons, none of which are Group Companies; or
- (v) the Board determining in its reasonable opinion that control of the Company has or is likely to change or pass to one or more persons.

(n) **Issue of Shares on exercise of Share Rights:** Following exercise of the Share Rights, the Company will, subject to the terms of the Company’s relevant policies, issue or transfer Shares to that Participant and apply for official quotation or listing of those Shares on ASX if applicable. Unless and until the Share Rights have been exercised and the relevant Shares issued to that Participant as a result of that exercise, a Participant has no right or interest in those Shares.

(o) **Ranking of Shares:** Shares issued upon exercise of the Share Rights will rank equally in all respects with existing Shares, except for entitlements which had a record date before the date of the issue of that Share.

(p) **Adjustment of Share Rights:** If, prior to the vesting of a Share Right, there is a reorganisation of the issued share capital of the Company (including a consolidation, sub-division or reduction of capital or return of capital to Shareholders), the number of Share Rights to which a Participant is entitled will be adjusted in a manner required by the Listing Rules.

(q) **Clawback:** Where a Participant:

- (i) in the reasonable opinion of the Board:
- (A) acts fraudulently or dishonestly, or is grossly negligent, with respect to the Group;
 - (B) is in material breach of their obligations or duties owed to any Group Company;
 - (C) demonstrates serious or wilful misconduct as an officer of a Group Company;
 - (D) has caused or materially contributed to a false or misleading statement or omission being made that was relied on by the Board in making any decision under the NED Share Rights Plan including assessing whether any Share Rights should be issued, vest or lapse under the NED Share Rights Plan;
 - (E) causes a material adverse effect on the reputation or financial position or performance of any Group Company; or
 - (F) commits some other act or omission that creates a reasonable basis for the Board exercising its rights;
- (ii) has his or her office with any Group Company terminated due to serious or wilful misconduct or otherwise for cause without notice;
- (iii) deals with or disposes of Share Rights or Shares contrary to the provisions of the NED Share Rights Plan or any applicable Offer; or
- (iv) becomes ineligible to hold his or her office due to Part 2D.6 of the Corporations Act,
- (v) the Board may, without any liability to the Participant, by written notice to the Participant:
- (vi) deem any unvested, or vested but unexercised, Share Rights acquired by the Participant under the NED Share Rights Plan to have lapsed;
