
GLOBAL STRATEGIC ALLIANCE & MASTER SERVICES AGREEMENT WITH IMAGE ANALYSIS GROUP

Highlights

- Strategic Alliance & Master Services Agreement executed with Image Analysis Group (IAG), a London-headquartered global imaging clinical research organisation whose DYNAMIKA™ platform has supported more than 700 clinical trials since 2007
- Resonance's MRI analysis endpoints; FerriScan®, FerriSmart®, HepaFatScan®, HepaFatSmart®, LiverSmart® and CardiacT2*, to become orderable endpoints within IAG's global imaging business
- Resonance gains access to IAG's broader imaging infrastructure and global reader network for multi-modality clinical-trial studies
- Resonance becomes IAG's Australian delivery partner for clinical trials: feasibility, ethics, local sponsorship, TrialsWest sites, and a pathway to eligible R&D activities that may qualify for Australia's R&D Tax Incentive
- Alliance targets high-growth indications including obesity and metabolic disease (VAT/SAT, liver fat, and muscle mass/muscle quality measures in development), iron overload disorders, MASH/MASLD, hepatology and oncology
- Non-exclusive framework; initial 24-month term with renewal ability; no minimum volume or revenue commitments; revenue dependent on work orders executed

Resonance Health Partners with Global Imaging CRO, Image Analysis Group

Resonance Health Limited (ASX: RHT) (**Resonance** or **Company**) is pleased to announce that the Company has entered into a Strategic Alliance & Master Services Agreement (**Agreement**) with Image Analysis Limited, trading as Image Analysis Group, a London-headquartered global imaging clinical research organisation (**IAG**).

The Strategic Alliance & Agreement Details

IAG operates across the UK, EU, USA, India, China, and Australia and has supported more than 700 clinical trials on its proprietary DYNAMIKA™ platform since 2007, including publicly announced collaborations with leading global pharmaceutical companies.

The Agreement creates a two-way commercial pathway where; (i) IAG incorporates Resonance's specialised quantitative MRI endpoints into its global clinical trial strategies and proposals, and (ii) Resonance gains access to IAG's broader imaging infrastructure, global reader network and its DYNAMIKA™ platform for multi-modality studies.

Pursuant to the Agreement, Resonance's regulatory-cleared Software-as-Medical-Device (**SaMD**) services including FerriScan®, FerriSmart®, HepaFatScan®, HepaFatSmart®, LiverSmart® and CardiacT2*, become orderable endpoints within IAG's global imaging strategies and proposals, still analysed and/or overseen by Resonance's ISO 13485-certified core laboratory, but delivered through IAG's DYNAMIKA™ platform.

IAG's overseas customers (comprised of global pharma company sponsors) gain Australian in-country service delivery through any of Resonance's business units, including SaMD services, clinical trial sites (**TrialsWest**), and

Australian clinical trial advisory (**CRO** or **Resonance Clinical**) businesses. Collectively, the Resonance business segment services include; feasibility, ethics, local Australian sponsor, trial performance through the Company's 100% owned TrialsWest sites, and assistance in relation to eligible R&D activities that may qualify for Australia's R&D Tax Incentive.

The alliance is particularly focussed on obesity and metabolic disease programmes, where global pharma sponsors increasingly need to understand changes in body composition, not just body weight. The combined offering brings together IAG's DXA body-composition and muscle imaging workflows with Resonance's quantitative SaMD MRI capabilities, including visceral and subcutaneous adipose tissue (**VAT & SAT**), liver fat assessment through HepaFatScan®, and muscle mass and muscle quality assessments currently in development.

The Agreement also complements the Company's research and development (**R&D**) pipeline, including the non-invasive MRI Liver Fibrosis device, whose extended proof-of-concept (**EPoC**) trial is fully enrolled. Business development initiatives highlighting the new strategic alliance are initially planned for Europe, the United States of America, Australia, and China.

Strategic Rationale and Potential Upside

The Agreement provides Resonance with capital-light global distribution of its regulatory cleared SaMD endpoints into IAG's established worldwide sponsor customer base and growth pipeline, without the cost of building equivalent international business-development infrastructure. The Australian gateway adds a second channel of inbound work from IAG's global customers, complementing the Company's existing Resonance Clinical and TrialsWest operations. Resonance also gains access to IAG's multi-modality imaging infrastructure and reader network for its own client programmes. The financial impact of the Agreement will depend on the number and size of work orders executed under it and cannot be reliably quantified at this date.

An engagement of Resonance's services by one or more of IAG's global pharma customers would be documented and contracted by execution of work orders under the Agreement. The work order would specify the exact Resonance services to be delivered and the estimated budget, costs, and timelines for delivery of those services.

Dr Olga Kubassova, CEO and President of IAG, said:

"This partnership reflects our continued commitment to building an integrated global imaging ecosystem that removes friction for our sponsors, wherever their trials are located.

"By combining Resonance Health's specialised MRI expertise with IAG's global reach and DYNAMIKA™ platform, we're offering sponsors a more efficient path to reliable imaging endpoints across therapeutic areas."

Resonance Health's CEO & Managing Director, Mr Andrew Harrison said:

"This is disciplined growth inside our core domain and significantly expands the global reach of our SaMD technologies. Our regulatory-cleared endpoints will become available to IAG's global sponsor network, while IAG's clients gain access to Resonance's Australian clinical trial infrastructure and specialised quantitative MRI capabilities.

We are delighted to be working with IAG's founder, Dr Olga Kubassova, and her team. Olga's global reputation in clinical trial imaging speaks for itself, and the calibre of the organisation she has built is exactly why this partnership makes sense for our sponsors and our shareholders.

Together, we can address more of the biomarker assessments increasingly demanded by the next generation of clinical trials – from iron and liver fat today to non-invasive liver fibrosis, body composition, and muscle quality, as our portfolio expands.

We grew Group revenue from \$4M in FY23 to \$15.8M in FY26. Partnerships such as this provide an opportunity to extend our SaMD technologies and services into larger international clinical trial networks while continuing to build recurring, scalable revenue within our core areas."

Key Terms of the Agreement

The Agreement is non-exclusive and provides for the mutual provision of services under the framework of a mutual master services agreement. Services provision by Resonance and/or IAG is facilitated through the execution of individual work orders, with the first two work orders to comprise pilot studies to assess and streamline workflows and determine whether to continue with the Agreement.

1. Key contractual terms of the Agreement include: an initial term of 24 months, renewing automatically for successive 12-month periods unless either party gives notice of non-renewal, with either party able to terminate at any time for convenience on 90 days' notice and in-progress work orders continuing to completion;
2. non-exclusive and no minimum volume or revenue commitments; and
3. detailed commercial terms, including transfer pricing and referral arrangements, remaining confidential.

- **LiverSmart®**, an AI-trained, non-invasive MRI-based multi-parametric device combining FerriSmart® and HepaFat-AI® into a consolidated report providing accurate assessment of LIC and liver fat.
- **CardiacT2***, the most widely accepted MRI method for assessing heart iron loading. Resonance Health offers a dual analysis of FerriScan® and CardiacT2*.

The Company has a development pipeline of additional medical imaging analysis products and services, including the MRI Liver Fibrosis Project, aimed at accurately assessing the presence and progression of liver fibrosis utilising non-invasive MRI analysis. The Company also has a clinical trials business which both manages clinical trials in Australia and includes the site management operations of TrialsWest.
